1	<p>Welcome and Agenda</p> <p>The Chair opened the meeting with an Acknowledgement of Country.</p> <p>The Chair noted the Competition Law Statement and reminded members of their obligations, encouraging them to raise any Competition Law issues with her if they arose.</p>
2	<p>Meeting Attendance</p> <p>The Chair noted the attendance as listed above.</p>
3	<p>Minutes of Meeting 2025_11_14</p> <p>The working group approved the minutes out-of-session which were published on 16 December 2024.</p>
4	<p>Action Items</p> <p>The Chair noted the Action Items as provided.</p>
5	<p>HTR Issues Workbook</p> <p>The Chair provided an update since the publication of the EPNR consultation paper in February 2025. She noted the HTR recommendations were widely accepted by stakeholder submission, with limited comment. She added that among those who did comment, there was strong consensus that the HTR reforms were urgent to enable new technologies to connect to the network.</p> <p>The Chair confirmed that EPWA accepts that HTR changes are urgent and would progress these ahead of broader PNR reforms. She outlined that the working group's next task would be to develop draft rules, with EPWA relying on the group to provide drafting instructions to amend the HTR.</p> <p>The Chair also noted the publication of the Power System, Security, and Reliability Standards Consultation Paper for the SWIS on 19 June 2025. She encouraged members to review the paper and consider which parts may be adopted or adapted for the NWIS.</p> <p>Mr Robinson facilitated a discussion on all issues listed in the HTR meeting workbook (circulated 3 July 2025), reviewing recommendations, confirming leads and supports, and identifying the next steps for each issue in the workbook.</p> <p>Following the meeting, EPWA provided an updated copy of the HTR meeting workbook, reflecting the outcomes of the 10 July 2025 meeting. This updated workbook was shared with members out of session and will be published with these Minutes as a record of this meeting.</p>
6	<p>New Issues for HTR List</p> <p>Mr Robinson facilitated a discussion on new issues for consideration. Members discussed several new issues, which are captured in the updated HTR meeting workbook as issues I2025.1-6.</p>
	<p>Next Steps</p> <p>The Chair thanked all members for their contributions.</p> <p>The Chair noted that EPWA would schedule the next meeting in about 4 weeks time, allowing time for issue leads to progress their work and circulate the outcomes to members at least one week before the meeting.</p>
