Exmouth Gulf Taskforce Communique

Meeting 11, 14 May 2025

Latest news

The 11th and final meeting of the Exmouth Gulf Taskforce (the Taskforce) was held in Exmouth on 14 May 2025. The meeting was chaired by Mr David McFerran, Taskforce Chair.

The Taskforce discussed a range of topics, including:

- Nganhurra Thanardi Garrbu Aboriginal Corporation Sea Country Planning.
- Dr Jenny Shaw, Research Director, Western Australian Marine Science Institution provided an update on the knowledge review report and State of Exmouth Gulf Reporting Framework.
- Marine heatwave conditions including impacts to the Exmouth Gulf and considerations for Taskforce advice.
- Updates from state government on projects in the Exmouth Gulf including Department of Transport and Water Corporation.
- Final Taskforce recommendations, strategic advice and reporting requirements to fulfill its Terms of Reference to the Minister for the Environment.

The Taskforce also hosted two Community Information Forums in Exmouth on 13 May 2025 and Onslow on 15 May 2025. The Forums covered: an overview of the 2021 government decision; Taskforce establishment and Terms of Reference; Taskforce role, reporting, activities and next steps. Updates by the Western Australian Marine Science Institution and Department of Primary Industries and Regional Development (Fisheries) were also provided to both communities.

The Taskforce was pleased with the level of attendance and the interest, knowledge and understanding demonstrated by the attendees. The Taskforce noted the attendees' views on protections for Exmouth Gulf and current economic values and opportunities for the region.

Who is on the Taskforce?

The Taskforce comprises representatives of member organisations appointed by the Minister for the Environment. Membership includes:

Background

The Exmouth Gulf Taskforce was established under section 25 of the *Environmental Protection Act* 1986. Secretariat support is provided by the Department of Water and Environmental Regulation.

What is next?

The Taskforce has delivered its final advice to the Minister for the Environment, aligned with its Terms of Reference. This advice complements the Exmouth Gulf Taskforce Interim Report, published in May 2024. The Taskforce also delivered a knowledge review report, updating key information gaps on the Gulf and its surrounds. The Taskforce concludes in June 2025.
