Introduction

Each year the State Records Office of WA (**SRO**) publishes an online Guide to State Cabinet records which have been released in the previous calendar year. Archived records of Western Australian State Cabinet are released for public access 30 years after the records are created.

State Cabinet records are historically significant documents which reveal the decisions made by the government of the day. These unique records are the primary source documents for information about the issues raised at Cabinet meetings. This online Guide is intended to assist the Western Australian community to access these records.

This year's Guide reviews State Cabinet records, which comprise the minutes and decisions Cabinet, dating from 10 January through to 19 December 1994. The Guide also provides an overview of Western Australian state issues in 1994, as well as highlighting prominent national and international news events of that year for context. A list of the topics and subjects discussed at each meeting of State Cabinet in 1994 is provided in this Guide to assist with further research into the records. This list includes a link to the SRO's online catalogue to enable the public to view relevant State Cabinet records online.

This year (2025) the Guide to the 1994 State Cabinet Records has been produced with the assistance of Ms Cydney Seed, a Bachelor of Arts (Law and Society) and Bachelor of Commerce (Business Law) student from the University of Western Australia during a McCusker Centre for Citizenship Internship at the SRO. During her placement Ms Seed researched 1994 State Cabinet Minutes and Decisions and Meeting Summaries, compiling a detailed list of Cabinet meeting subjects, as well as compiling sections on world, national and local events.

State Cabinet Records are held by the SRO, the entity responsible for identifying, managing, preserving, and providing access to the State's Archives. Some of the State Cabinet Records listed in this Guide can be accessed online via the SRO's catalogue at: https://archive.sro.wa.gov.au and digitised on request through the same service.

All of the original records are available for viewing on request in the Reading Room on the third floor of the Alexander Library Building in the Perth Cultural Centre. Records must be requested in advance via the SRO's catalogue. The Reading Room is open during State Library opening hours. World Events that Made the News in 1994¹

1994 was the year Nelson Mandela became the President of South Africa after the first multiracial democratic elections took place in which black citizens could vote. The North American Free Trade Agreement (NAFTA) came into effect and in Finland voters in a referendum decided to join the European Union. The assassination of the Rwandan President triggered a horrific genocide of Tutsis in the country. Former U.S. President Ronald Reagan announced he had Alzheimer's disease on November 5th, 1994.

In the United Kingdom, economic growth exceeded 1% in the first quarter, the highest for 5 years. Unemployment decreased to just over 2.5 million, marking the lowest level in 2 years. The economy was recovering following the recession that ended in 1993.

In Literature, Arts and Entertainment, the US TV sitcom 'Friends' aired for the first time. 'Pulp Fiction' hit cinemas in September of 1994. American performer, Adam Horovitz, was sentenced to 200 hours of community service after attacking a cameraman during the funeral service for actor River Phoenix. Nirvana's frontman Kurt Cobain passed away. Pope John Paul II was named Time Magazine 1994 'Man of the Year'. Tom Hanks won his first Oscar for his role in 'Philadelphia'.

Important world sporting events of 1994 include: the FIFA world cup held in the USA for the first time, with record breaking tournament attendance of nearly 69,000 spectators per game. A player strike in Major League Baseball in the USA, lasted from 12 August 1994 to 2 April 1995, resulting in no baseball world series that year. Prior to the 1994 Winter Olympics, ice skater Nancy Kerrigan was attacked by fellow ice skater Tonya Harding's bodyguard who injured her knee. Nancy Kerrigan recovered quickly and went on to win the silver medal in the Olympics and Tonya was banned from competitive skating. In Formula 1 Michael Schumacher won his first championship by one point, making it the closest championship win ever. 1994 also saw the death of driver Ayrton Senna at the San Marino Grand Prix.

Australian Events that Made the News in 1994²

At the beginning of 1994 one of the worst bush fire seasons in the history of New South Wales occurred. From the 27th of December 1993 to the 16 of January, over 800 fires burned along New South Wales coastal areas with. 800,000 hectares destroyed, in an area stretching from Batemans Bay to the Queensland border. Four people were killed.

On 16 January 1994 the Prince of Wales, now His Majesty King Charles, was shot at by a starting pistol with two blank shots. This occurred while the Prince Charles was presenting awards at an Australia Day ceremony. The gunman was identified as David Kang whose motive for the incident was to bring greater media attention to the asylum seekers held in detention camps in Australia. He was found guilty of threatening unlawful violence and sentenced to 500 hours of community service.

On 2 March 1994, a bomb went off at the National Crime Authority's office in Adelaide. The bomb was delivered to Detective Sergeant Bowen via parcel post who died after opening the parcel. Despite an arrest being made, the perpetrator Domenic Perre, had his charges dropped due to lack of evidence, but was finally convicted of murder in 2022.

The former Premier of Western Australia, Brian Burke was found guilty of 4 accounts of fraud on the 13 July 1994. He was sentenced to 2 years imprisonment for defrauding the State of over \$17,000 in travel expenses. He was released on parole 7 months later.

On 2 December 1994, the Australian Government agreed to pay reparations to Aboriginal people displaced by the nuclear tests of the 1950s and 1960s.

1994 marked the 98th season of the Australian Football League or AFL (formerly the Victorian Football League). Several alterations to the laws of the game occurred. Some of these included, increasing the field umpires from 2 to 3, decreasing playing time per quarter to 20 minutes, down from 25 and allowing advertising on the back of guernseys. The West Coast Eagles soundly defeated Geelong at the 1994 AFL Grand Final, after a total of 16 wins and 6 loses throughout the season.

Events and Issues in WA Politics in 1994^[3]

In 1994 the State Government was led by Liberal Party leader Premier Richard Court. The Government was formed through a coalition of the Liberal Party and the Nationals.

The Court Ministry was reshuffled on the 25 January 1994, the Premier himself taking over the position of Tourism Minister from the Deputy Liberal leader, Colin Barnett. George Cash undertook the role of Minister assisting the Premier as Minister for Public Sector Management. Kevin Prince succeeded Kevin Minson as Minister for Aboriginal affairs. He also inherited the Housing portfolio from Richard Lewis.

State Government dealt with many issues in 1994 including: concerns surrounding the deregulation of trading hours for businesses, the potential abolishing of some public holiday rights for public servants, and compulsory marriage counselling for de facto relationships, the condition of the Swan and Canning rivers and other environmental matters, and the role of the Collie Coal fields in Western Australia's energy equation.

Cabinet also discussed the Aboriginal Social Justice Report. A task force was established in September 1993, looking at problems in Aboriginal health, education, housing, employment and welfare, and released its two-volume report in 1994. This report outlined the need for a commission of elders to improve consultation with Aboriginal communities. The report also recommended that the establishment of a new Aboriginal Affairs Department replace the Aboriginal Affairs Planning Authority.

The closure of two Collie Coalfields underground mines was announced following an after struggling to meet the quantity and price demands of State Energy Commission of Western Australia (SECWA) contracts. The agreement stipulated that 40% of the coal no longer had to be mined underground.

Within Cabinet, in 1994, there was significant discussion surrounding the Christan Brothers, Government employee superannuation, housing and air conditioning subsidies, reform of land tax in WA, and juvenile justice.

Description of the 1994 State Cabinet Records

State Cabinet records include minutes and decisions, agenda, submissions to Cabinet and are listed chronologically. They are the official record the meetings of the State Cabinet of the Court/Cowan Coalition Government held between 10 January 1994 and 19 December 1994 inclusive and are described on SRO's catalogue as *State Cabinet Minutes and Decisions (Series 1228, Consignment 5944)*.

State Cabinet Records and Minutes and Decisions are the primary original source documents that describe decisions made at Cabinet meetings. These documents contain the names of the Ministers present and absent at each meeting, supporting reports, copies, summaries or reviews of submissions, and a record of ministerial recommendations, including decisions, approvals, deferrals by State Cabinet.
