Draft Mines and Petroleum Regulations Amendment Regulations 2025

Information sheet

Purpose

This information sheet provides guidance on key aspects of the draft Mines and Petroleum Regulations Amendment Regulations (the Amendment Regulations), which prescribe the requirements for:

- a legislative framework for pipeline transport and permanent underground storage of greenhouse gas substances;
- enabling the exploration and recovery of regulated substances (proposed to be prescribed as hydrogen and helium);
- · electronic transactions; and
- provide for the use of additives in petroleum operations.

Background

The *Petroleum Legislation Amendment Act 2024* (PLAA2024) amended the petroleum legislation to, amongst other things, provide a legislative framework for the pipeline transport and permanent underground storage of greenhouse gas substances. These activities form part of what is commonly referred to as Carbon Capture and Storage (CCS).

Marked up versions (Blue Bills) of the amended petroleum legislation can be obtained from the Parliament of Western Australia website for the <u>Petroleum Legislative Amendment Bill</u> 2023.

Attached for your review is the Amendment Regulations which build on the development of two sets of new Injection and Storage Regulations released for public consultation 16 July to 5 September 2025.

This set of regulations contains all the amendments to the current petroleum regulations required to commence the PLAA, except for the petroleum underground storage provisions which will be developed separately.

The title of the Amendment Regulations reflects the Minister for Mines and Petroleum's portfolio and does not make any amendments to mining legislation.

Standard Western Australian drafting protocol for the amendment of existing regulations is that a consolidated version of the new Amendment Regulations is not provided.

This can be read with links below to the current versions of the 12 regulations. Please note that the amendments vary in scale and some are limited to amendment of the name of the Regulations only (e.g. inclusion of 'greenhouse gas storage' in the title).

These amendments do not relate to hydraulic fracture stimulation. The Western Australian Government is progressing amendments to address the findings of the Independent Scientific Panel Inquiry into Hydraulic Fracture Stimulation in Western Australia in a separate package of legislative amendments. This is independent of that process.
