Type of Exemption

I/we hereby apply for an Exemption from compliance with the *Motor Vehicle Dealers Act 1973* under section 31(1) of the Act, on the grounds that: (select the appropriate category below)

- the selling of vehicles by auction does not comprise a significant part of my business as an auctioneer; and
 - I agree that I will not sell vehicles which are owned by trade owners (licensed motor vehicle dealers, finance companies or hire car companies).
