### Selection of Award Recipients

- A short-listing process will be conducted by a panel established by the Law Society of Western Australia in conjunction with Legal Aid WA. The final selection will be made by the Attorney General.
- The decision will be final, and no correspondence will be entered into.
- The Attorney General will present the winners with the Attorney General's Community Service Law Awards at a function in November.
