Use of this form

This form is to be used by people applying to be a nominee for a licence registered with the Electrical Services Board. In Western Australia the **Electricity (Licensing) Regulations Act 1991** provides for registration of electrical workers. Electrical Contractor's and In- House electrical installation licences require that a nominee be registered. The holder of a licence may nominate a person as a replacement for a nominee; or as an additional nominee. A person can't be a nominee for a licence, or stay a nominee, unless they work for the licence holder.
