PLUMBERS LICENSING BOARD

Qualifications required to obtain a tradesperson's licence, a tradesperson's licence (drainage plumbing) or a provisional tradesperson's licence

Purpose

The purpose of this policy is to guide members of the Plumbers Licensing Board (the Board), and departmental officers delegated by the Board, in making appropriate, consistent and legally valid decisions when issuing tradesperson's licences under the *Plumbers Licensing* and *Plumbing Standards Regulations 2000* (the Regulations).

The policy sets out how the Board will satisfy itself as to the plumbing qualification requirements for the granting of a tradesperson's licence, a tradesperson's licence (drainage plumbing) or a provisional tradesperson's licence under regulation 17 of the Regulations. This policy does not address a person's fitness or propriety to hold a licence. Those matters are covered in a separate Board policy.

Scope

This policy applies to all applications for a tradesperson's licence, a tradesperson's licence (drainage plumbing) or a provisional tradesperson's licence made under regulation 15 of the Regulations and accepted for processing by the Board.

The policy does not limit or inhibit the Board's discretion in taking a decision outside these principles and in accordance with the Regulations, based on the individual circumstances of an applicant.

Background

Regulation 17 of the Regulations sets out the matters about which the Board must be satisfied before issuing a licence following an application made under regulation 15.

In considering the issue of a tradesperson's licence, tradesperson's licence (drainage plumbing) or a provisional tradesperson's licence, regulation 17(1)(b) requires the Board to be satisfied that:

- an applicant for a tradesperson's licence meets the requirements prescribed in clause 3
 of Schedule 3 of the Regulations;
- an applicant for a tradesperson's licence (drainage plumbing) meets the requirements prescribed in clause 4 of Schedule 3 of the Regulations; or
- an applicant for a provisional tradesperson's licence meets the requirements prescribed in clause 5 of Schedule 3 of the Regulations.

Licence requirements under Schedule 3 of the Regulations

Tradesperson's licence

Under clause 3 of Schedule 3 of the Regulations, the requirements for a tradesperson's licence are that –

- (a) the applicant holds -
 - (i) a Certificate III in Plumbing attained by fulfilling the obligations of an apprentice under a training contract, as those terms are defined in the *Vocational Education and Training Act* 1996 (the VET Act) section 60A; or
 - (ii) an equivalent Australian qualification, and equivalent practical experience, as determined by the Board; or
- (b) the applicant holds, or has within the preceding 6 months held, a provisional tradesperson's licence and also holds
 - (i) a Certificate III in Plumbing; or
 - (ii) an equivalent Australian qualification as determined by the Board.

Tradesperson's licence (drainage plumbing)

Under clause 4 of Schedule 3 of the Regulations, the requirements for a tradesperson's licence (drainage plumbing) are that the applicant holds –

- (a) a Certificate II in Drainage attained by fulfilling the obligations of an apprentice under a training contract, as those terms are defined in the VET Act section 60A; or
- (b) an equivalent Australian qualification, and equivalent practical experience, as determined by the Board.

Provisional tradesperson's licence

Under clause 5 of Schedule 3 of the Regulations, the requirements for a provisional tradesperson's licence are that the applicant holds –

- (a) an Offshore Technical Skills Record (OTSR), issued by the Commonwealth body called Trades Recognition Australia (TRA), that relates to units of competency within Certificate III in Plumbing; or
- (b) an equivalent Australian qualification as determined by the Board.

Applications for a tradesperson's licence

Obtaining a tradesperson's licence by completing a plumbing apprenticeship

Applicants seeking a tradesperson's licence under clause 3(a)(i) of Schedule 3 of the Regulations must provide the following information to the Board with their application:

- 1. Evidence that the applicant holds a Certificate III in Plumbing. The Board will accept as evidence:
 - a. a document certifying that the applicant holds a Certificate III in Plumbing (with a course code of CPC32420, CPC32413, CPC32412, CPC32411, CPC32408 or BCP30103) conferred by a registered training provider;
 - b. a statement of attainment of the units of competency required for a Certificate III in Plumbing; or
 - an academic record issued by a registered training provider reflecting the applicant's successful completion of the units of competency required for a Certificate III in Plumbing; and
- 2. Evidence that the applicant attained the Certificate III in Plumbing by fulfilling the obligations of an apprentice under a training contract. The Board will accept as evidence:
 - a. a trade certificate issued to the applicant recognising the successful completion of the training contract; or
 - b. an official Australian apprenticeship document issued by a state or territory training authority confirming the successful completion of the training contract.

Obtaining a tradesperson's licence through an equivalent Australian qualification and equivalent practical experience, as determined by the Board

Applicants seeking a tradesperson's licence under clause 3(a)(ii) of Schedule 3 of the Regulations must satisfy the Board that they hold an equivalent Australian qualification, and equivalent practical experience, to an applicant seeking a tradesperson's licence under clause 3(a)(i) above.

For migrant plumbers, the Board will accept as evidence the applicant's skilled migration outcome letter which confirms that both the applicant's qualification and practical experience meet the requirements of TRA's Offshore Skills Assessment Program for the licensed occupation of Plumber (General).

The Board reserves its right to take a decision based on the individual circumstances of an applicant.

Obtaining a tradesperson's licence by completing a Certificate III in Plumbing

Applicants seeking a tradesperson's licence under clause 3(b)(i) of Schedule 3 of the Regulations must provide the following information to the Board with their application:

- 1. Confirmation that the applicant holds, or has within the preceding 6 months held, a provisional tradesperson's licence; and
- 2. Evidence that the applicant holds a Certificate III in Plumbing. The Board will accept as evidence:
 - a document certifying that the applicant holds a Certificate III in Plumbing (with a course code of CPC32420, CPC32413, CPC32412, CPC32411, CPC32408 or BCP30103) conferred by a registered training provider;
 - b. a statement of attainment of the units of competency required for a Certificate III in Plumbing; or
 - an academic record issued by a registered training provider reflecting the applicant's successful completion of the units of competency required for a Certificate III in Plumbing.

Obtaining a tradesperson's licence through an equivalent Australian qualification, as determined by the Board

Applicants seeking a tradesperson's licence under clause 3(b)(ii) of Schedule 3 of the Regulations must provide the following information to the Board with their application:

- 1. Confirmation that the applicant holds, or has within the preceding 6 months held, a provisional tradesperson's licence; and
- 2. Evidence that the applicant holds an equivalent Australian qualification to a Certificate III in Plumbing. The Board will accept as evidence:
 - a. a statement of attainment of the units of competency required for a Course in Migrant Plumbing (with a course code of 52915WA); or
 - an academic record issued by a registered training provider reflecting the applicant's successful completion of the units of competency required for a Course in Migrant Plumbing (with a course code of 52915WA).

Licence fee for applicants who currently hold a provisional tradesperson's licence

Under regulation 26B(3) of the Regulations, if a tradesperson's licence is issued by the Board to a person who holds a provisional tradesperson's licence, the Board must refund to the person so much of the fee last paid for the provisional licence as the Board deems appropriate. This is covered under a separate Board policy.

Applications for a tradesperson's licence (drainage plumbing)

Obtaining a tradesperson's licence (drainage plumbing) by completing a Certificate II in Drainage

Applicants seeking a tradesperson's licence (drainage plumbing) under clause 4(a) of Schedule 3 of the Regulations must provide to the Board:

- 1. Evidence that the applicant holds a Certificate II in Drainage. The Board will accept as evidence:
 - a document certifying that the applicant holds a Certificate II in Drainage (with a course code of CPC20720, CPC20712, CPC20711 or CPC20708) conferred by a registered training provider;
 - b. a statement of attainment of the units of competency required for a Certificate II in Drainage; or
 - an academic record issued by a registered training provider reflecting the applicant's successful completion of the units of competency required for a Certificate II in Drainage.
- 2. Evidence that the applicant attained the Certificate II in Drainage by fulfilling the obligations of an apprentice under a training contract. The Board will accept as evidence:
 - a. a trade certificate issued to the applicant recognising the successful completion of the training contract; or
 - b. an official Australian apprenticeship document issued by a state or territory training authority confirming the successful completion of the training contract.

Obtaining a tradesperson's licence (drainage plumbing) through an equivalent Australian qualification, and equivalent practical experience, as determined by the Board

Applicants seeking a tradesperson's licence (drainage plumbing) under clause 4(b) of Schedule 3 of the Regulations must provide to the Board any information requested by the Board to satisfy itself that the applicant holds an equivalent Australian qualification to that required to be held under clause 4(a) above.

Applications for a provisional tradesperson's licence

Obtaining a provisional tradesperson's licence through an OTSR that relates to units of competency within Certificate III in Plumbing

Applicants seeking a provisional tradesperson's licence under clause 5(2)(a) of Schedule 3 of the Regulations must provide to the Board an OTSR that relates to units of competency within Certificate III in Plumbing.

Obtaining a provisional tradesperson's licence through an equivalent Australian qualification as determined by the Board

Applicants seeking a provisional tradesperson's licence under clause 5(2)(b) of Schedule 3 of the Regulations must provide to the Board any information requested by the Board to satisfy

itself that the applicant holds an equivalent Australian qualification to that required to be held under clause 5(2)(a).

Policy principles and implementation

The Board's assessment of an applicant's qualifications as required under regulation 17 of the Regulations will be conducted as set out in this policy.

Departmental officers delegated by the Board will process applications in a manner that conforms to this policy and will inform applicants of this policy.
