## WA Entry – Request for Approval as an Exempt Traveller

### IMPORTANT INFORMATION

A state of emergency is in effect for the whole of Western Australia pursuant to the *Emergency Management Act 2005 (WA)* (**the Act**). In connection with that state of emergency, the State Emergency Coordinator has given the Quarantine (Closing the Border) Directions (**the Directions**). Those Directions prohibit entry into Western Australia by **any** person other than an exempt traveller. The categories of who is an exempt traveller are set out in the Directions. If you are not an exempt traveller you may commit an offence by entering Western Australia and you will be refused entry and asked to leave.

If you wish to seek approval to enter Western Australia as an exempt traveller, you should complete this form and provide any supporting information and evidence requested. A separate form must be completed for each person who wishes to enter Western Australia, including any child. Forms being completed for a minor child can be signed by a parent or guardian of the child.

This form is to be read and understood with the Directions. Before completing the form, you **must** read the Directions. The Directions are available at **WA.gov.au**.
