#### **CERTIFICATION REPORT**

#### EVIDENCE OF CONSULTATION AND CONSENT

The Yawuru Native Title Holders Aboriginal Corporation RNTBC ("the Yawuru PBC") has authorised the Yawuru Prescribed Body Corporate Indigenous Land Use Agreement in accordance with 9.2-9.3 of its corporate rules, which comply with s251A of the *Native Title Act 1993* (Cth).

This document is in compliance with rule 9.3.3(a) of the Yawuru PBC Rules.

In accordance with rule **9.3.3(b)(i)** it is certified that the affected native title holders have been consulted about, and consent to, the proposed native title decision.

#### Description of Area and Impact on Native Title

In accordance with **9.3.3(c)**, a summary of the ILUA presented to the Yawuru PBC meeting of 30 October 2009 is annexed at **Annexure 1.** to this document which:

- in accordance with 9.3.3(c)(i) provides a description of the proposal that is the subject of the proposed native title decision;
- in accordance with 9.3.3(c)(ii) provides a description sufficient to enable the identification of the affected area;
- in accordance with 9.3.3(c)(iv) provides sufficient information to enable the impacts of the proposed native title decision to be identified;
- in accordance with 9.3.3(c)(v) provides sufficient information to enable the effect on native title of the proposed native title decision to be identified;
- in accordance with 9.3.3(c)(vi) provides details of the extent, if any, of any claims, actions or debts to which any native title holder may be liable as a result of the proposed native title decision.

#### Map of Area

In accordance with **9.3.3(c)(iii)** a map showing the location and extent of the affected area is provided in the ILUA.

#### Identification of Affected Native Title Holders

In accordance with **9.3.3(c)(vii)** all Yawuru native title holders recognised in the Federal Court native title determination of 28 April 2006 (Rubibi Determination) are affected native title holders for this native title decision.

#### List of Yawuru native title holders who considered and consented to the native title decision

In accordance with 9.3.3(c)(vii) a list of the Yawuru native title holders who attended the meeting of 30 October 2009 and consented to the native title decision is **Annexure 2**.

#### Report of the Involvement of Affected Native Title Holders in Decision

In accordance with **9.3.3(c)(viii)** the following is the report setting out the involvement of affected native title holders in considering and making decisions about the proposed native title decision.

#### Advertising of Meeting

- Correspondence advising all members of the Yawuru PBC of the meeting to authorise the ILUA was sent on or around 6 October 2009.
- correspondence advising Yawuru native title holders who were not yet members of the Yawuru PBC and whose addresses were known, was sent, advising them of the meeting to authorise the ILUA on or around 15 October 2009.
- public notices of the meeting were announced on the local Indigenous radio station twice daily, from the morning of 21 October to the morning of 30 October;
- public notices were distributed by hand to members with known difficulties with postal addresses.
- Loose leaflets of the public notice were inserted into the every Broome Advertiser on 22 October 2009.
- Public Notice advertisement in the Broome Advertiser on 29 October 2009.

#### Attendance at the Meeting

Over 65 members of the Yawuru PBC attended. A list of attendees is **Annexure 2** to this document.

Four out of five of the Nominated Law Bosses were in attendance. They were Frank Sebastian, Patrick Dodson, Thomas Edgar Jnr and Neil McKenzie. Mr Joseph Roe, a Lead Negotiator, was unable to attend, but sent his apologies and advised his agreement to approving the ILUA. Other Yawuru law bosses in attendance included Doris Edgar and Francis Djiagween.

#### **Meeting Process**

The meeting commenced at approximately 10.00am and continued until around 4.00pm. A presentation was made to the members detailing the provisions of the ILUA. After

considered discussion, all affected native title holders present at the meeting agreed by consensus to accept the ILUA in accordance with **Rule 9.3.2(a)** of the Rules and passed a resolution to this effect provided at **Annexure 3**.

- holders.



Area Agreement ILUA

## **Conservation Estate**

- 1. Outside Town (Freehold Areas)
  - At Registration, **Reserve land** Interim management order vested in DEC and Yawuru until legislative change that would allow joint management in freehold land granted to Yawuru;
  - Within 4 years, State to amend CALM Act and grant freehold title to Yawuru with conditions for: conservation, recreation, traditional Aboriginal use and enjoyment and sustaining Native Title;
  - 99 year lease back, Joint Management with DEC
  - Law grounds to be excluded from lease back and surrounded by Restricted Access Areas and managed in accordance with Cultural Management Plan
  - Joint Management under cultural management plan and management plan
  - Non-extinguishment principle to apply
  - Yawuru may terminate lease if State funding levels fall below initial 5 year's agreed funding arrangements
  - Rescission of some grazing licences affecting coastal park within 6 months of request by Park Council (DEC and Yawuru)
  - Areas of cultural significance (3 on Thangoo) to be incorporated into the Conservation Estate (subject to agreement)

### 2. Intertidal Areas

## **Roebuck Bay ITZ**

- Intertidal zone to be Class A Reserve
- Interim control by Yawuru and Conservation Commission pending amendment of CALM Act; then controlled by Yawuru (and subject to Yawuru agreement for future management)
- Joint Management in accordance with Yawuru cultural management plan and management plan

### **Cable Beach ITZ**

- Class A Reserve
- Perpetual joint management with Yawuru, BSC and DEC

### 3. Inside Town

- Class A Reserve
- Controlled jointly by Yawuru and Broome Shire Council with assistance from DEC
- Joint management in accordance with Yawuru cultural management plan and management plan

Note: Some other Reserves not Class A but managed as above:

- Broome Port Authority land transferring to Parks
- Balance of Gantheaume Point UCL
- Heritage Buffer on Fairway Drive North

## 4. Marine Park (Under Area Agreement ILUA)

- Reserved as a Marine Park under CALM Act
- Vested in Marine Authority
- Joint Management by Yawuru, Marine Authority, and DEC
- Management in accordance with Yawuru cultural management plan and management plan

## 5. Aboriginal Land Trust Areas

• State to fund Yawuru for materials to fence around ALT lands adjacent to Conservation Estate

## 6. Funding

\$1m for joint management plan

\$9m for 5 years for joint management

\$2m over 5 years for capital works

State and Yawuru to make equal contributions to funds administered by DEC. (except for Cultural Management Plans)

## 7. Rangers

- Guaranteed full-time jobs for Yawuru as rangers and in parks management positions (within budgets)
- Rangers to be "triple badged" under CALM, Local Govt, and Fisheries
- Within 5 years of registration of ILUA all rangers will be Yawuru
- 8. Economic Benefits derived from Parks (eg eco tourism, biodiversity offsets, carbon-trading, etc) to be re-invested into Parks management.

- **9.** Yawuru retain right to **sustain native title practices** in Conservation Estate, including hunting and fishing as prescribed in cultural management plan and management plan
- **10.** Non-extinguishment principle to apply to all Conservation Estate (including public works)

## **Other Items**

## Heritage

- 1. MoU to ensure Yawuru have "primary and principal interests" and rights and must be consulted in first instance regarding any development on Yawuru country.
- 2. State to require all State agencies to comply with MoU.

## Broome Road Airport and Industrial land.

- Yawuru to surrender native title on Broome Airport land affected by native title, subject to transfer of 80 ha Heavy Industrial land to Yawuru.
- 2. During the Development Phase.
  - State to give priority to Yawuru tenders
  - 10% of contractor's employees to be Yawuru
  - At least 10% of contracts to be to Yawuru businesses

## 3. Planning

- State and Shire to support inclusion of Yawuru in planning processes within determination area.
- State to support Yawuru applications for re-zoning of land

## 4. Extinguishment of Native Title

- Transfers of freehold title to Yawuru will extinguish native title only at the time of transfer
- Non-Extinguishment principle applies to all areas where suppression of native title occurs and does not extinguish or abandon Yawuru native title rights

## 5. Indexation

• All payments to Yawuru after registration of ILUA indexed to CPI.

## 6. Rates Exemption

 State to support Yawuru application to BSC for rates exemption until Yawuru achieves an income stream from land development

## 7. Costs and charges

• State will cover GST, stamp duty and other government charges associated with compensation package.
