# Schedule 3 – Certification by KLC that Native Title Act requirements met for Registration (clause 5.5)

# Yawuru Area Agreement Broome Indigenous Land Use Agreement ("The Agreement")

## **CERTIFICATION REPORT**

PREPARED BY THE KIMBERELY LAND COUNCIL FOR THE PURPOSES OF THE APPLICATION

FOR REGISTRATION OF THE YAWURU AREA AGREEMENT BROOME INDIGENOUS LAND

USE AGREEMENT ON THE REGISTER OF INDIGENOUS LAND USE AGREEMENTS (pursuant to subsections 24CG(3)(a) of the *Native Title Act 1993* (Cth)

#### INTRODUCTION

As the Native Title Representative Body (NTRB) for the Kimberley Region, the Kimberley Land Council is pleased to certify the Yawuru Area Agreement Broome Indigenous Land Use Agreement. It does so, on the evidence provided to it by the Yawuru Native Title Aboriginal Corporation RNTBC and the expert evidence of the KLC's senior anthropologist, Henry Cox, who witnessed the authorisation of the Agreement on 30<sup>th</sup> October 2009. The KLC also certifies the agreement on the following 'certification requirement' basis:

#### **CERTIFICATION REQUIREMENTS**

This CERTIFICATION is provided on the basis that the following requirements have been met:

- (i) all reasonable efforts have been made (including by consulting all representative Aboriginal/Torres Strait Islander bodies for the area) to ensure that all persons who hold or may hold native title in relation to land or waters in the area covered by the agreement have been identified;
- (ii) all of the persons so identified have authorised the making of the agreement;

The statements setting out grounds on which the KLC are satisfied that these requirements are met are as follows.

#### Identification of common law native title holders

The areas which are the subject of the agreement are excluded from the area that is the subject of the Yawuru Native Title Determination of 28 April 2006 (Rubibi Determination). These areas are surrounded by and adjoin areas that are the subject of the Rubibi Determination. Therefore, it is beyond doubt that any person who may hold native title in the area will be from the same claim group as those the subject of the Rubibi Determination. At the meeting held on the 30<sup>th</sup> October 2009, the native title holders self-identified and were identified by others as such at the meeting. A record of attendance was compiled at the meeting.

For these reasons, the KLC is of the opinion that all reasonable efforts have been made to ensure that all persons who hold or may hold native title in relation to land or waters subject to the Area Agreement have been identified.

#### Authorisation by common law native title holders

The decision of the Yawuru common law native title holders in relation to the Area ILUA occurred at the same time as a decision of the Yawuru native title holders for the related Body Corporate ILUA at a large community meeting held on the 30<sup>th</sup> October 2009. The decision making process was in accordance with Rules of the Yawuru Native Title Aboriginal Corporation RNTBC. These Rules had been agreed to and adopted by the Yawuru native title holding group to relate to agreements of this kind concerning their native title.

These decision-making rules were followed by the common law holders in authorising the Area Agreement. As the common law holders and Yawuru native title holding group are the same people, the Kimberley Land Council considers that this authorisation process is applicable to the Area Agreement as well as the Body Corporate Agreement and therefore believes that all identified common law holders of native title for the area subject to the Area Agreement have authorised the making of the Agreement.

#### Advertising of Meeting

- Correspondence advising all members of the Yawuru Native Title Holders Aboriginal Corporation of the meeting to authorise the ILUA was sent on or around 6 October 2009
- Correspondence advising Yawuru native title holders who were not yet members of the Yawuru Native Title Holders Aboriginal Corporation and whose addresses were known were of the meeting to authorise the ILUA was mailed on or around 15 October 2009.
- Public notices of the meeting were announced on the local indigenous radio station twice daily, from the morning of 21 October to the morning of 30 October;
- An insert of the Notice of Meeting was placed in every copy of the Broome Advertiser on 22 October 2009;
- An advertisement of the Notice of Meeting was placed in the Broome Advertiser on 29 October 2009;
- Notices were distributed by hand to members with known difficulties with postal addresses.

#### Attendance at the Meeting

Ninety two native title holders attended the meeting. A list of attendees is **Annexure 1** to this document.

Four out of five of the Nominated Law Bosses were in attendance. They were Frank Sebastian, Patrick Dodson, Thomas Edgar Jnr and Neil McKenzie. Mr Joseph Roe, a Lead Negotiator, was unable to attend, but sent his apologies and advised his agreement to approving the ILUA. Other Yawuru law bosses in attendance included Doris Edgar and Francis Djiagween.

#### **Meeting Process**

The meeting commenced at approximately 10 am and continued until approximately 4pm. A presentation was made to the members detailing the provisions of the ILUA, the negotiation events and processes that have occurred since May 2006. After considered discussion, all affected native title holders present at the meeting agreed by consensus (unanimous) to accept the ILUA in accordance with the agreed and adopted decision making process.

### **KLC** satisfied

For these reasons, the KLC believes that all the persons so identified as being common law native title holders have authorised the making of the agreement in accordance with an agreed and adopted decision making process.
