Business model

Ausuntech solar is a direct importer of solar system components which are warehoused at the base in Bibra Lake. Engineering, sales and operations are coordinated from the office and focused on both the domestic and commercial markets. It is expected that PPAs will only be offered to larger commercial customers.

Forecast of commercial sales

We estimate that one quarter of our commercial customers will elect the PPA option as opposed to the choices of leasing or outright purchase, thus 24 systems on the order of 30 kW+ each is our expected annual uptake of PPA transactions in WA. This is expected to increase 20% in each of the subsequent two years thus installing a cumulative 2.5mW under PPAs over the three year period.
