RE: Consultation Papers – Improving access to the Western Power network

Thank you for the opportunity to comment on the three consultation papers relating to the proposed implementation of reforms to improve access to the Western Power network published during February and early March 2018. This letter outlines a submission from ATCO.

ATCO recognises the potential improvements that could be delivered through constrained access, including improved efficiency and clearer signals for potential investors in new generation assets.

ATCO submits that there is considerable potential for small-scale hybrid energy solutions and microgrids (typically with an installed generation capacity of 2-5MW) in Western Australia, especially in areas of the State where traditional network infrastructure investment is difficult to justify on cost or efficiency grounds. These areas face a number of energy supply difficulties or potential difficulties, such as intermittent reliability and being served by long 'stringy' feeder lines, or they comprise only a small number of customers. The emergence of new and cost effective energy technologies means it is becoming increasingly realistic to provide consumers in these areas with access to safe, affordable and reliable electricity using non-network energy solutions. Similar solutions are also becoming increasingly viable for larger towns and regional centres in Western Australia.

In this context, ATCO welcomes the exclusion of small generators (capacity less than 10MW) from the proposed constrained access arrangements. These generators are not required to be registered in the Wholesale Electricity Market nor subject to central dispatch, so it would be consistent and equitable to retain their current unconstrained access rights to the Western Power network under new constrained access arrangements. This approach also provides regulatory certainty on network access for proponents of hybrid energy solutions and microgrids.
