

# Retail Trade, January 2017

### **Key Facts**


#### Western Australia

- Seasonally adjusted retail trade in Western Australia increased by 0.3% to \$2,852 million between December and January.
- The monthly increase was mainly driven by a rise in 'food retailing' and 'cafes, restaurants and takeaway food services' which contributed 0.4 and 0.3 percentage points to growth respectively. This was partially offset by a fall in 'household goods retailing' which detracted 0.2 percentage points from growth.
- Retail trade rose by 0.7% in annual average terms and by 0.3% over the three months to January 2017.
- The main contributor to annual average growth in retail trade was 'other' spending while 'nondiscretionary' spending contributed to a lesser degree.
- Trend retail trade in Western Australia grew by 0.1% between December and January, and rose by 0.7% over the year.

#### **Australia**

- Australia's seasonally adjusted retail trade grew by 0.4% to \$25,726 million between December and January.
- Retail trade grew by 3.4% in annual average terms and increased by 0.7% in the three months ending in January.
- The largest annual average increase in retail trade by State was 6.1% in the Australian Capital Territory. The smallest increase was 0.3% in the Northern Territory.
- Australia's trend retail trade rose by 0.2% between December and January, and grew by 3.4% in annual average terms.




#### Western Australia

- Seasonally adjusted retail trade in Western Australia decreased by 0.7% to \$2,829 million between January and February.
- The monthly decrease was mainly due to a fall in 'other retailing' and 'clothing, footwear and personal accessory retailing' which both detracted 0.3 percentage points from growth. This was partially offset by a lift in 'department stores' which contributed 0.1 percentage points to growth.
- Retail trade rose by 0.7% in annual average terms and grew by 0.3% over the three months to February 2017.
- The main contributor to annual average growth in retail trade was 'other' spending while 'nondiscretionary' spending contributed to a lesser degree.
- Trend retail trade in Western Australia grew by 0.1% between January and February, and rose by 0.6% over the year.

#### **Australia**

- Australia's seasonally adjusted retail trade fell by 0.1% to \$25,692 million between January and February.
- Retail trade grew by 3.3% in annual average terms and increased by 0.4% in the three months ending in February.
- The largest annual average increase in retail trade by State was 5.6% in the Australian Capital Territory. The smallest increase was 0.3% in the Northern Territory.
- Australia's trend retail trade rose by 0.1% between January and February, and grew by 3.3% in annual average terms.




Seasonally adjusted retail trade in Western Australia increased by 0.1% to \$2,828 million in March, and rose by 0.6% in annual average terms.

- The monthly increase was driven by 'household goods retailing', and 'clothing, footwear and personal accessory retailing' which contributed 0.2 and 0.1 percentage points to growth respectively. This was partially offset by 'department stores' and 'other retailing' which each detracted 0.1 percentage points from growth.
- The main contributor to annual average growth in retail trade came from 'other' spending (contributing 0.6 percentage points) while 'non-discretionary<sup>1</sup>' spending contributed to a lesser degree (contributing 0.1 percentage points). 'Discretionary' spending detracted 0.1 percentage points from growth.
- Australia's seasonally adjusted retail trade decreased by 0.1% to \$25,630 million in March 2017, and rose by 3.1% in annual average terms.
- The largest annual average increase in retail trade by State was 5.3% in the Australian Capital Territory.
   The smallest increase was 0.1% in the Northern Territory.



Seasonally adjusted retail trade in Western Australia increased by 0.1% to \$8,305 million in the March quarter 2017, and fell by 0.5% in annual average terms.





Australia's seasonally adjusted retail trade increased by 0.1% to \$75,015 million in the March quarter 2017, and rose by 1.7% in annual average terms.

The largest annual average increase in retail trade by State was 3.6% in Australian Capital Territory. The largest decline was 1.4% in the Northern Territory.




#### Western Australia

- Seasonally adjusted retail trade in Western Australia increased by 0.4% to \$2,842 million between March and April.
- The monthly increase was mainly driven by a rise in 'food retailing' and 'other retailing' which contributed 0.4 and 0.3 percentage points to growth respectively. This was partially offset by a fall in 'household goods retailing' which detracted 0.3 percentage points from growth.
- Retail trade rose by 0.4% in annual average terms and fell by 0.1% over the three months to April 2017.
- The main contributor to annual average growth in retail trade was 'other' spending while 'nondiscretionary' spending contributed to a lesser degree.
- Trend retail trade in Western Australia was unchanged between March and April 2017, and rose by 0.5% over the year.

#### Australia

- Australia's seasonally adjusted retail trade grew by 1.0% to \$25,892 million between March and April.
- Retail trade grew by 3.1% in annual average terms and increased by 0.4% in the three months ending in April.
- The largest annual average increase in retail trade by State was 5% in the Australian Capital Territory. The smallest increase was 0.1% in the Northern Territory.
- Australia's trend retail trade rose by 0.1% between March and April, and grew by 3.1% in annual average terms.





- The monthly increase was mainly driven by a rise in 'household goods' which both contributed 0.3 percentage points to growth. This was partially offset by a fall in 'food retailing' which detracted 0.1 percentage point from growth.
- Retail trade rose by 0.4% in annual average terms and was unchanged over the three months to May.
- The main contributor to annual average growth in retail trade was 'other' spending while 'nondiscretionary' spending contributed to a lesser degree.
- Trend retail trade in Western Australia grew by 0.1% between April and May, and rose by 0.4% over the year.

#### **Australia**

- Australia's seasonally adjusted retail trade rose by 0.7% to \$26,084 million between April and May.
- Retail trade grew by 3.1% in annual average terms and increased by 0.9% in the three months ending in May.
- The largest annual average increase in retail trade by State was 5.1% in the Australian Capital Territory. Retail trade spending in the Northern Territory was unchanged in annual average terms, recording the weakest result.
- Australia's trend retail trade rose by 0.3% between April and May, and grew by 3.1% in annual average terms.

Seasonally adjusted retail trade in Western Australia increased by 0.1% to \$2,852 million in June, and rose by 0.4% in annual average terms.


- The monthly increase was driven by 'food retailing',
   'cafes, restaurants and takeaway food services', and
   'other retailing' which contributed 0.2, 0.1 and 0.1
   percentage points to growth respectively. This was
   partially offset by 'household goods retailing' which
   detracted 0.2 percentage points from growth.
- The main contributor to annual average growth in retail trade came from 'other' spending (contributing 1.9 percentage points) while 'non-discretionary' spending contributed to a lesser degree (contributing 0.9 percentage points). 'Discretionary' spending detracted 0.5 percentage points from growth.
- Australia's seasonally adjusted retail trade increased by 0.3% to \$26,151 million in June 2017, and rose by 3.2% in annual average terms.
- The largest annual average increase in retail trade by State was 5.2% in the Australian Capital Territory. The smallest increases were recorded in both Western Australia and the Northern Territory (0.4%).



- Trend retail trade in Western Australia increased by 0.1% between July and August, and rose by 0.5% over the year.


Seasonally adjusted retail trade in Western Australia decreased by 1.3% to \$2,801 million between August and September, and rose by 0.4% in annual average terms.


- The monthly decrease was primarily due to 'household goods retailing', which subtracted 0.6 percentage points (pp), 'other retailing' (-0.3 pp) and 'food retailing' (-0.2 pp).
- The main contributor to annual average growth was 'non-discretionary' spending. 'Other' spending also contributed to growth, while 'discretionary' spending detracted from growth.
- Australia's seasonally adjusted retail trade was broadly unchanged at \$25,897 million between August and September, and grew by 2.9% in annual average terms.



Seasonally adjusted retail trade in Western Australia decreased by 0.1% to \$8,515 million in the September quarter 2017, and was unchanged in annual average terms.

- Australia's seasonally adjusted retail trade increased by 0.1% to \$77,387 million in the September quarter 2017, and rose by 2.1% in annual average terms.
- The largest annual average increase in retail trade by State was 2.9% in South Australia. The largest decline was 0.1% in the Northern Territory.





- The monthly increase was mainly due to 'food retailing' and 'clothing, footwear and personal accesory retailing' which contributed 0.5 and 0.1 percentage points to growth respectively. This was partially offset by 'other' retailing (including pharmaceutical, cosmetic and toiletry goods), which detracted 0.2 percentage points from growth.
- Retail trade rose by 0.3% in annual average terms and dropped by 1.1% over the three months to October 2017.
- The main contributor to annual average growth was 'non-discretionary' spending. 'Other' spending also contributed to growth, while 'discretionary' spending detracted from growth.
- Trend retail trade in Western Australia decreased by 0.3% between September and October, and rose by 0.3% over the year.



- Australia's seasonally adjusted retail trade rose by 0.5% to \$26,052 million between September and October.


Seasonally adjusted retail trade in Western Australia decreased by 0.8% to \$2,831 million between November and December, and rose by 0.3% in annual average terms.

- The monthly decline was primarily due to household goods retailing' which detracted 0.4 percentage points (pp) from growth, and 'other retailing' and 'food retailing' which each detracted 0.3pp. This was partially offset by 'cafes, restaurants and takeaway food services' which contributed 0.3pp growth.
- 'Non-discretionary' spending was the only contributor to annual average growth (0.5pp). 'Discretionary' spending and 'other' spending both detracted 0.1pp.
- Australia's seasonally adjusted retail trade fell by 0.5% to \$26,261 million between November and December and grew by 2.7% in annual average terms.
- The largest annual average increase in retail trade by State was 3.9% in Victoria. The smallest increase was 0.3% in Western Australia.



 Seasonally adjusted retail trade in Western Australia decreased by 0.2% to \$8,488 million in the December quarter 2017, and rose by 0.2% in annual average terms.





- Australia's seasonally adjusted retail trade increased by 0.9% to \$78,042 million in the December quarter 2017, and rose by 2.2% in annual average terms.
