
Major Resource Projects – Works Approval Applications



In Quarter 2, 2016–17 (the quarter):

- The Department of Environment Regulation (DER) decided 100 per cent (of one in total) of major resource projects works approvals applications within 60 working days.
- One new application was received and three applications were not decided by the end the quarter.
- The average time for decisions was 56 working days.

Major Resource Projects - Licence Applications



In the quarter:

- DER did not decide any major resource projects licence applications.
- Two new applications were received and four applications were not decided by the end of the guarter.

Other Projects - Works Approval Applications



In the quarter:

- DER decided 88 per cent (of 18 in total) of other project works approvals applications within 60 working days.
- 33 new applications were received and 43 applications were not decided by the end of the quarter.
- The average time for decisions was 60 working days.

Other Projects – Licence Applications



In the quarter:

- DER decided 82 per cent (of 11 in total) of other project licences applications within 60 working days.
- 31 new applications were received and 58 applications were not decided by the end of the quarter.
- The average time for decisions was 60 working days.

Native Vegetation Clearing Permit Applications

From Quarter 1 2016–17, native vegetation clearing permit application data are reported in working days rather than calendar days.


Applications Decided



In the quarter:

- DER decided 74 per cent (of 101 in total) of native vegetation clearing permit applications within 60 working days.
- 109 new applications were received and 138 applications were not decided by the end of the quarter.
- The average time for decisions was 53 working days.

Hectares Granted or Refused



In the quarter:

• There were 2,771 hectares refused (12 applications) and 1,060 hectares granted (69 applications).

Contaminated Sites




In the quarter:

- DER processed 100 per cent (of 33 in total) of Form 1s within 45 calendar days.
- 51 new Form 1s were received and 31 were not decided by the end of the quarter.


Compliance and Enforcement

Compliance Program 2016-17



- The Annual Compliance Program 2016–17 achieved 38 per cent (479) of its annual target (1245) by the end of Quarter 2.
- The Works Approval Program does not have a specific target, as such the percentage achieved is not measured.

Controlled Waste Licences



In the quarter:

• 104 new controlled waste licence applications were received, with 99 per cent assessed within the 30 calendar day statutory timeframe.

Enforcement Activity



In the quarter:

- DER finalised 99 per cent (of 303 in total) of investigations within 60 working days.
- There were 780 new matters recorded and 343 ongoing at the end of the quarter.
- The average time taken to finalise matters was five calendar days.

Licence and Works Approval - Applications for Amendment

- Major Amendments those which may adversely affect the risk of the premises: 80% of applications finalised within 60 working days; and
- Minor Amendments those which do not adversely affect the risks of the premises: 80% of applications finalised within 40 working days.
