

# Agenda Item 5a (i): Overview of Market Rule Changes

Below is a summary of the status of Market Rule Changes that are either currently being progressed by the IMO or have been registered by the IMO as potential Rule Changes to be progressed in the future.

The net increase in six rule changes (from June to August) has arisen from:

- IMO appendix 5: inconsistency around use of Trading Day and calendar days (low);
- IMO clause 8.4 8.6: general issues and inconsistencies with Meter Data Submissions and the format of Meter Data Submissions (low);
- IMO various clauses: there are various transition rules in the Market Rules that are no longer relevant (low);
- Griffin Energy (via MAC meeting) Definition of Market Power (med);
- Synergy ability for a retailer to directly re-nominate its bilateral to a third party without needing to reveal this to its supplying generators (med); and
- IMO Metering timelines (med).

The increase of 14 minor and typographical rule changes has arisen from the audit of the IMO's unofficial version of the Market Rules and its Market Rules Walkthrough project. The IMO is currently preparing third and final suite of minor and typographical rule changes for 2009. This will be formally submitted during September.
