FISHERIES ACT 1905

(Sections 9 and 11.)
 Notice No. 197.

F.D. 485/75

I HEREBY give notice pursuant to sections 9 and section 11 of the Fisheries Act 1905 that:

- (1) (a) the taking of fish by means of nets in the waters specified in Column 1 of the Schedule is prohibited at all times other than the times specified in relation thereto in Column 2 of the Schedule; but
- (b) the species listed in Column 3 of the Schedule may be taken at the times shown in these waters by means specified in relation thereto in Column 4 of the Schedule;
- (c) the notice relating to those portions of Western Australian waters specified in the Schedule below published in the *Government Gazette* of 25 May 1984 is hereby cancelled.
- (2) Subclause (1) does not apply to a person who –
 - (a) is fishing for a non commercial purpose;
 - (b) is fishing for –
 - (i) cherabin; or
 - (ii) bait fish of any of the Families *Clupeidae*, *Atherinidae*, *Engraulididae*, *Mugilidae* and *Hermiramphidae*; and
 - (c) is fishing by means of a throw net.
