

FISH RESOURCES MANAGEMENT ACT 1994**Prohibition on Fishing for Rock Lobster (Seven Mile Beach) Order 2014**

Order No. 10 of 2014

FD 2557/13 [1174]

Made by the Minister under section 43.

1. Citation

This order is the *Prohibition on Fishing for Rock Lobster (Seven Mile Beach) Order 2014*.

2. Interpretation

In this order, unless the contrary intention appears –

“**rock lobster**” means the fish of that common name described by the scientific classification opposite that name in Column 2 of Schedule 7 to the *Fish Resources Management Regulations 1995*.

3. Prohibition on fishing

A person must not fish for rock lobster by any means in the waters described in the Schedule.

4. Revocation

Notice No. 364 published in the Government Gazette of 9 September 1988, which continued in force under regulation 186 of the *Fish Resources Management Regulations 1995* as if it were an order made under Section 43 of the Act, is revoked.

**Schedule
Seven Mile Beach**

All waters bounded by a line commencing at the intersection of 29° 10.405' south latitude and 114° 53.435' east longitude, thence west to the intersection of 29° 10.405' south latitude and 114° 53.155' east longitude, thence south to the intersection of 29° 11.055' south latitude and 114° 53.335' east longitude, thence
