Made by the Minister under section 43.

1. Citation

This order is the *Prohibition on Fishing for Crabs (Peel Inlet and Harvey Estuary) Order* 2007.

2. Interpretation

In this order "crab" means the fish of that common name described by the scientific classification opposite that name in Column 2 of Schedule 7 of the regulations.

3. Prohibition on fishing for crabs

A person, other than a person fishing under an authorisation issued in respect of the West Coast Estuarine Managed Fishery, must not fish for crabs during the period commencing on 1 September in any year and ending on 31 October in any year in the waters of -

- (a) the Harvey Estuary and its tributaries; or
- (b) the Peel Inlet and its tributaries; or
- (c) the Channel entrance to the Peel Inlet; or
- (d) the Dawesville Cut; or
- (e) any artificially-constructed channel or marina in any of the waters specified in paragraphs (a) to (d).
