#### Part 1 - Preliminary

#### 1. Citation

This local planning scheme is the Shire of Beverley Local Planning Scheme No. 3.

#### 2. Commencement

Under section 87(4) of the Act, this local planning scheme comes into operation on the day on which it is published in the *Gazette*.

#### 3. Scheme revoked

The following local planning scheme is revoked -

Shire of Beverley Town Planning Scheme No. 2 (gazette date 26 April 1993).

#### 4. Notes do not form part of Scheme

Notes, and instructions printed in italics, do not form part of this Scheme.

Note: The *Interpretation Act 1984* section 32 makes provision in relation to whether headings form part of the written law.

#### 5. Responsibility for Scheme

The Shire of Beverley is the local government responsible for the enforcement and implementation of this Scheme and the execution of any works required to be executed under this Scheme.

#### 6. Scheme area

This Scheme applies to the area shown on the Scheme Map.

#### 7. Contents of Scheme

- (1) In addition to the provisions set out in this document (the *scheme text)*, this Scheme includes the following -
  - (a) the deemed provisions (set out in the *Planning and Development* (Local Planning Schemes) Regulations 2015 Schedule 2) including any supplemental deemed provisions outlined in Schedule A of the scheme text; and
  - (b) the Scheme Map.
- (2) This Scheme is to be read in conjunction with any local planning strategy for the Scheme area.

#### 8. Purposes of Scheme

The purposes of this Scheme are to -

- (a) set out the local government's planning aims and intentions for the Scheme area; and
- (b) set aside land as local reserves for public purposes; and
- (c) zone land within the Scheme area for the purposes defined in this Scheme; and
- (d) control and guide development including processes for the preparation of structure plans, activity centre plans and local development plans; and
- (e) set out procedures for the assessment and determination of development applications; and
- (f) set out procedures for contributions to be made for the costs of providing infrastructure in connection with development through development contribution plans; and
- (g) make provision for the administration and enforcement of this Scheme; and
- (h) address other matters referred to in Schedule 7 of the Act.

#### 9. Aims of Scheme

The aims of this Scheme are to -

- (a) encourage and control the orderly development of the Beverley townsite and its surrounds:
- (b) facilitate the growth of the Beverley townsite in a sustainable manner that protects and conserves rural land for rural uses, as well as, retains the existing character and amenity of the district;
- (c) protect, conserve and enhance the district's environmental values and natural resources by promoting ecological sustainable land use and development;
- (d) promote and enhance the quality of urban, rural and rural living environments by providing for a range of compatible land uses and associated development with high levels of safety, amenity, heritage and servicing;
- (e) encourage a high standard of orderly development so as to promote and protect public health, safety, amenity and well-being of the community.
- (f) ensure there is a sufficient supply of serviced and suitable land for housing, rural living, commercial, industrial and tourism developments, as well as identifying opportunities for home-based employment;

- (g) facilitate sustainable development that integrates economic, social and environmental goals for the district;
- (h) assist employment and economic growth by identifying suitable land for retail, commercial, industrial and tourism development, as well as identifying opportunities for home-based employment;
- (i) avoid and minimise land use conflicts by providing a comprehensive planning framework that considers sensitive land uses, and facilitates consistent planning decision-making;
- (j) ensure for the extraction of basic raw materials in accordance with industry best practice.

#### 10. Relationship with local laws

Where a provision of this Scheme is inconsistent with a local law, the provision of this Scheme prevails to the extent of the inconsistency.

#### 11. Relationship with other local planning schemes

There are no other local planning schemes of the Shire of Beverley which apply to the Scheme area.

#### 12. Relationship with region planning scheme

There are no region planning schemes which apply to the Scheme area.

#### Part 2 - Reserves

#### 13. Regional Reserves

There are no regional reserves in the Scheme area.

Note: The process of reserving land under a regional planning scheme is separate from the process of reserving land under the *Land Administration Act 1997* section 41.

#### 14. Local reserves

(1) In this clause -

**Department of Main Roads** means the department principally assisting in the administration of the *Main Roads Act 1930*;

**Western Australian Road Hierarchy** means the document of that name available on the website maintained by the Department of Main Roads.

- (2) Local reserves are shown on the Scheme Map according to the legend on the Scheme Map.
- (3) The objectives of each local reserve are as follows -

- (2) The objectives of each zone are as follows -

#### 18. Interpreting zoning table

- (1) The permissibility of uses of land in the various zones in the Scheme area is determined by cross-reference between the list of use classes on the left hand side of the zoning table and the list of zones at the top of the zoning table.
- (2) The symbols used in the zoning table have the following meanings -
  - P means that the use is permitted if it complies with any relevant development standards and requirements of this Scheme;
  - I means that the use is permitted if it is consequent on, or naturally attaching, appertaining or relating to the predominant use of the land and it complies with any relevant development standards and requirements of

#### this Scheme;

- D means that the use is not permitted unless the local government has exercised its discretion by granting development approval;
- A means that the use is not permitted unless the local government has exercised its discretion by granting development approval after giving notice in accordance with clause 64 of the deemed provisions;
- X means that the use is not permitted by this Scheme.
- Note 1. The development approval of the local government may be required to carry out works on land in addition to any approval granted for the use of land. In normal circumstances one application is made for both the carrying out of works on, and the use of, land. For development on land that does not require development approval see clause 61 of the deemed provisions.
- Note 2. In considering an application for development approval, the local government will have regard to clause 67 of the deemed provisions.
  - (3) A specific use class referred to in the zoning table is excluded from any other use class described in more general terms.
  - (4) The local government may, in respect of a use that is not specifically referred to in the zoning table and that cannot reasonably be determined as falling within a use class referred to in the zoning table -
    - (a) determine that the use is consistent with the objectives of a particular zone and is therefore a use that may be permitted in the zone subject to conditions imposed by the local government; or
    - (b) determine that the use may be consistent with the objectives of a particular zone and give notice under clause 64 of the deemed provisions before considering an application for development approval for the use of the land; or
    - (c) determine that the use is not consistent with the objectives of a particular zone and is therefore not permitted in the zone.
  - (5) If a use of land is identified in a zone as being a class P or class I use, the local government may not refuse an application for development approval for that use in that zone but may require works that are to be undertaken in connection with that use to have development approval.
  - (6) If a use of land is identified in a zone as being a class X use, the local government must refuse an application for development approval for that use in that zone unless -
    - (a) the development approval application relates to land that is

- being used for a non-conforming use; and
- (b) the local government considers that the proposed use of the land would be less detrimental than the non-conforming use.
- (7) If the zoning table does not identify any permissible uses for land in a zone the local government may, in considering an application for development approval for land within the zone, have due regard to any of the following plans that apply to the land -
  - (a) a structure plan;
  - (b) an activity centre plan; and
  - (c) a local development plan.

#### 19. Additional uses

- (8) Table 5 sets out -
  - (a) classes of use for specified land that are additional to the classes of use that are permissible in the zone in which the land is located; and
  - (b) the conditions that apply to that additional use.

(9) Despite anything contained in the zoning table, land that is specified in the Table to subclause (1) may be used for the additional class of use set out in respect of that land subject to the conditions that apply to that use.

#### 20. Restricted uses

There are no restricted uses which apply to this Scheme.

#### 21. Special use zones

There are no special use zones which apply to this Scheme.

#### 22. Non-conforming uses

(1) Unless specifically provided, this Scheme does not prevent -

- (a) the continued use of any land, or any structure or building on land, for the purpose for which it was being lawfully used immediately before the commencement of this Scheme; or
- (b) the carrying out of development on land if -
  - (i) before the commencement of this Scheme, the development was lawfully approved; and
  - (ii) the approval has not expired or been cancelled.
- (2) Subclause (1) does not apply if -
  - (a) the non-conforming use of the land is discontinued; and
  - (b) a period of 6 months, or a longer period approved by the local government, has elapsed since the discontinuance of the non-conforming use.
- (3) Subclause (1) does not apply in respect of a non-conforming use of land if, under Part 11 of the Act, the local government -
  - (a) purchases the land; or
  - (b) pays compensation to the owner of the land in relation to the non-conforming use.

#### 23. Changes to non-conforming use

- (1) A person must not, without development approval -
  - (a) alter or extend a non-conforming use of land; or
  - (b) erect, alter or extend a building used for, or in conjunction with, a non-conforming use; or
  - (c) repair, rebuild, alter or extend a building used for a nonconforming use that is destroyed to the extent of 75% or more of its value; or
  - (d) change the use of land from a non-conforming use to another use that is not permitted by the Scheme.
- (2) An application for development approval for the purposes of this clause must be advertised in accordance with clause 64 of the deemed provisions.
- (3) A local government may only grant development approval for a change of use of land referred to in subclause (1)(d) if, in the opinion of the local government, the proposed use -
  - (a) is less detrimental to the amenity of the locality than the existing non-conforming use; and

(b) is closer to the intended purpose of the zone in which the land is situated.

#### 24. Register of non-conforming uses

- (1) The local government may prepare a register of land within the Scheme area that is being used for a non-conforming use.
- (2) A register prepared by the local government must set out the following -
  - (a) a description of each area of land that is being used for a non-conforming use;
  - (b) a description of any building on the land;
  - (c) a description of the non-conforming use;
  - (d) the date on which any discontinuance of the non-conforming use is noted.
- (3) If the local government prepares a register under subclause (1) the local government -
  - (a) must ensure that the register is kept up-to-date; and
  - (b) must make a copy of the register available for public inspection during business hours at the offices of the local government; and
  - (c) may publish a copy of the register on the website of the local government.
- (4) An entry in the register in relation to land that is being used for a nonconforming use is evidence of the matters set out in the entry, unless the contrary is proved.

#### Part 4 - General development requirements

#### 25. R-Codes

- (1) The R-Codes, modified as set out in clause 26, are to be read as part of this Scheme
- (2) The local government -
  - (a) must make a copy of the R-Codes available for public inspection during business hours at the offices of the local government; and
  - (b) may publish a copy of the R-Codes on the website of the local government.
- (3) The coding of land for the purposes of the R-Codes is shown by the coding number superimposed on a particular area contained within the boundaries of the area shown on the Scheme Map.
- (4) The R-Codes apply to an area if the area has a coding number superimposed on it in accordance with subclause (3).

#### 26. Modification of R-Codes

- (1) Residential development in the Rural Townsite zone shall comply with the R40 code.
- (2) In areas shown on the Scheme Map with a density code of R10/25, development and subdivision in accordance with the higher code shall only be supported where reticulated sewerage is available and the land is, or will be, connected.
- (3) With the exception of lot area all provisions of the R2 code apply in the Rural Residential zone.

#### 27. Environmental conditions

(1) There are no environmental conditions imposed under the Environmental Protection Act 1986 that apply to this Scheme.

#### 28. Additional site and development requirements

- (1) Clauses 32 to 48 set out requirements relating to development that are additional to those set out in the R-Codes, local structure plans, local development plans or State or local planning policies.
- (2) To the extent that a requirement referred to in subclause (1) is inconsistent with a requirement in the R-Codes, a local structure plan, a local development plan or a State or local planning policy the requirement referred to in subclause (1) prevails.

## 29. Additional site and development requirements for areas covered by structure plan, activity centre plan or local development plan

(1) Schedule 1 sets out requirements relating to development in the Rural Residential zone that are included in structure plans that apply in the Scheme area.

#### 30. Variations to site and development requirements

(1) In this clause -

additional site and development requirements means requirements set out in clauses 32 to 48 of this Scheme.

- (2) The local government may approve an application for a development approval that does not comply with an additional site and development requirements.
- (3) An approval under subclause (2) may be unconditional or subject to any conditions the local government considers appropriate.
- (4) If the local government is of the opinion that the non-compliance with an additional site and development requirement will mean that the development is likely to adversely affect any owners or occupiers in the general locality or in an area adjoining the site of the development the local government must -
  - (a) consult the affected owners or occupiers by following one or more of the provisions for advertising applications for development approval under clause 64 of the deemed provisions; and
  - (b) have regard to any expressed views prior to making its determination to grant development approval under this clause.
- (5) The local government may only approve an application for development approval under this clause if the local government is satisfied that -
  - (a) approval of the proposed development would be appropriate having regard to the matters that the local government is to have regard to in considering an application for development approval as set out in clause 67 of the deemed provisions; and
  - (b) the non-compliance with the additional site and development requirement will not have a significant adverse effect on the occupiers or users of the development, the inhabitants of the locality or the likely future development of the locality.

#### 31. Restrictive covenants

- (1) A restrictive covenant affecting land in the Scheme area that would have the effect of limiting the number of residential dwellings which may be constructed on the land is extinguished or varied to the extent that the number of residential dwellings that may be constructed is less than the number that could be constructed on the land under this Scheme.
- (2) If subclause (1) operates to extinguish or vary a restrictive covenant

- (a) development approval is required to construct a residential dwelling that would result in the number of residential dwellings on the land exceeding the number that would have been allowed under the restrictive covenant; and
- (b) the local government must not grant development approval for the construction of the residential dwelling unless it gives notice of the application for development approval in accordance with clause 64 of the deemed provisions.

#### 32. Development and subdivision in the Rural Residential zone

- (1) Land zoned Rural Residential shall be 1 ha to 4 ha in size, with an average lot size of generally 2 ha.
- (2) Planning proposals for Rural Residential zoned land shall be in accordance with State planning policy and are to appropriately address land capability and environmental matters, including bushfire risk, revegetation of cleared land and/or eroded areas and overstocking.
- (3) Prior to subdivision and development of Rural Residential land, a structure plan may be required to address issues including the following:
  - (a) access;
  - (b) bushfire management;
  - (c) servicing; and
  - (d) environmental features and buffers.
- (4) Notwithstanding subclause (3), a structure plan may not be required in support of proposals for Rural Residential land where identified issues may be addressed through the provision of technical information.
- (5) In addition to the requirements of subclause (2), site-specific development requirements applicable to specific Rural Residential precincts are included in Schedule 1.

#### 33. Development and subdivision in the Rural Smallholding zone

- (1) Land zoned Rural Smallholding shall be 4 ha to 40 ha in size.
- (2) Planning proposals for Rural Smallholding zoned land shall be in accordance with State planning policy and are to appropriately address land capability and environmental matters, including bushfire risk, revegetation of cleared land and/or eroded areas and overstocking.

#### 34. Development and subdivision in the Rural zone

- (1) Additional dwellings
  - (a) In the Rural zone, the erection of more than one (1) single house per lot will generally not be supported. The local government may, at its discretion, approve the erection of one (1) additional dwelling on a rural lot provided that:

- (i) the total number of dwellings on the lot will not exceed three (3) dwellings;
- (ii) the additional dwelling(s) complies with the setback requirements of Table 5 of this Scheme;
- (iii) the lot has an area not less than 100 ha;
- (iv) it can be demonstrated that the additional dwelling(s) is for workers or family members employed for primary production activities on that lot:
- adequate provision of potable water for and disposal of sewage from the additional dwelling(s) can be demonstrated;
- (vi) the additional dwelling(s) will not adversely detract from the rural character and amenity of the area or conflict with primary production on the subject lot or adjoining land;
- (vii) access to the existing road network is to be provided for any additional dwelling(s) and shared with any existing dwelling(s) where practicable;
- (viii) the existence of more than one dwelling on a lot in the Rural zone shall not be considered by itself to be sufficient grounds for subdivision.
- (2) Subdivision of Rural land shall be in accordance with State planning policy, with the exception of the creation of homestead lots which will only be supported where the parent lot is greater than 100 ha in area.
- (3) In considering an application for development approval in the Rural zone the local government will have due regard to the relevant matters as listed in clause 67 of the deemed provisions, including:
  - (a) potential impact from sensitive land uses and the requirement for buffers and separation distances, including potential for spray drift and other amenity impacts;
  - (b) potential threat of bushfire to people, property and infrastructure;
  - (c) potential impact on sensitive environmental features including wetlands, waterways and remnant vegetation; and
  - (d) the siting and location of development and its potential impact on visual landscape amenity.

#### 35. Development in the Rural Townsite zone

- (1) Planning proposals, including subdivision, for land zoned Rural Townsite shall be connected to reticulated water and sewerage.
- (2) In considering an application for development approval in the Rural Townsite zone the local government will have due regard to the relevant matters as

- listed in clause 67 of the deemed provisions, including heritage and streetscape compatibility.
- (3) Notwithstanding anything contained in Table 5, residential development in the Rural Townsite zone shall be in accordance with the 'R40' density code of the R-Codes.

#### 36. Development in the Light Industry zone

- (1) All development shall provide at least one (1) refuse storage area readily accessible to service vehicles and screened from view from a public street by a close fence, wall or screen landscaping no less than 1.8m in height.
- (2) A person shall not use land for open storage purposes unless it is screened from public view by a fence or wall to the satisfaction of the local government.
- (3) The minimum standard fence shall be a 1.8m in height link mesh security fence unless otherwise approved by the local government.

#### 37. Development in the General Industry zone

- (1) All development shall provide at least one (1) refuse storage area readily accessible to service vehicles and screened from view from a public street by a close fence, wall or screen landscaping no less than 1.8m in height.
- (2) A person shall not use land for open storage purposes unless it is screened from public view by a fence or wall to the satisfaction of the local government.
- (3) The minimum standard fence shall be a 1.8m in height link mesh security fence unless otherwise approved by the local government.

# 38. General site requirements for development in the Residential, Rural Residential, Rural Smallholdings, Rural, Rural Townsite, Light Industry and General Industry zones.

(1) The minimum general site requirements for the development in the above zones are as follows:

#### 39. Access

- (1) Development approval of land will generally only be granted where the land has, or can be, provided with direct frontage access to a constructed public road, which is connected to the road system of the locality.
- (2) In considering an application for development approval on land abutting an undedicated and/or unconstructed road or a lot which does not have direct frontage to a dedicated and/or constructed road, the local government shall:
  - (a) refuse the application for development approval until the road has been dedicated and/or constructed or access by means of a dedicated and constructed road is provided as the case may be; or
  - (b) impose conditions of development approval requiring the applicant to pay a sum of money for the full and/or partial cost of upgrading and/or construction of the road; or
  - (c) require such other arrangements to be made for permanent legal access to the satisfaction of the local government.
- (3) Vehicular access and circulation areas for development, excluding a single house, ancillary accommodation and associated outbuildings, shall be designed and constructed so as to permit all vehicles of a type that may be reasonably be expected to visit the site on a regular basis, to enter and leave the site in a forward gear.

#### 40. Provision of car parking

- (1) In considering an application for development approval for the development or use of land for a purpose specified in Table 6, the local government shall require arrangements for the provision of car parking spaces not less than the number specified in Table 6.
- (2) Where a calculation made in accordance with Table 6 results in a number which is not a whole number, the number of parking spaces required shall be the next highest whole number.
- (3) Where a development application is made in respect to the development or use of land referred to in Table 3 Zoning Table for which no provision is made in respect of Table 6, the car parking spaces required for the use shall be as determined by the local government.
- (4) The size of car parking spaces and the vehicular driveways providing entry to, or exit from, a parking area shall be in accordance with Table 7 and the explanatory figure in Figure 1.
- (5) Where car parking spaces are required to be provided in accordance with this Scheme, the local government may grant a cash payment in lieu of the provision of some or all of those car parking spaces, if:

- (a) the payment is not less than the amount the local government estimates to be the cost to the landowner/applicant of providing and constructing those spaces together with the amount the local government estimates to be the value of the land which would have been occupied by those spaces; and
- (b) payment is made prior to commencement of the development in respect of which those spaces are required to be provided in accordance with the terms of any agreement made between the local government and the landowner/applicant for that development.
- (6) Any amount paid to the local government under subclause (5) shall be held by the local government in a separate reserve account or trust account and shall be applied by the local government:
  - (a) in providing car parking spaces or car parking facilities capable of serving the needs of the development in respect of which the payment was made and in the locality of the development; or
  - (b) to the acquisition of land and the construction of buildings for the purpose referred to in subclause (6)(a).
- (7) In considering an application for development approval in the Rural Townsite, Light Industry and General Industry zones the local government shall:
  - require the setting aside and designation of an area of appropriate size that is clear of the street for the purposes of loading and unloading goods and/or materials;
  - (b) require parking, loading/unloading and access arrangements, including drainage, signage, and marking as required by the local government, to be constructed prior to any occupation of the development, or at such time as may be agreed in writing between the local government and the landowner/applicant; and
  - (c) require external servicing areas to be constructed and maintained in perpetuity to the satisfaction of the local government.
- (8) The local government may grant development approval for 'Commercial Vehicle Parking' in the Residential, Rural Residential and Rural Smallholdings zones, provided that:
  - (a) satisfactory arrangements being made with the local government for the vehicle to be accommodated in a garage or structure or parked behind the main residential building line;
  - (b) the vehicle together with its load does not exceed three (3) metres in height;
  - (c) the vehicle forms an essential part of the lawful occupation of an occupant of the single house and that occupation, if carried on upon the lot, does not contravene the provisions of this Scheme:

- (d) the vehicle is not brought or taken from the land between the hours of midnight and 6:00am; and
- (e) no more than one (1) commercial vehicle shall be permitted to be parked.



#### 41. Caretaker's dwelling

- (1) Caretaker's dwelling:
  - (a) shall be limited to one dwelling per each lot;
  - (b) shall be limited in floor area to a maximum 100 m², measured from the external face walls. Open verandahs may be permitted, but if enclosed will form part of the total calculated floor area; and
  - (c) shall be incidental to the predominant use of the site.

- (2) The local government will not consider applications for caretaker's dwelling prior to the primary site activity being either approved or constructed.
- (3) Where simultaneous approval has been granted by the local government for both a caretaker's dwelling and the main activity on the same lot, the main activity must be developed and operational prior to occupation of the dwelling.
- (4) A caretaker's dwelling should be carefully sited and constructed so the potential site (or estate) impacts from noise, dust, odour or amenity are minimised.
- (5) The local government may consider the use of notifications on title to advise prospective landowners of potential impacts from noise, dust, odour or amenity that may arise from the location of a residential land use within the area.
- (6) A caretaker's dwelling shall only be occupied by the owner, manager, lessee or employee (and immediate family thereof) of the lawfully established or approved land use.
- (7) Subdivision of the caretaker's dwelling from the parent lot will not be permitted.

#### 42. Rural pursuit/hobby farm

- (1) Notwithstanding anything contained in the Zoning Table (Table 3), the local government may grant development approval for a 'rural pursuit/hobby farm' use within Residential zoned land with a density code of R2, R2.5 and R5.
- (2) In considering an application for development approval for a 'rural pursuit/hobby farm' use, the local government shall have due regard to any livestock stocking rates of the local government and State department responsible for agriculture, and any other relevant matter as listed in clause 67 of the deemed provisions.

#### 43. Requirement for consultation to commence mining

(1) In considering proposals to commercially extract minerals, the local government may exercise its discretion to inform the Minister for Mines and the Minister for Planning in writing that the granting of a mining lease or general purpose lease is contrary to the provisions of the Scheme and the Local Planning Strategy.

#### Part 5 - Special control areas

#### 44. Operation of special control areas

- (1) The following special control areas are shown on the Scheme Map:
  - (a) Special Control Area No. 1 Avon River Flood Prone Area.
  - (b) Special Control Area No. 2 Public Drinking Water Source Protection Area.
  - (c) Special Control Area No. 3 Basic Raw Materials Area.
  - (d) Special Control Area No. 4 Infrastructure.
- (2) In respect of the special control areas shown in the Scheme Map, the provisions applying to the special control area apply in addition to the provisions applying to the underlying zone or reserve and any general provisions of this Scheme.

#### 45. Special Control Area No.1 - Avon River Flood Prone Area

#### (1) Purpose

The purpose of Special Control Area No. 1 - Avon River Flood Prone Area is to:

- (a) protect against any increase threat of flooding to people, property and infrastructure;
- (b) avoid and limit development and land uses that would negatively impact upon the river and flood regime; and
- (c) ensure development is undertaken in such a manner it does not impact upon the floodway.

#### (2) Application

Development approval of the local government is required for any development, or use of land within Special Control Area No. 1 - Avon River Flood Prone Area.

#### (3) <u>Development requirements</u>

In addition to the requirements of clause 67 of the deemed provisions, in considering any planning proposal, including zoning requests and subdivision and/or development applications, the local government shall have due regard to the following:

- (a) potential nutrient export in the context of the soil and total water management cycle;
- (b) potential impact on river flow and increased flood levels upstream;
- (c) potential impact on environmental values, including riparian vegetation;
- (d) potential impact on water quality, including stormwater run-off.

Planning proposals that intensify development will generally not be supported by the local government.

Public works or community facilities may be permitted within this special control area, subject to advice from the State department responsible for water and flood management that such development can be designed and located in a manner so as to minimise flood risk, property damage and obstructions to river flow.

The local government may impose development conditions to require a minimum habitable floor level of 0.5m above the predicted 1 in 100 year flood level.

#### (4) Referral

Within this special control area, the local government shall have regard to the advice of relevant agencies, including the State department responsible for water and flood management.

#### 46. Special Control Area No. 2 - Public Drinking Water Source Protection Area

#### (1) Purpose

The purpose of Special Control Area No. 2 - Public Drinking Water Source Protection Area is to:

- (a) identify proclaimed drinking water source areas (PDWSA); and
- (b) ensure that development and land use within PDWSA is compatible with the protection and long-term management of water resources for public water supply.

#### (2) Application

Development approval of the local government is required for any development, or use of land within Special Control Area No. 2 - Public Drinking Water Source Protection Area.

#### (3) <u>Development requirements</u>

In addition to the requirements of clause 67 of the deemed provisions, in considering any planning proposal, including zoning requests and subdivision and/or development applications, the local government shall have due regard to the following:

- (a) potential impact on recharge area and surface water sources;
- (b) relevant State policy and guidance frameworks.

#### (4) Referral

Within this special control area, the local government will generally refer any development application which involves the following activities to the State department responsible for water prior to determination:

- (a) potential increased nutrient loading, in particular point source for nutrients;
- (b) application of fertilisers and pesticides;

- (c) storage of chemicals, fuels and other potentially polluting substances;
- (d) substantial increase in water run-off; and
- (e) any other impact which the local government considers could have any impact on the quality of public drinking water.

#### 47. Special Control Area No. 3 - Basic Raw Materials Area

#### (1) Purpose

The purpose of Special Control Area No. 3 - Basic Raw Materials Area is to:

- (a) identify and protect significant geological supplies; and
- (b) ensure for the appropriate extraction and use of basic raw materials in accordance with State policy.

#### (2) Application

Development approval of the local government is required for any development, or use of land within Special Control Area No. 3 - Basic Raw Material Area.

#### (3) Development requirements

In addition to the requirements of clause 67 of the deemed provisions, in considering any planning proposal, including zoning requests and subdivision and/or development applications, the local government shall have due regard to State policy.

#### (4) Referral

Within this special control area, the local government is required to refer development applications to the State department responsible for mining prior to determination.

#### 48. Special Control Area No. 4 - Infrastructure

#### (1) Purpose

The purpose of Special Control Area No. 4 – Infrastructure is to:

- (a) ensure compatibility of development and land use with wastewater infrastructure; and
- (b) prevent land use conflict and protect the communities infrastructure investment by ensuring that odour sensitive land uses are not permitted in the wastewater treatment plant odour buffer.

#### (2) Application

Development approval of the local government is required for any development, or use of land within Special Control Area No. 4 - Infrastructure.

#### (3) Development requirements

In addition to the requirements of clause 67 of the deemed provisions, in considering any planning proposal, including zoning requests and subdivision and/or development applications, the local government shall have due regard to the following:

- (a) the proximity of development to the emission source and potential risk and impact arising;
- (b) the sensitivity of the proposed development and/or land use to off-site emissions and risk;
- (c) any other relevant planning consideration.

#### (4) Referral

Within this special control area, the local government is required to refer planning proposals to the relevant wastewater service provider prior to determination.

### Part 6 - Terms referred to in Scheme

### Division 1 - General definitions used in Scheme

### **49.** Terms used

(1) If a word used in this Scheme is listed in this clause the meaning of the word is as set out below –

### building envelope

means the area of land within which all buildings and effluent disposal facilities on a lot must be contained.

### building height

in relation to a building —

- (a) if the building is used for residential purposes, has the meaning given in the R-Codes; or
- (b) if the building is used for purposes other than residential purposes, means the maximum vertical distance between the natural ground level and the finished roof height directly above, excluding minor projections as that term is defined in the R-Codes.

### cabin

means a dwelling forming part of a tourist development or caravan park that is -

- (a) an individual unit other than a chalet; and
- (b) designed to provide short-term accommodation for guests.

### chalet

means a dwelling forming part of a tourist development or caravan park that is -

- (a) a self-contained unit that includes cooking facilities, bathroom facilities and separate living and sleeping areas;
- (b) designed to provide short-term accommodation for guests.

### commencement day

means the day this Scheme comes into effect under section 87(4) of the Act.

### commercial vehicle

means a vehicle, whether licenced or not, that has a gross vehicle mass of greater than 4.5 tonnes including –

- (a) a utility, van, truck, tractor, bus or earthmoving equipment; and
- (b) a vehicle that is, or is designed to be an attachment to a vehicle referred to in paragraph (a).

#### floor area

has meaning given in the Building Code.

### frontage

in relation to a building -

- (a) if the building is used for residential purposes, has the meaning given in the R-Codes; or
- (b) if the building is used for purposes other than residential purposes, means the line where a road reserve and the front of a lot meet and, if a lot abuts 2 or more road reserves, the one to which the building or proposed building faces.

### incidental use

means a use of premises which is consequent on, or naturally attaching, appertaining or relating to, the predominant use.

### minerals

has the meaning given in the Mining Act 1978 section 8(1).

### net lettable area (nla)

means the area of all floors within the internal finished surfaces of permanent walls but does not include the following areas –

- (a) stairs, toilets, cleaner's cupboards, lift shafts and motor rooms, escalators, tea rooms and plant rooms, and other service areas;
- (b) lobbies between lifts facing other lifts serving the same floor;
- (c) areas set aside as public space or thoroughfares and not for the exclusive use of occupiers of the floor or building;
- (d) areas set aside for the provision of facilities or services to the floor or building where those facilities are not for the exclusive use of occupiers of the floor or building.

### non-conforming use

has the meaning given in the *Planning and Development Act 2005* section 172.

plot ratio

means the ratio of the floor area of a building to an area of land within the boundaries of the lot or lots on which the building is located.

precinct

means a definable area where particular planning policies, guidelines or standards apply.

predominant use

means the primary use of premises to which all other uses carried out on the premises are subordinate, incidental or ancillary.

retail

means the sale or hire of goods or services to the public.

short-term accommodation

means temporary accommodation provided either continuously or from time to time with no guest accommodated for periods totalling more than 3 months in any 12 month period.

### wall height

in relation to a wall of a building —

- (a) if the building is used for residential purposes, has the meaning given in the R-Codes; or
- (b) if the building is used for purposes other than residential purposes, means the vertical distance from the natural ground level of the boundary of the property that is closest to the wall to the point where the wall meets the roof or parapet.

### wholesale

means the sale of goods or materials to be sold by others.

- (2) A word or expression that is not defined in this scheme
  - (a) has the meaning it has in the Planning and Development Act 2005; or
  - (b) if it is not defined in that Act has the same meaning as it has in the R-Codes.

### Division 2 - Land use terms used in Scheme

### abattoir

means premises used commercially for the slaughtering of animals for the purposes of consumption as food products.

### agriculture - extensive

means premises used for the raising of stock or crops including outbuildings and earthworks, but does not include agriculture - intensive or animal husbandry - intensive.

### agriculture - intensive

means premises used for commercial production purposes, including outbuildings and earthworks, associated with any of the following -

- (a) the production of grapes, vegetables, flowers, exotic or native plants, or fruit or nuts;
- (b) the establishment and operation of plant or fruit nurseries:
- (c) the development of land for irrigated fodder production or irrigated pasture (including turf farms);
- (d) aquaculture.

### amusement parlour

means premises -

- (a) that are open to the public; and
- (b) that are used predominantly for amusement by means of amusement machines including computers; and
- (c) where there are 2 or more amusement machines.

### animal establishment

means premises used for the breeding, boarding, training or caring of animals for commercial purposes but does not include animal husbandry - intensive or veterinary centre.

### animal husbandry - intensive

means premises used for keeping, rearing or fattening of pigs, poultry (for either egg or meat production), rabbits (for either meat or fur production) or other livestock in feedlots, sheds or rotational pens.

### art gallery

means premises -

- (a) that are open to the public; and
- (b) where artworks are displayed for viewing or sale.

### bed and breakfast

means a dwelling -

- (a) used by a resident of the dwelling to provide short-term accommodation, including breakfast, on a commercial basis for not more than 4 adult persons or one family; and
- (b) containing not more than 2 guest bedrooms.

### betting agency

means an office or totalisator agency established under the Racing and Wagering Western Australia Act 2003.

### brewery

means premises the subject of a producer's licence authorising the production of beer, cider or spirits granted under the *Liquor Control Act 1988*.

### bulky goods showroom

### means premises -

- (a) used to sell by retail any of the goods and accessories of the following types that are principally used for domestic purposes
  - (i) automotive parts and accessories;
  - (ii) camping, outdoor and recreation goods;
  - (iii) electric light fittings;
  - (iv) animal supplies including equestrian and pet goods;
  - (v) floor and window coverings;
  - (vi) furniture, bedding, furnishings, fabrics, manchester and homewares:
  - (vii) household appliances, electrical goods and home entertainment goods;
  - (viii) party supplies;
  - (ix) office equipment and supplies;
  - (x) babies' and children's goods, including play equipment and accessories;
  - (xi) sporting, cycling, leisure, fitness goods and accessories;
  - (xii) swimming pools. Or
  - (b) used to sell goods and accessories by retail if -

# (i) a large area is required for the handling, display or storage of the goods; or vehicular access is required means premises that are a caravan park as defined in the *Caravan Parks and Camping Grounds Act 1995* section 5 (1).

### caravan park

### caretaker's dwelling

means a dwelling on the same site as a building, operation or plant, and occupied by a supervisor of that building, operation or plant.

### car park

means premises used primarily for parking vehicles whether open to the public or not but does not include -

- (a) any part of a public road used for parking or for a taxi rank; or
- (b) any premises in which cars are displayed for sale.

### child care premises

means premises where -

- (a) an education and care service as defined in the Education and Care Services National Law (Western Australia) section 5(1), other than a family day care service as defined in that section, is provided; or
- (b) a child care service as defined in the *Child Care Services Act* 2007 section 4 is provided.

### cinema/theatre

means premises where the public may view a motion picture or theatrical production.

### civic use

means premises used by a government department, an instrumentality of the State or the local government for administrative, recreational or other purposes.

### club premises

means premises used by a legally constituted club or association or other body of persons united by a common interest.

### commercial vehicle parking

means premises used for parking of one or 2 commercial vehicles but does not include —

- (a) any part of a public road used for parking or for a taxi rank; or
- (b) parking of commercial vehicles incidental to the predominant use of the land.

### community purpose

means premises designed or adapted primarily for the provision of educational, social or recreational facilities or services by organisations involved in activities for community benefit.

### consulting rooms

means premises used by no more than 2 health practitioners at the same time for the investigation or treatment of human injuries or ailments and for general outpatient care.

#### convenience store

means premises —

- (a) used for the retail sale of convenience goods commonly sold in supermarkets, delicatessens or newsagents; and
- (b) operated during hours which include, but may extend beyond, normal trading hours; and
- (c) the floor area of which does not exceed 300 m2 net lettable Area.

### corrective institution

means premises used to hold and reform persons committed to it by a court, such as a prison or other type of detention facility.

### educational establishment

means premises used for the purposes of providing education including premises used for a school, higher education institution, business college, academy or other educational institution.

### exhibition centre

means premises used for the display, or display and sale, of materials of an artistic, cultural or historical nature including a museum.

### family day care

means premises where a family day care service as defined in the *Education and Care Services National Law (Western Australia)* is provided.

### fast food outlet/lunch bar

means premises, including premises with a facility for drive-through service, used for the preparation, sale and serving of food to customers in a form ready to be eaten —

- (a) without further preparation; and
- (b) primarily off the premises.

### fuel depot

means premises used for the storage and sale in bulk of solid or liquid or gaseous fuel but does not include premises used —

- (a) as a service station; or
- (b) for the sale of fuel by retail into a vehicle for use by the vehicle.

### funeral parlour

means premises used -

- (a) to prepare and store bodies for burial or cremation;
- (b) to conduct funeral services.

### garden centre

means premises used for the propagation, rearing and sale of plants, and the storage and sale of products associated with horticulture and gardens.

#### guest house

means a dwelling or part of a dwelling occupied by a person but containing rooms used to accommodate short-term guests for hire or reward.

### holiday accommodation

means 2 or more dwellings on one lot used to provide short term accommodation for persons other than the owner of the lot.

### holiday house

means a single dwelling on one lot used to provide short-term accommodation but does not include a bed and breakfast.

#### home business

means a dwelling or land around a dwelling used by an occupier of the dwelling to carry out a business, service or profession if the carrying out of the business, service or profession —

- (a) does not involve employing more than 2 people who are not members of the occupier's household; and
- (b) will not cause injury to or adversely affect the amenity of the neighbourhood; and
- (c) does not occupy an area greater than 50 m<sup>2</sup>; and
- (d) does not involve the retail sale, display or hire of any goods unless the sale, display or hire is done only by means of the Internet: and
- (e) does not result in traffic difficulties as a result of the inadequacy of parking or an increase in traffic volumes in the neighbourhood; and
- (f) does not involve the presence, use or calling of a vehicle of more than 4.5 tonnes tare weight; and
- (g) does not involve the use of an essential service that is greater than the use normally required in the zone in which the dwelling is located.

### home occupation

means a dwelling or land around a dwelling used by an occupier of the dwelling to carry out an occupation if the carrying out of the occupation that —

- (a) does not involve employing a person who is not a member of the occupier's household; and
- (b) will not cause injury to or adversely affect the amenity of the neighbourhood; and
- (c) does not occupy an area greater than 20 m2; and
- (d) does not involve the display on the premises of a sign with an area exceeding 0.2 m2; and
- does not involve the retail sale, display or hire of any goods unless the sale, display or hire is done only by means of the Internet; and
- (f) does not -
- (i) require a greater number of parking spaces than normally required for a single dwelling; or
- (ii) result in an increase in traffic volume in the neighbourhood; and
- (g) does not involve the presence, use or calling of a vehicle of more than 4.5 tonnes tare weight; and
- (h) does not include provision for the fuelling, repair or maintenance of motor vehicles; and
- (i) does not involve the use of an essential service that is greater than the use normally required in the zone in which the means a dwelling used by an occupier of the dwelling to carry out a home occupation if the carrying out of the occupation —
- (a) is solely within the dwelling; and
- (b) does not entail clients or customers travelling to and from the dwelling; and
- (c) does not involve the display of a sign on the premises; and
- (d) does not require any change to the external appearance of the dwelling.

### home store

means a shop attached to a dwelling that —

- (a) has a net lettable area not exceeding 100 m<sup>2</sup>; and
- (b) is operated by a person residing in the dwelling.

### hospital

means premises that are a hospital within the meaning given in the *Health Services Act 2016* section 8(4).

### hotel

means premises the subject of a hotel licence other than a small bar or tavern licence granted under the *Liquor Control Act 1988* including any betting agency on the premises.

### industry

means premises used for the manufacture, dismantling, processing, assembly, treating, testing, servicing, maintenance or repairing of goods, products, articles, materials or substances and includes facilities on the premises for any of the following purposes —

- (a) the storage of goods;
- (b) the work of administration or accounting;
- (c) the selling of goods by wholesale or retail;
- (d) the provision of amenities for employees;
- (e) incidental purposes.

### home office

### industry - extractive

means premises, other than premises used for mining operations, that are used for the extraction of basic raw materials including by means of ripping, blasting or dredging and may include facilities for any of the following purposes —

(a) the processing of raw materials including crushing, screening, washing, blending or grading:

(b) activities associated with the extraction of basic raw materials including wastewater treatment, storage, rehabilitation, loading, transportation, maintenance and administration.

### industry - light

means premises used for an industry where impacts on the amenity of the area in which the premises is located can be mitigated, avoided or managed.

### industry - primary production

means premises used —

(a) to carry out a primary production business as that term is defined in the *Income Tax Assessment Act 1997* (Commonwealth) section 995-1; or

(b) for a workshop servicing plant or equipment used in primary production businesses.

### land drainage works

means all work undertaken, on lots/location which have any potential for significant off-site impacts, in the interest of altering contours, directing land or storing stormwater and/or natural runoff, through or on any property, via landfill or construction such as contours banks, dam or any on-side building stormwater runoff system.

### market

means premises used for the display and sale of goods from stalls by independent vendors.

### medical centre

means premises other than a hospital used by 3 or more health practitioners at the same time for the investigation or treatment of human injuries or ailments and for general outpatient care.

### mining operations

means premises where mining operations, as that term is defined in the *Mining Act 1978* section 8(1) is carried out.

### motel

means premises, which may be licensed under the *Liquor Control Act 1988* —

(a) used to accommodate guests in a manner similar to a hotel; and

(b) with specific provision for the accommodation of guests with motor vehicles.

### motor vehicle, boat or caravan sales

means premises used to sell or hire motor vehicles, boats or caravans.

### motor vehicle repair

means premises used for or in connection with —

(a) electrical and mechanical repairs, or overhauls, to vehicles other than panel beating, spray painting or chassis reshaping of vehicles; or

(b) repairs to tyres other than recapping or re-treading of tyres.

### motor vehicle wash

means premises primarily used to wash motor vehicles.

nightclub means premises the subject of a nightclub licence granted

under the Liquor Control Act 1988.

office means premises used for administration, clerical, technical,

professional or similar business activities.

park home park means premises used as a park home park as defined in the

Caravan Parks and Camping Grounds Regulations 1997 Schedule

8.

place of worship means premises used for religious activities such as a chapel,

church, mosque, synagogue or temple.

reception centre means premises used for hosted functions on formal or ceremonial

occasions.

recreation - private means premises that are —

(a) used for indoor or outdoor leisure, recreation or sport; and

(b) not usually open to the public without charge.

repurposed dwelling means a building or structure not previously used as a single house,

which has been repurposed for use as dwelling

resource recovery centre

means premises other than a waste disposal facility used for the

recovery of resources from waste.

restaurant/cafe means premises primarily used for the preparation, sale and serving

of food and drinks for consumption on the premises by customers for whom seating is provided, including premises that are licenced

under the Liquor Control Act 1988.

restricted premises means premises used for the sale by retail or wholesale, or the offer

for hire, loan or exchange, or the exhibition, display or delivery of —

(a) publications that are classified as restricted under the Classification (Publications, Films and Computer Games)

Act 1995 (Commonwealth); or

(b) materials, compounds, preparations or articles which are used

or intended to be used primarily in or in connection with any

form of sexual behaviour or activity; or

(c) smoking-related implements.

#### rural home business

means a dwelling or land around a dwelling used by an occupier of the dwelling to carry out a business, service or occupation if the carrying out of the business, service or occupation —

- (a) does not involve employing more than 2 people who are not members of the occupier's household; and
- (b) will not cause injury to or adversely affect the amenity of the neighbourhood; and
- (c) does not occupy an area greater than 200 m<sup>2</sup>; and
- (d) does not involve the retail sale, display or hire of any goods unless the sale, display or hire is done only be means of the

Internet; and

- (e) does not result in traffic difficulties as a result of the inadequacy of parking or an increase in traffic volumes in the neighbourhood; and
- (f) does not involve the presence, use or calling of more than 3 vehicles at any one time or of a vehicle of more than 30 tonnes gross weight.

### rural pursuit/hobby farm

means any premises, other than premises used for agriculture — extensive or agriculture — intensive, that are used by an occupier of the premises to carry out any of the following activities if carrying out of the activity does not involve permanently employing a person who is not a member of the occupier's household —

- (a) the rearing, agistment, stabling or training of animals;
- (b) the keeping of bees;
- (c) the sale of produce grown solely on the premises.

### second-hand dwelling

means a dwelling that has been in a different location, and has been dismantled and transported to another location, but does not include a new modular or transportable dwelling.

### service station

means premises other than premises used for a transport depot, panel beating, spray painting, major repairs or wrecking, that are used for —

- (a) the retail sale of petroleum products, motor vehicle accessories and goods of an incidental or convenience nature;
- (b) the carrying out of greasing, tyre repairs and minor mechanical repairs to motor vehicles.

### shop

means premises other than a bulky goods showroom, a liquor store — large or a liquor store — small used to sell goods by retail, to hire goods, or to provide services of a personal nature, including hairdressing or beauty therapy services.

#### small bar

means premises the subject of a small bar licence granted under the *Liquor Control Act 1988*.

#### tavern

means premises the subject of a tavern licence granted under the *Liquor Control Act 1988*.

### telecommunications infrastructure

means premises used to accommodate the infrastructure used by or in connection with a telecommunications network including any line, equipment, apparatus, tower, antenna, tunnel, duct, hole, pit or other structure related to the network.

tourist development

means a building, or a group of buildings forming a complex, other

than a bed and breakfast, a caravan park or holiday

accommodation, used to provide -

(a) short-term accommodation for guests; and (b) onsite facilities for the use of guests; and

(c) facilities for the management of the development.

trade display

means premises used for the display of trade goods and equipment

for the purpose of advertisement.

trade supplies

means premises used to sell by wholesale or retail, or to hire, assemble or manufacture any materials, tools, equipment,

machinery or other goods used for the following purposes including goods which may be assembled or manufactured off the premises

(a) automotive repairs and servicing;

(b) building including repair and maintenance;

(c) industry;

(d) landscape gardening;

(e) provision of medical services;

(f) primary production;

(g) use by government departments or agencies, including local

government.

transport depot

means premises used primarily for the parking or garaging of 3 or

more commercial vehicles including —

(a) any ancillary maintenance or refuelling of those vehicles; and

(b) any ancillary storage of goods brought to the premises by

those vehicles; and

(c) the transfer of goods or persons from one vehicle to another.

tree farm

means land used commercially for tree production where trees are planted in blocks of more than one hectare, including land in respect of which a carbon right is registered under the *Carbon Rights Act 2003* section 5.

veterinary centre

means premises used to diagnose animal diseases or disorders, to surgically or medically treat animals, or for the prevention of animal diseases or disorders

warehouse/storage

means premises including indoor or outdoor

facilities used for —

(a) the storage of goods, equipment, plant or materials; or

(b) the display or sale by wholesale of goods.

waste disposal facility

means premises used —

(a) for the disposal of waste by landfill; or

(b) the incineration of hazardous, clinical or biomedical waste.

waste storage facility

means premises used to collect, consolidate,

temporarily store or sort waste before transfer to a waste disposal facility or a resource recovery facility on a commercial scale.

wind farm

means premises used to generate electricity by wind force and any associated turbine, building or other structure but does not include anemometers or turbines used primarily to supply electricity for a

domestic property or for private rural use.

### winery

means premises used for the production of viticultural produce and associated sale of the produce.

## workforce accommodation

means premises, which may include modular or relocatable buildings, used —

- (a) primarily for the accommodation of workers engaged in construction, resource, agricultural or other industries on a temporary basis; and
- (b) for any associated catering, sporting and recreation facilities for the occupants and authorised visitors.
