Sections 157(1)(e), 157(1)(k), 180 and 190(1)(p)

EDUCATION WORKER (RESTRICTIONS ON ACCESS) DIRECTIONS (No 5)

The World Health Organization declared COVID-19 a pandemic on 11 March 2020.

On 23 March 2020, the Minister for Health declared a public health state of emergency with effect from 1.30 pm on 23 March 2020 in respect of COVID-19 pursuant to section 167 of the *Public Health Act 2016* (WA) (**Act**). On 22 September 2021, the Minister for Health declared a further public health state of emergency with effect from 4.25 pm on 22 September 2021 in respect of COVID-19 pursuant to section 167 of the Act. The public health state of emergency applies to the State of Western Australia.

I, Dr Andrew Robertson, the Chief Health Officer, authorised as an emergency officer under section 4 of the Act to exercise any of the emergency powers while the public health state of emergency declaration in respect of COVID-19 is in force, consider it reasonably necessary to give the following directions to all persons in Western Australia to prevent, control or abate the serious public health risk presented by COVID-19 pursuant to sections 157(1)(e), 157(1)(k), 180 and 190(1)(p) of the Act.

PREAMBLE

1. The purpose of these directions is to put in place some measures to address the unique risks posed by COVID-19 to the education workforce for the purpose of preventing the spread of COVID-19 to children, students, families and members of the education workforce in Western Australia and the closure of education facilities due to outbreaks.

CITATION

2. These directions may be referred to as the **Education Worker (Restrictions on Access) Directions (No 5)**.

COMMENCEMENT

3. These directions come into effect upon signing.

REVOCATION

4. The Education Worker (Restrictions on Access) Directions (No 4) are revoked.

DIRECTIONS

Access Restrictions Applying to Education Workers

5. Subject to paragraphs 6 and 7:
- (a) on and from 12:01am on 1 January 2022, a person who is an **education worker** must not enter, or remain at, an **education facility** if the education worker has not been **partially vaccinated** against COVID-19; or
 - (b) on and from 12:01am on 31 January 2022, a person who is an education worker must not enter, or remain at, an education facility if the education worker has not been **fully vaccinated** against COVID-19,
- unless the person is present at the education facility solely in a capacity other than as an education worker or is an **exempt person**.

General Vaccination Requirements

6. Where only part of **premises** are being used as an education facility, nothing in these directions prevents an education worker who does not meet the requirements of paragraph 5 from entering that part of the premises which is not being used as an education facility.
7. Nothing in these directions prevents a person who is not vaccinated against COVID-19 from entering any part of an education facility for the purposes of:
- (a) performing a statutory duty arising under a law of the Commonwealth that cannot reasonably be performed other than by entering the education facility; or
 - (b) performing any function or duty or exercising any right or power under a Fair Work entry permit issued by the Fair Work Commission under the *Fair Work Act 2009* (Cth) or a Work Health and Safety entry permit issued by the Fair Work Commission under the *Work Health and Safety Act 2011* (Cth) or a right of entry permit issued by the Registrar of the Department of the Registrar, Western Australian Industrial Relations Commission under the *Industrial Relations Act 1979* (WA);
 - (c) responding to an emergency where the emergency response is required to be provided immediately and a fully vaccinated or partially vaccinated person is not available to provide the response; and

- (d) in any circumstances approved in writing by the **Chief Health Officer** or a person authorised in writing by the Chief Health Officer for that purpose and subject to any conditions expressed in that approval.
- 8. An education worker must provide evidence in the form approved by the Chief Health Officer of their **vaccination status** for inspection, recording and retention of a copy if:
 - (a) **directed** to do so by an **emergency officer** or a **nominated officer**; or
 - (b) required to do so by their employer, **principal** or the person in charge of the education facility.
- 9. The employer, principal or the person in charge of the education facility must:
 - (a) take all reasonable and lawful steps to:
 - (i) collect and maintain a record of the vaccination status of each education worker; and
 - (ii) only roster on, or otherwise permit to work in an education facility, an education worker who is vaccinated or is an exempt person in accordance with these directions;
 - (iii) if they are the principal or person in charge of the education facility, only permit an education worker who is vaccinated or an exempt person in accordance with these directions to enter, or remain at, the education facility, unless the person is present at the education facility solely in a capacity other than as an education worker; and
 - (b) on request, provide any record of the kind referred to in paragraph 9(a)(i), that the employer, principal or the person in charge of the education facility has collected and maintained to an emergency officer or nominated officer as soon as practicable after the request is made; and
 - (c) not use or disclose any record of the kind referred to in paragraph 9(a)(i) except:
 - (i) as provided for in this paragraph 9; or
 - (ii) as permitted or required by law, including any law of the Commonwealth; or
 - (iii) for the purpose of ascertaining compliance with any employer direction restricting entry to an education facility; or
 - (iv) to the extent that the person expressly provided the person's vaccination status for a purpose other than for the purposes of these directions; and
 - (d) take reasonable steps to protect any record it holds of the kind referred to in paragraph 9(a)(i) from:

- (i) misuse and loss; and
 - (ii) unauthorised access, modification or disclosure.
- 10. A person who is required to provide evidence of their vaccination status under paragraph 8 or a record of the kind referred to in paragraph 9(a)(i) under paragraph 9(b) must only provide that evidence or a record that is true and accurate.
- 11. The forms of evidence approved in the *Chief Health Officer Approved Form Of Evidence Of COVID-19 Vaccination Under Each Of The Restrictions On Access Directions Given Under The Public Health Act 2016 (WA) In Respect Of COVID-19*, as amended or replaced from time to time, are approved for the purposes of paragraph 8 of this direction.

INTERPRETATION

- 12. Unless specified otherwise, any reference in these directions to any other **direction** made by the Chief Health Officer is deemed to be a reference to that direction as amended or replaced from time to time.

DEFINITIONS

For the purposes of these directions:

- 13. **Ad hoc basis** means attendance at no more than one education facility no more than once per week.
Note: A person who attends multiple education facilities in a week, but does not visit the same education facility twice, does not attend on an ad hoc basis. For example, a tradesperson who works at school A on Monday and then works at school B on Wednesday of the same week must comply with the vaccination requirements in these directions.
- 14. **Ad hoc volunteer** means a person who provides goods or services at an education facility in a voluntary or unpaid capacity and does so on an **ad hoc basis** only.
- 15. **Boarding premise** means a premise used to provide boarding or residential accommodation for students to attend, and participate in an educational programme of, a school.
Note: A boarding premise includes a student residential college established under the School Education Act 1999 (WA).
- 16. **Chief Health Officer** has the same meaning that it has in the Act.

17. **Child care service** has the same meaning that it has in the *Child Care Services Act 2007* (WA).

18. **Child care service facility** means a premise where an **education and care service**, a **child care service** or a vacation care program is provided.

Note: A child care service facility includes a premise where a family day care service or an outside school hours service is provided. A child care service facility does not include premises used for a play group or premises used solely to provide sport, dance, music, culture or language or religious instruction to children.

19. **Child care worker** means:

- (a) a person of the kind set out in Column 1 of the table in Schedule 1; or
- (b) any other person or class of persons specified in writing to be a child care worker by the Chief Health Officer or any person authorised by the Chief Health Officer for that purpose,

but does not include:

- (c) a person who enters any part of an education facility for any of the purposes in paragraph 7; or
- (d) a person of the kind set in Column 2 of the table in Schedule 1.

20. **College** has the same meaning that it has in the *Vocational Education and Training Act 1996* (WA).

21. **Community kindergarten** means a kindergarten registered under Part 5 of the *School Education Act 1999* (WA).

22. **Community kindergarten worker** means:

- (a) a person of the kind set out in Column 1 of the table in Schedule 2; or
- (b) any other person or class of persons specified in writing to be a community kindergarten worker by the Chief Health Officer or any person authorised by the Chief Health Officer for that purpose,

but does not include:

- (c) a person who enters any part of an education facility for any of the purposes in paragraph 7; or
- (d) a person of the kind set out in Column 2 of the table in Schedule 2.

23. **Direction** includes any direction under the Act, whether the direction is given orally or in writing, and **directed** includes directed by way of a direction under the Act, whether the direction is given orally or in writing.

24. **Education and care service** has the same meaning that it has in the *Education and Care Services National Law (Western Australia)*.
25. **Education facility** means:
- (a) a **school**;
 - (b) a **community kindergarten**;
 - (c) a **child care service facility**;
 - (d) a **vocational education and training institution**; or
 - (e) a **boarding premise**.
26. **Education worker** means:
- (a) a **school worker**;
 - (b) a **community kindergarten worker**;
 - (c) a **child care worker**; or
 - (d) a **vocational education and training worker**,
27. **Emergency officer** has the same meaning that it has in the Act.
28. **Exempt person** means, to the extent that any such person is an education worker:
- (a) a person who has:
 - (i) a **medical exemption** of which the person provides proof on request by a person referred to in paragraph 8; or
 - (ii) a **temporary exemption** of which the person provides proof on request by a person referred to in paragraph 8; or
 - (b) any other person or class of persons who the Chief Health Officer, or a person authorised by the Chief Health Officer for the purposes of this paragraph, declares in writing to be an exempt person upon receipt of a request for exemption in the form specified by the Chief Health Officer and subject to any terms and conditions specified.
29. **Exempt VET premise** means a premise:
- (a) where vocational education and training is provided by a **registered training provider**; and
 - (b) where all vocational education and training provided at the premise under paragraph 29(a) is delivered online or without any in-person contact with enrolled students; and
 - (c) the Chief Health Officer, or a person authorised by the Chief Health Officer for the purposes of this paragraph, declares the premise in writing to be an exempt VET premise upon receipt of a request for exemption by the registered training

provider in the form specified by the Chief Health Officer and subject to any terms and conditions specified.

30. **Fully vaccinated** means that the person has been administered with two doses of a COVID-19 vaccine registered by the Therapeutic Goods Administration.
31. **Group 1 or Group 2 industry or occupation** means an industry or occupation where a mandatory vaccination direction applies.
32. **Group 1 or Group 2 industry or work site** means a premise for which a mandatory vaccination direction applies.
33. **Home educator** has the same meaning it has in the *School Education Act 1999* (WA).
34. **Medical exemption** means a medical exemption recorded on the Australian Immunisation Register and displayed on the individual's Immunisation History Statement.
35. **Nominated officer** means an employee engaged by the Department of Education, the Department of Training and Workforce Development or the Department of Communities authorised by the Chief Health Officer orally or in writing to perform a function for the purposes of these directions.
36. **Partially vaccinated** means that the person has been administered with one dose of a COVID-19 vaccine registered by the Therapeutic Goods Administration.
37. **Premises** has the same meaning it has in the Act.
38. **Principal** has the same meaning it has in the *School Education Act 1999* (WA).
39. **Registered training provider** has the same meaning it has in the *Vocational Education and Training Act 1996* (WA).
40. **School** includes:
 - (a) a government school or a non-government school as defined in section 4 of the *School Education Act 1999* (WA);
 - (b) a premise that provides compulsory education to a child of compulsory school age other than a premise used by a **home educator**; and
 - (c) the site known as State Wide Services located at 33 Giles Ave, Padbury, Western Australia.
41. **School hours** means the hours of the day that a child of compulsory school age is required to attend a school.

Note: School hours do not include hours when students may attend the school for extracurricular activities that are not compulsory, such as band practice, sporting practice, theatre productions and parent teacher evenings.

42. **School worker** means:
- (a) a person of the kind set out in Column 1 of the table in Schedule 3;
 - (b) any other person or class of persons specified in writing to be a school worker by the Chief Health Officer or any person authorised by the Chief Health Officer for that purpose,
- but does not include:
- (c) a person who enters any part of an education facility for any of the purposes in paragraph 7; or
 - (d) a person of the kind set out in Column 2 of the table in Schedule 3.
43. **Temporary exemption** means an exemption approved by the Chief Health Officer or a person authorised by the Chief Health Officer for that purpose whether in relation to an individual or a class of persons and subject to any terms and conditions specified in that approval.
44. **University** means a university established under a written law.
45. **Vaccination status** means whether an education worker has been vaccinated or whether they are an exempt person.
46. **Vocational education and training** has the same meaning it has in the *Vocational Education and Training Act 1996* (WA).
47. **Vocational education and training institution** means a premise where **vocational education and training** is provided by a registered training provider, including a **college**, but does not include a school or a **university** or an **exempt VET premise**.
- Note: A vocational education and training institution includes a Technical and Further Education (TAFE) college. A vocational education and training institution does not include a university.*
48. **Vocational education and training worker** means:
- (a) a person of the kind set out in Column 1 of the table in Schedule 4; or
 - (b) any other person or class of persons specified in writing to be a vocational education and training worker by the Chief Health Officer or any person authorised by the Chief Health Officer for that purpose,
- but does not include:
- (c) a person who enters any part of an education facility for any of the purposes in paragraph 7; or
 - (d) a person of the kind set out in Column 2 of the table in Schedule 4.

PENALTIES

It is an offence for a person to fail, without reasonable excuse, to comply with any of these directions, punishable by a fine of up to \$20,000 for individuals and \$100,000 for bodies corporate.
