# COVID TRANSITION (PUBLIC HEALTH AND SOCIAL MEASURES) DIRECTIONS (NO 2)

### **DESIGNATION UNDER PARAGRAPH 54**

I, Jaala Downes, Senior Scientific Officer, having been approved by the State Emergency Coordinator for the purposes of paragraph 54 of the COVID Transition (Public Health and Social Measures) Directions (No 2), designate the **TABTouch Geraldton Gold Cup Day gathering** as an exempt gatherings for the purposes of the COVID Transition (Public Health and Social Measures) Directions (No 2) subject to the terms and conditions set out below.

#### TERMS AND CONDITIONS

- 1. A person must not hold, conduct, participate in, or attend a relevant TABTouch Geraldton Gold Cup Day gathering unless:
  - (a) in the grandstands at **Geraldton Turf Club** with fixed forward facing seating, the number of patrons present does not exceed 75% of capacity or 2 square metres of publicly available space for each person present within each grandstand (whichever is the greater); and
  - (b) in any other single undivided indoor space within the Geraldton Turf Club there are:
    - (i) no more than 500 patrons present within the single undivided outdoor space at the same time; and
    - (ii) there are at least 2 square metres of publicly available space for each person present within the single undivided indoor space; and
  - (c) on the outdoor grassed area within the Geraldton Turf Club there are at least 2 square metres of publicly available space for each person present in the outdoor grassed area; and
  - (d) there are no more than 1500 patrons present at the Geraldton Turf Club at the same time during the relevant TABTouch Geraldton Gold Cup Day gathering.

## INTERPRETATION

- 2. Unless specified otherwise, any reference in this designation to a direction made by the State Emergency Coordinator is deemed to be a reference to that direction as amended or replaced from time to time.
- 3. Unless specified otherwise, words and expressions used in this designation have the same meaning as they have in the COVID Transition (Public Health and Social Measures) Directions (No 2).

#### **DEFINITION**

- 4. **Geraldton Turf Club** means that part of Geraldton Turf Club located at 71 Eastward Road Geraldton WA 6530 at which a **race meeting** is being conducted, including any areas or facilities necessary or reasonably incidental to the conduct a race meeting.
- 5. **TABTouch Geraldton Gold Cup Day gathering** means a race meeting at the Geraldton Racecourse on the 10 April 2022, during the period:
  - (a) commencing two hours before the race meeting; and
  - (b) ending two hours after the completion of the race meeting.
- 6. Race meeting means a horse racing event that is a registered meeting.
- 7. **Registered meeting** has the same meaning that it has in the Racing and Wagering WA document entitled "RWWA Rules of Thoroughbred Racing 1 March 2019".
