The whole of Lot 802 on Plan 39991 as comprised on Certificate of Title Volume 2568 Folio 751

Reasons for which this vegetation conservation notice is given:

This vegetation conservation notice is given because I suspect on the following grounds that unlawful clearing has taken place and is likely to take place on the land:

- a) Clearing was observed on 28 November 2007 and 17 June 2008 on the land, on which there is a Conservation Covenant issued under Section 33b of the *Soil and Land Conservation Act 1945*.
- b) The clearing is not in accordance with section 51C of the *Environmental Protection Act 1986*.

Requirements of this vegetation conservation notice:

In accordance with *Section 70(3)(c)* of the *Environmental Protection Act 1986*, the person to whom this vegetation conservation notice is given and each owner and occupier of the land who is bound by this vegetation conservation notice is required to ensure that no unlawful clearing, or no further unlawful clearing, takes place on the land.

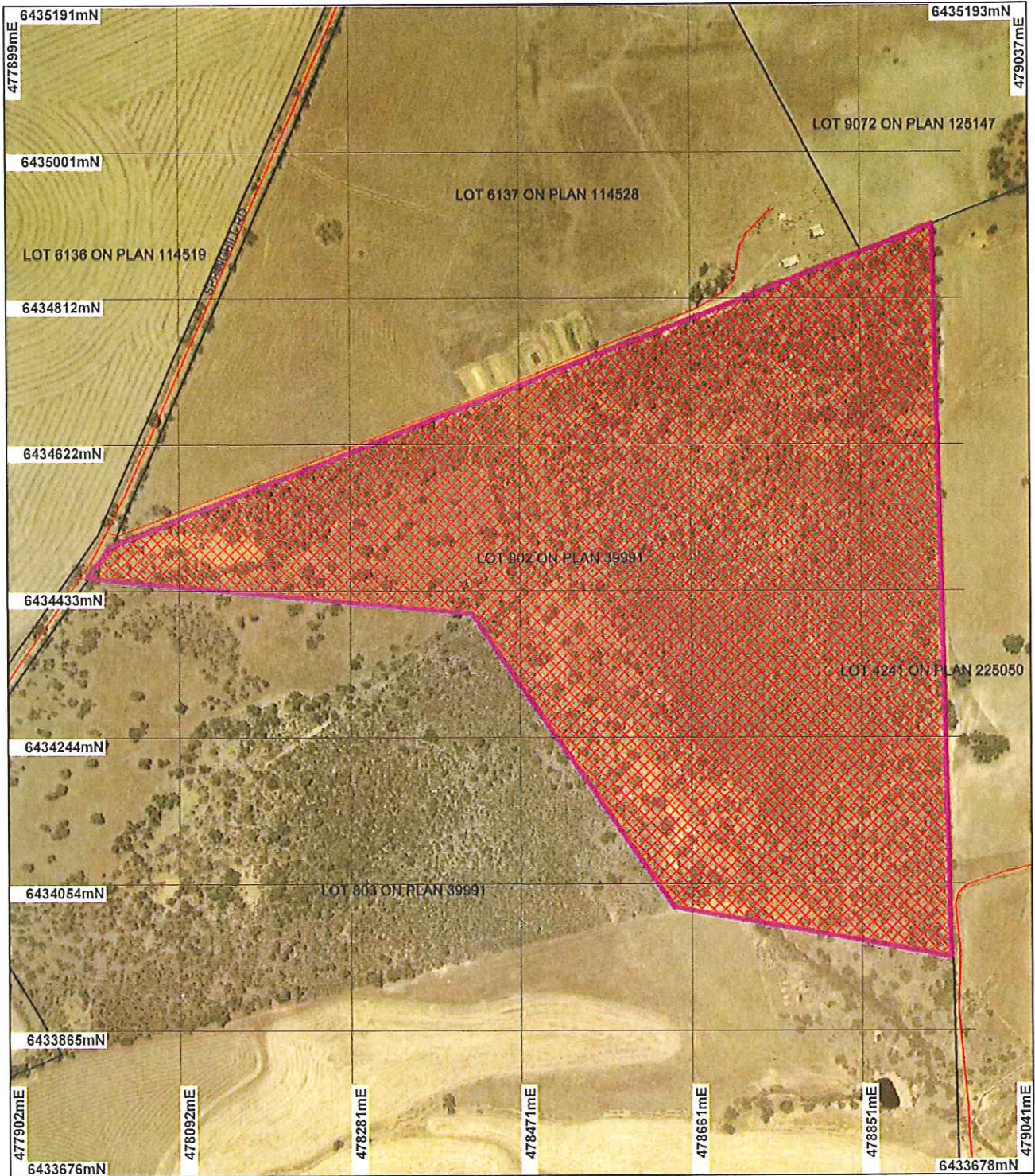

Under *Section 103* of the *Environmental Protection Act 1986*:






- A person who is aggrieved by a requirement contained in this vegetation conservation notice may within 21 days of being given this notice lodge with the Minister for the Environment an appeal in writing setting out the grounds of that appeal.
- Any other person who disagrees with a requirement contained in this vegetation conservation notice may within 21 days of the making of that requirement lodge with the Minister for the Environment an appeal in writing setting out the grounds of that appeal.

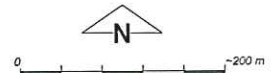
