VEGETATION CONSERVATION NOTICE

Person to whom this vegetation conservation notice is given:

(being the owner and occupier of the land described below)

Ivycross Pty Ltd

Land to which this vegetation conservation notice relates ("the land"):

Lot 6722 on plan 226868 as comprised on Certificate of Title Volume 1947 Folio 776

Lot 10478 on plan 401340 as comprised on Certificate of Title Volume 2895 Folio 899

Reasons for which this vegetation conservation notice is given:

This vegetation conservation notice is given because I suspect on the following grounds that unlawful clearing has taken place and is likely to take place on the land:

- Aerial imagery from 2001 and March 2012 shows the land contained native vegetation
- Satellite imagery from 1 July 2016 shows the land contained native vegetation
- Satellite imagery from 10 August 2016 shows native vegetation has been cleared on the land
- No clearing permit had been granted for the clearing.
- The clearing was not for an exempt purpose
- The clearing is unauthorised clearing under section 51C of the Environmental Protection Act 1986

Requirements of this Notice:

The person to whom this vegetation conservation notice is given, and each subsequent owner and or occupier of the land who is bound by this vegetation conservation notice, are required to undertake the following specified measures:

1. No unlawful clearing

Ensure that no clearing takes place on the land unless it is authorised by a clearing permit or is exempt from the requirement for a clearing permit by the provisions of Schedule 6 of the *Environmental Protection Act 1986* or by regulation 5 of the *Environmental Protection (Clearing of Native Vegetation) Regulations 2004*.

2. Cultivation prohibited

Ensure that for a period of ten years from the giving of this notice, no cultivation, including scraping, raking, ploughing or mechanical movement of soil, is carried out within the *specified areas* other than for the purpose of complying with a written firebreak notice.

DEFINITIONS

The following meanings are given to terms used in this Notice:

specified areas means the portions of Lot 6722 on deposited plan 226868 and Lot 10478 on deposited plan 401340 bounded by a line joining the Zone 50 GDA 94 points set out in the tables below consecutively then directly to the point of commencement:
