VEGETATION CONSERVATION NOTICE

CPS 7470/1

Persons to whom this vegetation conservation notice is given:

Roger William Graham of 1076 Lakes Road Nambeelup WA 6207 (being the occupier of the land described below); and

Valmai Evelyn Graham of Unit 1, 22 Spinnaker Quays Mandurah WA 6210 (being the owner of the land described below).

Land to which this vegetation conservation notice relates ("the land"):

Lot 2 on Diagram 57736 as comprised on Certificate of Title Volume 2156 Folio 48

Reasons for which this vegetation conservation notice is given:

This vegetation conservation notice is given because I suspect on the following grounds that unlawful clearing has taken place and is likely to take place on the land:

- Aerial photography between February 2016 and February 2017 shows native vegetation has been cleared on the land;
- A site inspection of the land by Department of Environment Regulation inspectors on 14 February 2017 confirmed that clearing had been carried out;
- No clearing permit had been granted for the clearing;
- The clearing was not for an exempt purpose; and
- The clearing is unauthorised clearing under section 51C of the Environmental Protection Act 1986.

Requirements of this Notice:

The persons to whom this vegetation conservation notice is given, and each subsequent owner and or occupier of the land who is bound by this vegetation conservation notice, are required to undertake the following specified measures:

1. No unlawful clearing

Ensure that no further unlawful clearing takes place on the land.

2. Cultivation prohibited

For a period of ten years from the giving of this notice, ensure no cultivation, including harvesting, mowing, scraping, raking, ploughing or mechanical movement of soil, is carried out within the *specified* area other than purposes required under this vegetation conservation notice or for the purpose of complying with a written firebreak notice.

3. Exclusion of stock

For a period of ten years from the giving of this notice, ensure that *livestock* are excluded from the *specified area* and not cause or permit *livestock* to enter or remain within the *specified area*.

DEFINITIONS

The following meanings are given to terms used in this Notice:

livestock means any animal kept for domestic or commercial purposes and includes any horse, donkey, mule, cattle, sheep, swine, goat, buffalo, deer, camel or alpaca.

specified area means the portions of Lot 2 on Diagram 57736 bounded by a line joining the Zone 50 GDA 94 points set out in the tables below consecutively then directly to the point of commencement:

- any other person who disagrees with a requirement contained in this vegetation conservation notice
 may within 21 days of the making of that requirement lodge with the Minister for Environment an
 appeal in writing setting out the grounds of that appeal.

PENDING THE DETERMINATION OF AN APPEAL REFERRED TO ABOVE, THE RELEVANT REQUIREMENTS CONTAINED IN THIS VEGETATION CONSERVATION NOTICE CONTINUE TO HAVE EFFECT.
