Scope and status

Nicole Leggett, Executive Director, Office for Prevention of Family and Domestic Violence

The family and domestic violence commissioning plan will set out:

- evidence based, fit for community purpose, service models;
- the composition of an 'ideal state' service system;
- a clear hierarchy of outcomes and measures of success;
- priorities for future investment;
- strategies to increase the number and type of services delivered by Aboriginal organisations for Aboriginal people (aligned to the Aboriginal Family Safety Strategy); and
- a strategic asset management plan.





The **scope** is inclusive of all family and domestic violence services funded by the Department of Communities. This includes:

- Crisis accommodation including refuges and safe houses
- Outreach including Safe at Home
- Counselling, advocacy and support services
- Coordinated Response Services (and the whole FDVRT model)
- Hubs
- Perpetrator responses including Breathing Space and men's behaviour change programs

It will also consider alignment with other key funded services including CSATS, EIFSS, AIHSS and homelessness services.







Immediate priority is financial analysis of the contemporary cost of operation for women's refuges and safe houses. This will inform a business case for consideration by Government in the 2023-24 budget process. The objective of this work is to provide sustainability of services over the life of the current contracts (to 2025 + 1 + 1).





Scope and status

Key inputs to this work include:

- clear mapping of current state by region (services and providers, investment, contract arrangements, client usage, asset condition);
- analysis of demand and unmet need;
- collation of existing sector consultation concerning outcomes, service models, measures of success and client pathways including journey maps;
- jurisdictional scan of service models and service system composition;
- guidance from the expert reference group;
- consultation with the sector and other key stakeholders; and
- input from survivors.



Expert Reference Group

First meeting on Monday 27 June, 1.30-2.30pm

The Expert Reference Group will provide ongoing advice about development of the strategic commissioning plan including the more immediate analysis of service cost for refuges and safe houses. It is their role assist with the analysis of data and information, test assumptions and consider options or opportunities for improvement.
