
Aboriginal Community Controlled Organisation (ACCO) Strategy 2022 to 2032

A Call to Action – Implementation Plan One

The ACCO Strategy 2022-2032 (Strategy) has been developed by the Department of Communities (Communities) in partnership with representatives from the ACCO Sector across Western Australia to improve the way Communities commission services for the Aboriginal community. Over the next ten years, Communities will empower Aboriginal children, families and communities to choose their own futures from secure and sustained foundations provided by ACCOs. In acknowledging the need for systemic change across Communities, the Strategy is fundamental to the reform process.





Aboriginal children, families and communities are empowered to choose their own futures from secure and sustained foundations provided by ACCOs.

Strategy Purpose

The Strategy provides a framework for how Communities will work together with and support Western Australian ACCOs to achieve self determination to create safe and healthy families and communities.

Strategy Pillars

Cultural Safety and Governance

Principle: That all services for Aboriginal children, families and communities are grounded in Aboriginal knowledge and culture.

Partnerships

Principle: Building genuine partnerships and engagement with ACCOs to deliver strong accountability and culturally responsive ways of working.

Economic Opportunities

Principle: ACCOs are given economic and socio-economic opportunities to deliver services to their community.

Strategy Objectives ----



Culturally informed decisionmaking by Communities that maximises ACCO involvement in delivering services to Aboriginal children, families and communities.



Communities' governance structures and systems are improved to achieve economic and socio-economic opportunities for ACCOs.



Communities' service delivery models are co-designed in partnership with ACCOs to provide locally informed, placebased and culturally appropriate services for Aboriginal children, families and communities.



Communities will procure ACCOs to deliver frontline services to Aboriginal children, families and communities.



The ACCO Strategy will be implemented across multiple stages to ensure Communities are continually evaluating the way we work, and are responsive to the needs of Aboriginal children, families, and communities. Communities will establish formal mechanisms for ongoing coordination and alignment of government priorities, capturing unique knowledge and experience in decision-making, and cultural ways through connection and reflection. The actions identified below are the priority focus for 2022 – 2024:
