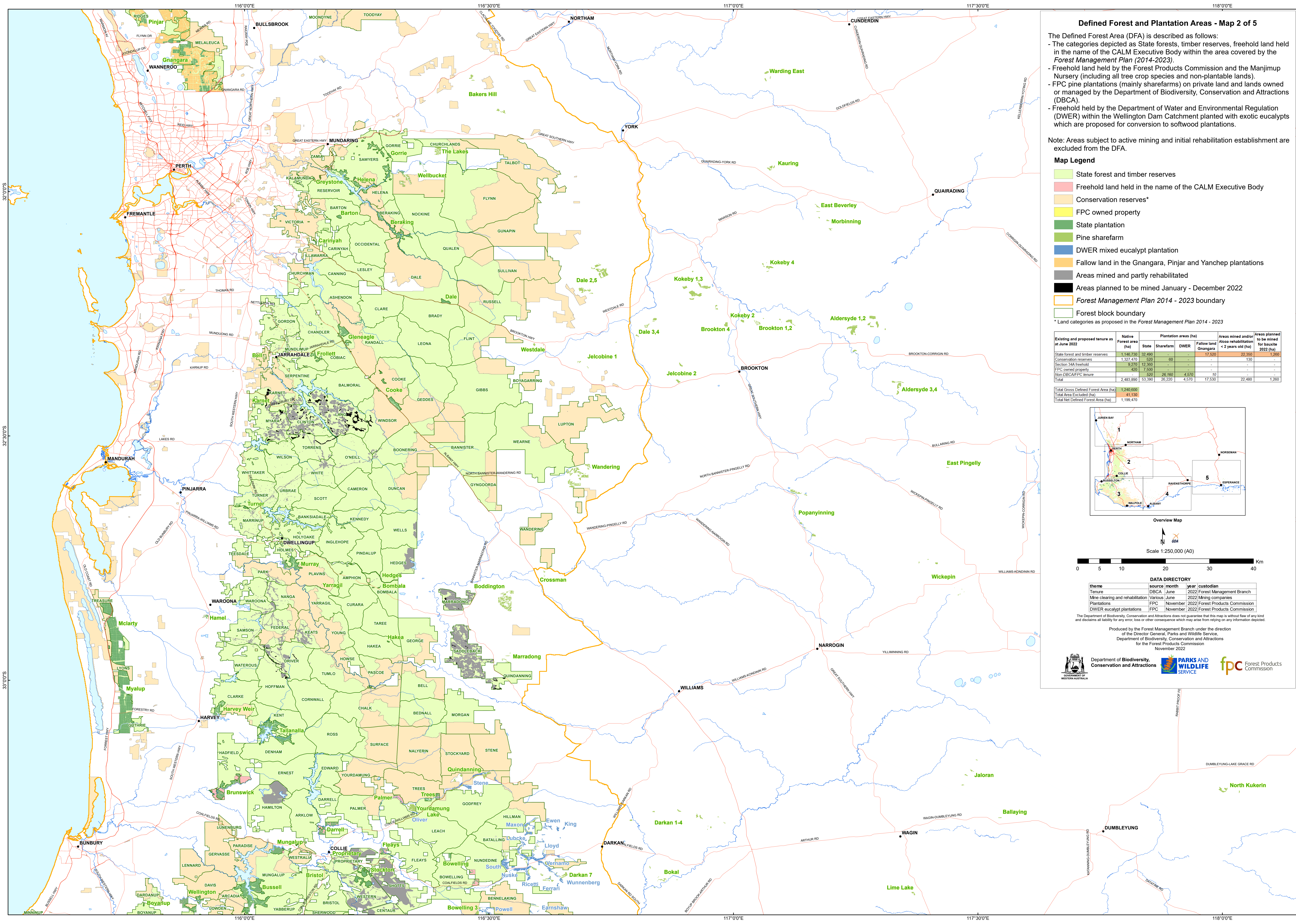




Defined Forest and Plantation Areas - Map 2 of 5

- The Defined Forest Area (DFA) is described as follows:
- The categories depicted as State forests, timber reserves, freehold land held in the name of the CALM Executive Body within the area covered by the *Forest Management Plan (2014-2023)*.
 - Freehold land held by the Forest Products Commission and the Manjimup Nursery (including all tree crop species and non-plantable lands).
 - FPC pine plantations (mainly sharefarms) on private land and lands owned or managed by the Department of Biodiversity, Conservation and Attractions (DBCA).
 - Freehold held by the Department of Water and Environmental Regulation (DWER) within the Wellington Dam Catchment planted with exotic eucalypts which are proposed for conversion to softwood plantations.

Note: Areas subject to active mining and initial rehabilitation establishment are excluded from the DFA.

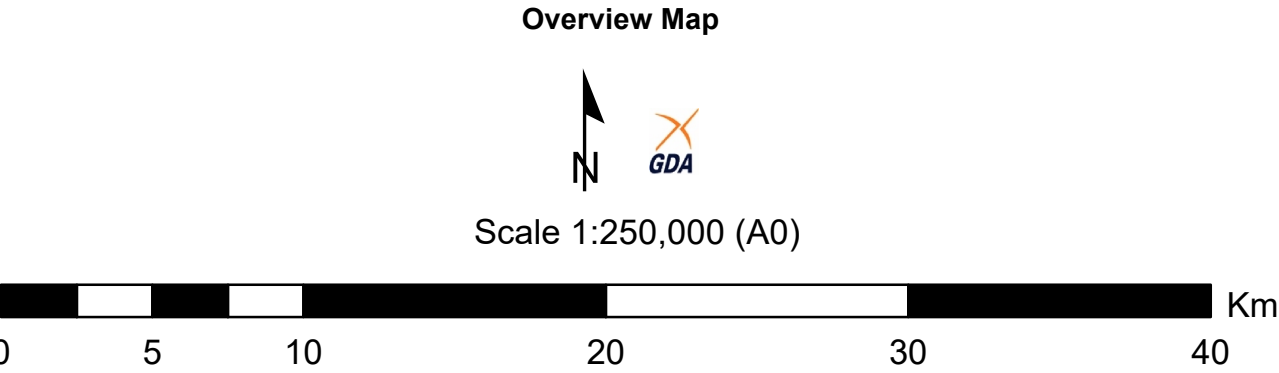
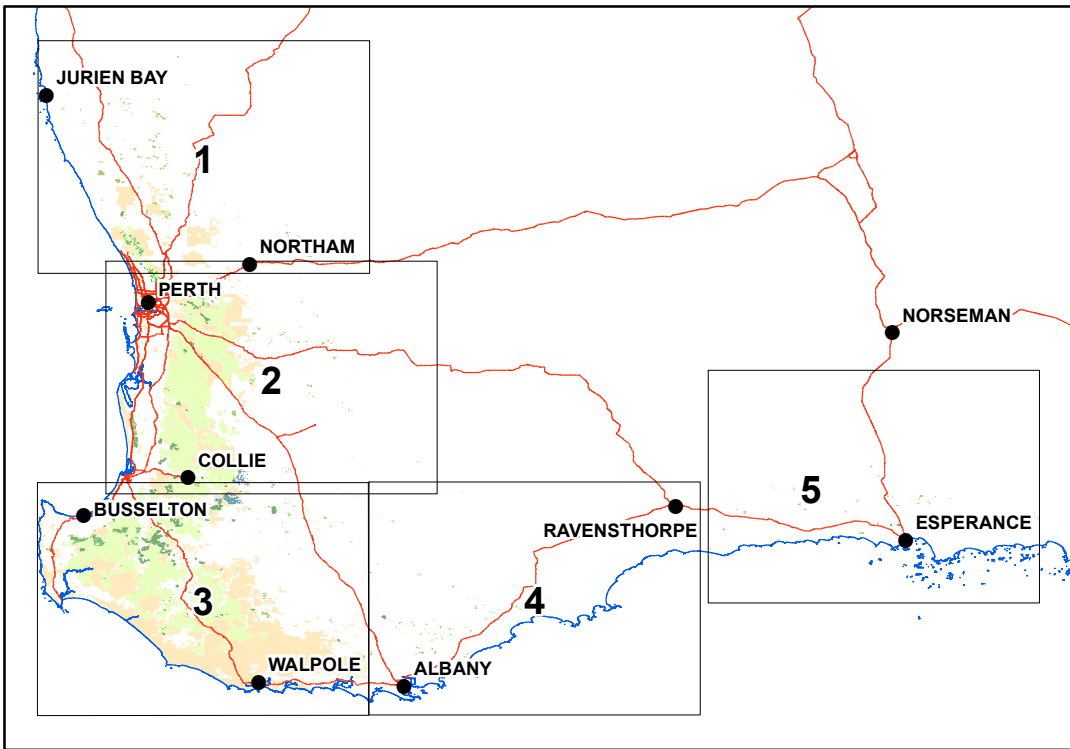
