VEGETATION CONSERVATION NOTICE

CPS 9794/1

Persons to whom this vegetation conservation notice is given:

(being the owner of the land described below)

Blue Whale Farm Plantation Pty Ltd 122 Main Street, Osborne Park WA 6017

Land to which this vegetation conservation notice relates ("the land"):

Lot 449 on Deposited Plan 231012 Milyeanup Coast Road Scott River

Reasons for which this vegetation conservation notice is given:

This vegetation conservation notice is given because I suspect on the following grounds that unlawful clearing has taken place on the land:

- (a) Examination of satellite imagery has shown the land contained native vegetation prior to February 2022;
- (b) A site inspection of the land by Department of Water and Environmental Regulation Inspectors on 20 June 2022 and 15 August 2022 determined that native vegetation had been cleared;
- (c) I suspect on reasonable grounds that the clearing was not authorised by a clearing permit, notice or by exemption under the *Environmental Protection Act 1986* or the *Environmental Protection* (Clearing of Native Vegetation) Regulations 2004; and
- (d) I suspect on reasonable grounds that unlawful clearing of native vegetation, constituting a contravention of section 51C of the *Environmental Protection Act 1986*, has taken place.

Requirements of this Notice:

The persons to whom this vegetation conservation notice is given is required to undertake the following specified measures, for a period of ten years from the date this notice is given to re-establish and maintain vegetation on the area affected by the clearing to a condition as near as possible to the condition of the vegetation before the clearing occurred:

1. No unlawful clearing

Ensure that no unlawful clearing, or further unlawful clearing, takes place on the land.

2. Gravel extraction prohibited

Ensure that no further gravel or lime extraction takes place within the *specified area*.

3. Weed control

- (a) Engage an *environmental specialist* to inspect the *specified area* at least once each year and identify all *weed* species present; and
- (b) Selectively remove or kill *weed* species within the *specified area* so that the average vegetation cover that is *weed* species is not greater than the percentage of total vegetation cover that is weed species within a control *quadrat* established under measure (5).

4. Rehabilitation

Prior to 1 June 2023:

- (a) shape the surface of the specified area so that it is consistent with the surrounding five metres of uncleared land; and
- (b) spread the piles of existing cleared material and topsoil retained from previous clearing over the surface of the specified area.

5. Establish control quadrat

Prior to 1 September 2023 establish the following control *quadrats* by installing a permanent steel post at the following *coordinates* to establish the south western corner of the *quadrat*:

6. Establish monitoring quadrats

Prior to 1 September 2023 establish the following monitoring *quadrats* by installing a permanent steel post at the following *coordinates* to establish the south western corner of each *quadrat*:

7. Monitor vegetation within quadrats

Engage an *environmental specialist* to conduct the following monitoring work at each *quadrat* in September of each and every year:

- (a) measure the species composition, structure, density and *vegetation condition* of the vegetation within each *quadrat*; and
- (b) take one photograph of the vegetation growing within the *quadrat*, from the south west corner of the *quadrat*.

8. Revegetation

In each year after 2023, where the species composition, structure, density and *vegetation condition* of a monitoring *quadrat* established under measure (6) is less than the species composition, structure, density and *vegetation condition* of the nearest control *quadrat* established under measure (5), engage an *environmental specialist* to undertake the following revegetation work within the *specified area*:

- (a) deliberately plant and/or seed native vegetation that is indigenous to the land; and
- (b) ensure that only local provenance seeds and propagation material originating from the land is used.

9. Records must be kept

The following records shall be maintained for activities done pursuant to this vegetation conservation notice:

- (a) in relation to *weed* control pursuant to measure (3):
 - (i) the date of the *weed* control activities; and
 - (ii) a description of all weed control activities undertaken.
- (b) in relation to monitoring pursuant to measure (7):
 - (i) the date of monitoring activities;
 - (ii) a description of all monitoring activities undertaken;
 - (iii) the species composition, structure, density and vegetation condition;
 - (iv) the photographs taken of each quadrant; and
 - (v) the percentage of total vegetation cover that is weed species.
- (c) in relation to *revegetation* pursuant to measure (8):
 - (i) the commencement date of revegetation;
 - (i) the size of the area revegetated in hectares;
 - (ii) the list of all local provenance seed species, quantity and propagation material used; and
 - (iii) a description of all revegetation activities undertaken.

10. Annual reporting

Records required under measure (9) shall be submitted to the CEO by 30 June of each year reporting on activities done under this vegetation conservation notice between 1 January and 31 December of the preceding year.

DEFINITIONS

The following meanings are given to terms used in this Notice:

CEO has the same meaning as it has in section in section 3(1) of the Environmental Protection Act 1986.

coordinate means a Map Grid of Australia 2020 (MGA2020) coordinate for Zone 50

environmental specialist means a person who holds a tertiary qualification in environmental science or equivalent, and has experience in the assessment of Western Australian native vegetation.

Keighery scale means the vegetation condition scale described in Bushland Plant Survey: A Guide to Plant Community Survey for the Community (1994) as developed by B.J. Keighery and published by the Wildflower Society of WA (Inc). Nedlands, Western Australia.

quadrat means a 10m x 10m plot established for the purpose of monitoring native vegetation species composition, structure, density and vegetation condition;

revegetate, revegetated and **revegetation** means the re-establishment of native vegetation to achieve a species composition, structure, density and *vegetation condition* of native vegetation similar to pre clearing species composition, structure, density and *vegetation condition*

specified area means the portion of the land consisting of the following revegetation areas bounded by a line joining the *coordinates* set out consecutively in the tables below:

Weed means any plant:

- (a) that is a declared pest under section 22 of the Biosecurity and Agriculture Management Act 2007; or
- (b) published in a Department of Biodiversity, Conservation and Attractions species-led ecological impact and invasiveness ranking summary, regardless of ranking; or
- (c) not indigenous to the area concerned.



- a person who is aggrieved by a requirement contained in this vegetation conservation notice may within 21 days of being given this notice lodge with the Minister for Environment an appeal in writing setting out the grounds of that appeal; and
- any other person who disagrees with a requirement contained in this vegetation conservation notice may within 21 days of the making of that requirement lodge with the Minister for Environment an appeal in writing setting out the grounds of that appeal.


