Request to engage or register an existing educator with a swimming pool or outdoor spa

Regulation 373C of the Education and Care Services National Regulations 2012 (WA) restricts approved providers of a family day care (FDC) service from engaging or registering new educators with a swimming pool or outdoor spa. However, the Regulatory Authority may give written approval to an approved provider of a FDC service to engage or register an existing educator in exceptional circumstances.

The Regulatory Authority may consider exceptional circumstances to be present if the approved provider of an existing educator with a swimming pool or outdoor spa:

- has their provider or service approval cancelled or suspended; or
- voluntarily suspends or surrenders their provider or service approval; or
- transfers/sells their service to another provider.

Receiving approved providers wishing to engage or register an existing educator in exceptional circumstances are required to seek written approval before doing so. Please complete the form on the last page and submit via email to ecru@communities.wa.gov.au. For the request to be considered complete, a copy of the risk assessment conducted by the receiving provider for the residence or venue must also be submitted.

Each request received by the Regulatory Authority will be assessed. The approved provider will be advised of the outcome as soon as practicable and no later than 28 days from the receipt of the request. A shorter timeframe may be considered in extenuating circumstances.

Information for approved providers with registered educators with a pool or outdoor spa

As an approved provider with registered educators with a pool or outdoor spa, please ensure you are aware of all the additional regulatory requirements that apply to you. This includes monthly inspections of each family day care educators' residence/venue who have swimming pools, spas or water features every month. There are also record keeping and reporting requirements that you should familiarise yourself with including requirements for:

- the approved provider and educators to keep copies of inspection reports and
- reporting any safety issues identified at family day care residences or venues to ECRU.

Training is available to help approved providers understand how to inspect family day care residences/venues with swimming pools, spas or water features The training can be accessed on the Royal Life Saving Society of WA (RLSS WA) course site. The course has been developed by RLSS WA on behalf of the Department of Communities. This course is not publicly available and can only be accessed through the above link. Users will need to register with an email address to undertake the course. It should take up to 45 minutes to complete and can be taken any time. There are some useful resources included with the training. Training is not compulsory but is being provided as part of the Government's commitment to support Approved Providers.

From 1 March 2023, family day care residences with pools or spas are also required to have a safety device installed to alert or deter a child from entering the pool, spa or its surrounds such as a pool alarm or a pool cover. Appropriate types of devices may include:

- gate alarms that alert an educator when a gate is left open
- pool alarms that alert when someone has entered the pool
- personal alarms designed to alert when a child enters a pool
- pool covers that are fixed in such a way that a child may not lift them to gain entry and can support the weight of anyone falling onto them.

Other types of devices that meet the criteria of alert or deter will also be considered. You will be expected to record these and ensure they are operating as part of your monthly inspections.
