Introduction

Each year the State Records Office of WA (**SRO**) publishes an online Guide to State Cabinet records which have been released from their 30-year restriction access period in the previous calendar year. This year's Guide introduces the records of Cabinet minutes and decisions from 1991.

State Cabinet records are historically significant documents which reveal the decisions made by the government of the day. These unique records are the primary source documents for information about the issues raised at Cabinet meetings. This online Guide is intended to assist the Western Australian community with access to these records.

This Guide also provides an overview of Western Australian state issues in 1991, as well as highlighting a few of the more prominent national and international news events of that year for context. A list of the topics and subjects discussed at each meeting of State Cabinet in 1991 is provided in this Guide to assist with further research into the records. This list includes a link to the SRO's online catalogue to enable the public to view relevant State Cabinet records online.

Unlike the release of Cabinet papers at the Commonwealth level, where records comprising more sensitive information can be embargoed beyond the restriction access period for the remaining records, all State Cabinet records for Western Australia are released for public access 30 years after the records are created.

This year (2022) the Guide to the 1991 State Cabinet Records has been produced with the assistance of Mr Benjamin Davis, a student from the University of Western Australia during a McCusker Centre for Citizenship internship at the SRO. During his placement he researched the 1991 State Cabinet Minutes and Decisions and an Index to these records, compiling a detailed list of Cabinet meeting subjects (see pp.11 - 39), as well as drafting sections on world, national and local events.

Description of the 1991 State Cabinet Records

The primary set of State Cabinet records referred to in this Guide is called 'Cabinet Minutes and Decisions.' State Cabinet Minutes and Decisions include agendas and submissions to Cabinet and are listed chronologically. They record the meetings of State Cabinet held between 07 January and 23 December 1991 inclusive, and are described on SRO's catalogue as [State Cabinet Minutes and Decisions \(Series 1228, Consignment 4736\)](#).

Other State Cabinet records which complement the Minutes and Decisions, include [Cabinet Meeting Summaries for 1991 \(Series 1230, Consignment 4823, items S09 and S10\)](#), and submissions, reports and other accompanying documents to the Minutes and Decisions, each of which is described as a ["Cabinet Record" \(Series 1228, Consignment 6150\)](#).

Cabinet Minutes and Decisions

State Cabinet Minutes and Decisions are the primary original source documents that describe decisions made at Cabinet meetings. These documents contain the names of the Ministers present and absent at each meeting, supporting reports, copies, summaries or reviews of submissions, and a record of ministerial recommendations, including decisions, approvals, deferrals by State Cabinet.

World Events that Made the News in 1991⁽¹⁾

1991 was a year of significant worldwide political, social, technological, cultural, and economic change. The year saw significant developments in the closing chapter of the Cold War. In the wake of the dissolution of the Soviet Union, several sovereign republics emerged. Through improved diplomatic relations between the United States and the Soviet Union, President George Bush and Soviet President Mikhail Gorbachev committed their respective nations to effectively ending the Cold War. Through the START I Treaty, signed in July, each nation promised to reduce the number of its nuclear warheads.

Following the invasion of Kuwait by Iraq the previous year, January 1991 saw the commencement of the Gulf War through the implementation of the UN-authorized Operation called 'Desert Storm'. An armed campaign conducted by a United States-led coalition of nations, the Gulf War was highly televised. On 28 February, U.S. President Bush declared a ceasefire, also declaring that Kuwait had been liberated.

In Africa, Eritrea gained its independence from Soviet supported Ethiopia after waging a long and destructive war. The Parliament of South Africa repealed the Population Registration Act 1950, a key component of *Apartheid*.

In 1991 the World Wide Web debuted as a publicly available service on the Internet. Originally developed by Tim Berners-Lee to fulfill the need of information sharing between scientists across the world, the creation of the World Wide Web is viewed by many as a watershed moment in the continual growth of globalisation and the erosion of borders between nations. In addition, HP released the very first colour image scanner – the ScanJet IIC.

In popular culture, 1991 was a year of seminal movies, television shows, and albums. The release of Nirvana's second studio album *Nevermind* saw a rise in popularity of grunge and alternative rock music. Along with increasing popularity of hip-hop music, this change paved the way for a generation of future artists to explore music outside the status quo. Jonathan Demme's psychological thriller *The Silence of the Lambs* captured a global audience with its combination of acting, storyline, cinematography, and soundtrack. Still regarded today by many as one of the most influential films of all time, it won Five Academy Awards.

Significant sporting events in the year included South Africa's readmittance into the International Cricket Council following the abolition of *Apartheid*; Australia's first triumph of the Rugby World Cup; and Mike Tyson's controversial victory over Donovan 'Razor' Ruddock. International soccer legend Diego Maradona tested positive for cocaine use and was consequently suspended from playing for 15 months.

The result of the 1990 Federal election left the Hawke Labor Government with a narrow majority in Parliament in 1991. In his New Year address, Prime Minister Bob Hawke warned the Australian people of tough financial times ahead. In January, the Australian Bureau of Statistics recorded an unemployment rate of 8.7%, which rose to 9.9% by April. Interest rates were also very high. In a leadership challenge on 19 December 1991, then Treasurer, Paul Keating, defeated Bob Hawke with 56 – 51 votes, and became Australia's 24th Prime Minister.

In March, the Federal government proposed legislation to prohibit all political commercials on television and radio. For some, the proposed legislation was perceived as a direct threat to the inherent right to freedom of expression and potentially disadvantaging smaller political parties with less access to the media than the major parties. In November, Federal Opposition Leader Dr. John Hewson introduced the *Fightback!* policy document, including measures such as the introduction of a Goods and Services Tax, and limits on unemployment benefits.

Outside of politics, Queensland was ravaged in January by the severe Tropical Cyclone Joy, which killed six people and caused over \$300 million in property damage. In February, the bulk carrier *Sanko Harvest* sunk off the coast near Esperance, leaking 700 tonnes of oil and 30,000 tonnes of fertiliser into the waters surrounding the Recherche Archipelago, and in April the bulk carrier MVMV *Mineral Diamond* disappeared during a cyclone off the coast of Western Australia. Archbishop Peter Hollingworth AO OBE was awarded Australian of the Year in 1991 for dedication to social justice and a more inclusive welfare agenda. In music, Bryan Adams' (*Everything I Do*) *I Do It For You* was the hit single of the year, spending 11 weeks at the top of the ARIA Singles Chart.

In sport, Australia won their first Rugby World Cup by beating arch-rivals England at Twickenham. The 1990-91 Ashes Test Series took place in Australia. Hawthorn defeated the West Coast Eagles 139 – 86 in the Australian Football League Premiership.

Events and Issues in WA Politics in 1991⁽³⁾

The Royal Commission into Commercial Activities of Government and Other Matters ('WA Inc') dominated Government activities during 1991. Throughout the year, Premier Carmen Lawrence's Government came under increasing public scrutiny due to the investigations and deliberations of the Royal Commission, which became one of the State's longest and most expensive inquiries to-date.

During 1991, State Cabinet introduced a number of pieces of legislation, including an Act to appoint an independent Director of Public Prosecutions; the East Perth Redevelopment Act; an Act to make provision for and regulate Human Reproductive Technology. An Act to make the wearing of bicycle helmets compulsory was also introduced into the Legislative Assembly in April, which would become legally enforceable on 1 January 1992. A Rebate Scheme accompanied this new compulsory law, whereby individuals with a Health Care card were entitled to a \$10 rebate if they purchased a helmet for their child through a school-based scheme.
