Introduction

Each year the State Records Office of WA (SRO) publishes an online Guide to State Cabinet records which have been released from their 30-year restriction access period in the previous calendar year. This year's Guide comprises information from Cabinet minutes and decisions from 1989.

State Cabinet records are historically significant documents which reveal the decisions made by the government of the day. These unique records are the primary source documents for information about the issues raised at Cabinet meetings. This online Guide is intended to assist the Western Australian community with access to these records.

This online Guide also provides an overview of Western Australian state issues in 1989, as well as highlighting a few of the more prominent national and international news events of that year for context. A list of the topics and subjects discussed at each meeting of State Cabinet in 1989 is provided in this Guide to encourage further research into the records. This list includes a link to the State archives online catalogue to enable online requests to order, view and digitise relevant records – see https://archive.sro.wa.gov.au/

Unlike the release of Cabinet papers at the Commonwealth level, where records comprising more sensitive information can be embargoed beyond the restriction access period for the remaining records, all of the State Cabinet records for Western Australia are released for public access 30 years after the records are created.

N.B. This year (2020) the Guide to the 1989 State Cabinet Records has been produced with the assistance of Ms Michelle Lam, a student from the University of Western Australia through a McCusker Centre for Citizenship internship at the SRO. Ms Lam researched the 1989 State Cabinet Minutes and Decisions, and an Index to these records, compiling and drafting the list of Cabinet meeting subjects (see pp.11 - 36) during her placement at the SRO.

Description of the 1989 State Cabinet Records

The primary set of State Cabinet records referred to in this Guide is called 'Cabinet Minutes and Decisions.' State Cabinet Minutes and Decisions include agendas and submissions to Cabinet and are listed chronologically. They record the meetings of State Cabinet held between 03 January and 18 December 1989 inclusive, and are described in the State archives online catalogue as <u>State Cabinet Minutes and</u> <u>Decisions (Series 1228, Consignment 4736)</u>.

Other State Cabinet records which complement the Minutes and Decisions, include <u>Cabinet Meeting Summaries for 1989 (Series 1228, Consignment 48236, items S07</u> and S08), and submissions, reports and other accompanying documents to the Minutes and Decisions, each of which is described as a <u>"Cabinet Record (Series 1228, Consignment 6150</u>.

Cabinet Minutes and Decisions

State Cabinet Minutes and Decisions are the primary original source documents that reveal government decisions made at Cabinet meetings. These documents contain the names of the Ministers present and absent at each meeting, supporting reports, copies, summaries or reviews of submissions, and a record of ministerial recommendations, and relevant decisions, approvals, deferrals and rejections by State Cabinet.

World Events that Made the News in 1989(1)

1989 opened with the death of Japan's emperor Hirohito, the departure of President Ronald Reagan from the White House, and the arrival of his replacement George W. Bush. Other notable regime changes in 1989 included the election of F. W. de Klerk as South Africa's National Party leader and his eventual term as president of South Africa. His election would initiate a series of reforms that would lead to the dismantling of apartheid and the release of Nelson Mandela.

Foreshadowed by Mikhail Gorbachev's appointment in 1988, George H. W. Bush and Gorbachev declared the Cold War between the US and the Soviet Union over on 3 December, putting an end to over 40 years of geopolitical tension between the two powers. Accompanying this was the demolition of the Berlin wall on 10 November, beginning the process of reunifying Germany after its split in the aftermath of World War II. These two events are considered to have heralded the fall of communism in Eastern and Central Europe. In this same year, Francis Fukuyama published his famous essay "The End of History?", where he declared democracy as the "final form of human government," a nod to the decline of Communism and the ascendancy of democracy as the only legitimate governance system.

Elsewhere in the world, enormous upheavals took place. February saw an end to the Soviet occupation of Afghanistan, with the last troops leaving Kabul on 15 February. April saw the beginning of the Tiananmen Square protests, where thousands of university students protested against the Communist government of China, demanding greater democracy. The first mass demonstration against the Communist regime in East Germany also took place on 7 October.

In 1989 the launch of the World Wide Web in the public domain by CERN scientist Tim Berners-Lee marked a change in the way the world would work forever.

Australian Events that Made the News in 1989(1)

The Hawke government continued to govern the country in 1989 and faced a number of key issues during that year, including rising inflation and a escalating national debt. As Australia's net national debt reached \$100 billion in August and interest rates rose to 17%, the Hawke government reduced spending, including State grants and loans.

1989 saw the introduction of HECS (Higher Education Contribution Scheme), a system under which the government would cover the balance of a student's tertiary education, and the student could gradually repay that debt through the tax system. This also accompanied the gradual reintroduction of university fees, after the Whitlam government abolished them in 1974.

The pilot's dispute, considered one of the most costly industrial actions to have ever taken place in Australia, was organised by the Australian Federation of Air Pilots in order to achieve a 30% wage increase. As pilots were held to the same wage fixing laws as other occupations, pilots claimed that they should have the same working conditions and chose to fly only during normal working hours of 9 am - 5 pm. This resulted in Prime Minister Hawke declaring a state of national emergency and allowing Royal Australian Air Force Pilots and overseas pilots to provide services. On the 23 August, all of Australia's 1,645 domestic pilots resigned from their roles to avoid civil litigation, and as services returned to normal, the dispute was never officially resolved.

In the Arts, Peter Carey's novel *Oscar and Lucinda* won the Miles Franklin award, an award given to literature that depicts Australian life. 1989 also saw the release of *The Delinquents*, starring Kylie Minogue and Charlie Schlatter, that was filmed in Queensland. *Dead Calm*, a psychological thriller horror based on a novel of the same name, was also released, and is considered by New York Times to be one of the top 1,000 ever made.

In sports, 1989 saw Australia regain the Ashes in England for the first time in 40 years. In what was considered a very one-sided series (4-0), this triumph over England led to Australia retaining the Ashes until 2005. The Victorian Football League also changed its name to the Australian Football League in 1989.

Events and Issues in WA in 1989(2)

The Burt Commission on Accountability reported in January 22, finding that the government had operated well beyond ministerial discretion and outside the realm of the scope of its power. This led to not only the dismantling of the corporations which formed WA Inc., but also charges being laid against Kevin Edwards and Tony Lloyd, two former government advisors, and against John Hilton, the former Rothwells bank director.

1989 also saw Alan Bond's Bond Corporation go into receivership with a debt of \$12 billion, the largest debt in Australian history. The collapse of the petrochemical project, and the subsequent loss of the government's \$175 million stake in it contributed to concerns about why the government engaged in such risky ventures.

Western Australians went to the polls in February 1989, choosing between the incumbent Peter Dowding Labor government and the Barry MacKinnon led Liberal opposition. In the wake of WA Inc, and the resignation of former Premier Brian Burke, media coverage at the time indicates that many assumed there would be a change of government. However, despite a 6.5% two party preferred swing against Peter Dowding's government, the Labor party retained power.

Protests against the redevelopment of the Old Swan Brewery near Kings Park also escalated in 1989. A group of Aboriginal people occupied the site in January as they feared that any construction work would disturb the Wagyl, the Noongar manifestation of the Rainbow Serpent. Despite boycotts from trade unions, the government started work on the site in June. However, in November the Supreme Court of WA granted an injunction which meant that no work could commence until a case relating to the site's significance was heard by the High Court of Australia.

There was significant activity in Tertiary education in WA in 1989 with discussions surrounding a merger between the University of Western Australia and Murdoch University occurring throughout the year, though legislation failed in the Legislative Council in December. The first private university in WA, the University of Notre Dame Australia, was announced in July, with the first student intake planned for 1992. 1989 also saw the passage of a bill decriminalising homosexual acts between consenting adults in WA.
