

Non-Indigenous Plant Species Diversification Permit Application Where can I find help?

Department of Planning, Lands and Heritage

The Department can help you with requirements for completing your application, the application process and advising the outcome of your application. The Department will initially review your application and direct it to the appropriate Land Management team which will assess your application and work with you during the application process. The Department will liaise with relevant State Government agencies, and the Pastoral Lands Board, regarding your application.

You should contact the Pastoral Lands Board if you require advice in relation to its policy on the Cultivation of Non-Indigenous Plant Species on a Pastoral Lease and associated templates, or have queries on pastoral purposes and the Pastoral Purposes Framework.
