Who can apply for a certificate							
Commemorative Birth certificates are available to the registered person (16 years of age or over) or a parent named in the birth certificate.  If you do not qualify under the Registry's Certificate Access Policy, you must provide the written consent or authority from a person entitled to the certificate and you must also provide identification for yourself and the person for whom you are acting.
