
Native Forest Transition

Industry and Community Development Programs Overview

The WA Government has committed to an \$80 million Native Forest Transition Plan, including a third pillar of \$30 million to support industry and communities.



The four Industry and Community Development Programs are outlined below:

Small Business Development and Diversification (SBDD)

- \$15 million over two funding rounds
- Round 1 closed 31 January 2023
- Round 2 opens 20 October 2023
- Round 2 closes 13 December 2023
- Grants of up to \$400,000

Targeted funding to help businesses with a demonstrated reliance on native forestry to remain open and diversify, expand or start a new business.

Community Small Grants Fund (CSGF)

- \$4 million over two funding rounds
- Round 1 closed 21 April 2023
- Round 2 opens 2024
- Grants of up to \$100,000

Funding to support sustainable projects that aim to stimulate the local economy, support tourism and events, and build liveable communities in the native forestry regions.

New Industry Development Grants (NIDG)

- \$10 million in one funding round
- Closed 4 September 2023
- Grants of up to \$2 million

Matched funding to support new/expanded industry in the native forestry regions, to future-proof regional economies.

Closure of Impacted Businesses (CIB)

- \$1 million in one funding round
- Opens 2024
- Grants of up to \$50,000

Funding for existing small businesses with a sole reliance on the native forestry industry that close.

- 1 Applicants that receive funding from BTP Program 1 can also apply for SBDD, but the maximum amount they would receive from SBDD would be the SBDD grant amount less the amount received from BTP Program 1.
- 2 Applicants cannot receive grants from both SBDD and NIDG
- 3 If an applicant has received a grant under the BTP, SBDD, CSGF or NIDG, they cannot also receive a grant for closing.
- 4 Businesses with a Forest Products Commission contract who are forced, or choose, to close may be eligible for payment under the BTP.
