# Metropolitan Region Scheme Standard Amendment 1413 Jarrahdale Parks and Recreation Precinct

#### **Amendment Report**

#### 1 Planning objective

The purpose of the proposed amendment is to transfer approximately 5.27 hectares of land in Jarrahdale from the Urban zone to the Parks and Recreation reservation in the Metropolitan Region Scheme (MRS), as shown on the **Amendment Figure - Proposal 1**.

#### 2 Background

The amendment land is located in the Shire of Serpentine Jarrahdale and is located to the south of the Jarrahdale townsite. The amendment land is adjoined by the Serpentine National Park on the south and west, Jarrahdale Primary School is immediately north of the amendment area, and the remaining surrounding land is generally established residential development.

The lots subject to this amendment were created in the late 1960's - early 1970's and have not been developed for residential purposes. These lots have not been provided with necessary infrastructure or constructed roads, and the amendment area is predominantly vegetated.

#### 3 Discussion

#### **PLANNING CONTEXT**

# Perth and Peel @3.5million / South Metropolitan and Peel Sub-Regional Planning Framework

The *Perth and Peel @3.5million* document provides strategic guidance to government agencies and local governments on land use, land supply, land development, environmental protection, infrastructure investment and the delivery of physical and community/social infrastructure for the Perth and Peel regions. It links the four Frameworks for each subregion and encourages the consideration of new urban growth opportunities.

The subject land is designated as "Urban" in the South Metropolitan peel Sub-regional Planning Framework. Notwithstanding this designation and the urban/residential zoning under the MRS and Local Planning Scheme (LPS) respectively, given the existing use and development constraints of the land, the land is recommended to be reserved for Parks and Recreation under the MRS. This is consistent with the key principles of the Frameworks which seek to avoid areas that are of high bush fire risk and avoiding and protecting environmental attributes.

#### State Planning Policy 3.7 - Planning in Bushfire Prone Areas

State Planning Policy 3.7 - Planning in Bushfire Prone Areas forms the foundation for landuse planning to address bushfire risk management in Western Australia. It is used to inform and guide decision-makers, referral authorities and proponents to achieve acceptable fire protection outcomes on planning proposals in bushfire-prone areas. The proposed amendment seeks to reserve the land as Parks and Recreation under the MRS and will not change the bushfire risk applicable to the land. The reservation to Parks and Recreation will ensure that no residential development is constructed on these lots which are highly vegetated and have a significant bushfire risk.

#### 4 Aboriginal cultural heritage

The process of rezoning or reservation of land in a region scheme is broad by nature and does not physically interfere with the land. Consideration of Aboriginal Cultural Heritage (ACH) is addressed more specifically at later stages of the planning process, typically when preparing a local structure plan or at the subdivision and development approval stages. All ACH is protected whether or not it has been previously recorded or reported.

Nevertheless, in recognising the importance of having reliable Aboriginal cultural heritage information, the WAPC and the Department of Planning, Lands and Heritage have entered into a Memorandum of Understanding with the South West Aboriginal Land and Sea Council (SWALSC) for the provision of Aboriginal consultative services. All amendment proposals likely to be of interest to Aboriginal persons are pre-referred to SWALSC for comment. SWALSC is the recognised Native Title Representative Body for Western Australia's southwest region and as such is well placed to provide advice on Aboriginal heritage. The amendment will be formally referred to SWALSC during the public submission period.

#### 5 Coordination of region and local scheme amendments

Under Section 126(3) of the *Planning and Development Act 2005* the WAPC has the option of concurrently rezoning land being zoned Urban under the MRS to a 'Development' zone (or equivalent) in a LPS. As no land is being zoned Urban under the MRS, this section of the Act is not applicable to this amendment.

#### 6 Substantiality

As of 1 August 2023, the *Planning and Development (Region Planning Scheme) Regulations* 2023 came into effect. Accordingly, there are three categories of MRS amendments being complex, standard and basic. The proposed amendment is recommended to be progressed as a standard amendment as follows:

- The size and scale of the proposed amendment is not considered regionally significant. It
  does not reflect a regional change to the planning strategy or philosophy for the
  metropolitan region.
- The proposed amendment seeks to better align the MRS with the existing environmentally constrained use and nature of the site and surrounds.
- The Shire of Serpentine-Jarrahdale and relevant State Government agencies have not raised matters which prevent the initiation and advertising of the amendment.

#### 7 Environmental Protection Authority advice

The proposed amendment was referred to the Environmental Protection Authority (EPA) for advice on whether environmental assessment would be required.

The EPA has advised that the proposed amendment does not require formal assessment under Part IV of the *Environmental Protection Act 1986*. A copy of the notice from the EPA is included at Appendix A.

#### 8 The amendment process

The procedures for amending the MRS are prescribed by the *Planning and Development Act* 2005 and the *Planning and Development (Region Schemes Regulations)* 2023. In essence, the procedure for a standard amendment involves:

- formulation of the amendment by the WAPC
- referral to the EPA for environmental assessment
- completion of an Environmental Review (if required) in accordance with EPA instructions
- public submissions being sought on the proposed amendment (including Environmental Review if required)
- consideration of submissions
- approval, with or without any modifications in response to submissions, or refusal to approve, by the Minister
- the amendment takes legal effect with Gazettal of the Minister's approval.

#### 9 Submissions on the amendment

The WAPC invites people to comment on this proposed amendment to the MRS. The amendment is being advertised for public submissions for a period of 42 days from 11 December 2023 to 25 January 2024.

#### 10 Modifications to the amendment


After considering any submissions received from Government agencies and the public, the WAPC may recommend that the Minister modify the amendment. The Minister may approve the amendment, with or without any modifications in response to submissions, or decline to approve.

#### 11 Final outcome

The recommendations of the WAPC, including any modifications, along with the determination of the Minister, are published in a report on submissions. Anyone who has made a submission, along with affected landowners, will be notified of the outcome when the amendment is gazetted to give it legal effect.

These may include an alternative approach or other ways for the WAPC to improve the amendment or make it more acceptable. Indicate the source of your information or argument where applicable.

If you prefer not to write your own comments, you may consider joining a group interested in making a submission on similar issues. Joint submissions can increase the pool of ideas and information.
