Important information for applicants

- 1 Prior to the WAPC's determination of an application, this form 2B may be submitted to the WAPC with an amended application that proposes minor variation/s to the submitted application. If the transaction has been entered into (signed) the determination period will be extended by 42 days to allow for assessment and, if required, the amended application to be referred to the relevant authorities.
- 2 Applications for section 136 or section 139 applications under the *Planning and Development Act 2005* are submitted to the WAPC on form 1B.
- 3 A request for consideration of an amended application must include:
 - This form 2B completed in full.
 - Additional material to explain the proposed minor variation/s.
 - A copy of the transaction and any supporting documentation.
 - Where the transaction includes land additional to that in the original application, attachments containing full details of the certificates of title of the additional land and copies of the certificates of title.
 - Amendments must be shown in the context of the overall application (i.e. resubmit entire lease, license, contract of sale agreement, rather than only submitting the portion that is being modified).
- 4 The request for consideration of the amended transaction may not be accepted and will be returned to the applicant with the submitted fee if these requirements are incorrect or incomplete.

If the attachments exceed the email size limit, please request a Large File Transfer from the above email address. The application will undergo a compliance check and within 72 business hours you will receive a confirmation email that your application has been received and accepted.
