## Published drinking water source protection reports

This index displays the published reports for each public drinking water source area (PDWSA) around Western Australia. These reports identify risks to drinking water quality and public health and discuss how to address those risks to help achieve safe, good quality drinking water supplies at a reasonable cost, now and in the future. They also assign boundaries, priority areas and protection zones to PDWSAs. This includes the following types of reports:

- Assessment: This provides an assessment of the risks to drinking water quality and public health. Key stakeholders are consulted when developing this type of report.
   Prepared by the department or the Water Corporation.
- *Plan:* Building on the assessment, a plan assigns priority areas and protection zones and undergoes public consultation. Prepared by the department.
- Review: A review updates a plan, providing a status on the recommendations implemented from the plan and any additional risks. Prepared by the department.
- Land use and water management strategy (LUWMS): Prepared by the Western Australian Planning Commission in consultation with the department, these strategies integrate land use planning with drinking water source management.
- Water service provider (WSP) report: A drinking water source protection report prepared by a water service provider (other than the Water Corporation), with the boundary, priority areas and protection zone endorsed by the department.

The water-related Western Australian Planning Commission's State Planning Policies (SPPs) are used to guide and help to prevent, control or manage development and land use changes in the policy area that are likely to cause detrimental effects to the groundwater and surface drinking water resource.

The index also notes water service providers licensed under the *Water Services Act 2012* (denoted beneath the table). Some sources are operated by and licenced to multiple entities supplying water to different locations or provide different services (i.e. potable/non-potable water supply).
