## 1.1. Opportunity

The Western Australian Government are offering up to 6 Delegate Passes (up to one pass per company) to the upcoming Bioshares Summit 2024 in Fremantle 12-13<sup>th</sup> July to Western Australian health and medical startups to attend, learn and engage with some of Australia's largest life science companies and with investors.

The Delegate Passes are valid for the two days of the conference (excluding the dinner ticket which is a separate charge) and includes access to the presentations scheduled for the day. See the [link](#) for details on the programme.

## 1.2. Eligibility

To be eligible to apply:

- You must live in Western Australia.
- You must demonstrate why attending Bioshares Summit would be beneficial to you.
- Your business/organisation must be a company that operates in the Health and Medical Life Sciences sector and are developing or expanding health and medical life science technology in Western Australia (does not extend to include consultants).
- Your business/organisation must be a registered business based and headquartered in Western Australia.
- Your business/organisation must be a small to medium enterprise that employs fewer than 200 people.
- Your business/organisation must hold at least one of the following:
  - A valid Certificate of Incorporation
  - A current Australian Business Number (ABN)
  - A current Australian Company Number (ACN)
- Your business/organisation must be a legally solvent entity.
- Your business/organisation must confirm that only one application by your company has been submitted for the Delegate Pass.



### 1.3. Application

To apply, please complete the application form online. Applications close at 11am AWST 10th June 2024. Successful applicants will be notified via email.

### 1.4. Process

The Department is intending to prioritise newer companies which may not have funds to participate in the event, to support them in developing new networks through event participation. The Department will assess your application for eligibility and consider your statement explaining how participation will benefit your company. Bioshares Summit Delegate Passes will be offered to the first 6 eligible applications that qualify and, in the Department's opinion, align with this prioritisation.

### 1.5. Delivery

The Delegate Passes for attendees will be available for collection from the Bioshares Summit registration stand on the first day of the event (July 12<sup>th</sup>). Please ensure your correct details are provided in the application form.

### 1.6. Terms and Conditions

1. The Promoter is the Department of Jobs, Tourism, Science and Innovation (the Department).
2. By submitting an application for a Bioshares Summit 2022 Delegate Pass (the Promotion), the applicant is deemed to accept these Terms and Conditions.
3. The Delegate Passes are not exchangeable, redeemable or transferrable.
4. Only one (1) Delegate Pass is available per eligible applicant per company.
5. To be eligible to apply, applicants must meet the eligibility criteria outlined in section 1.2 (Eligibility) above.
6. The Department is under no obligation to accept any application that fails to comply with the requirements, is incomplete or contains information or representations that are false or misleading.
7. The Department reserves the right to verify by any means which it considers necessary the identity of any applicant and to satisfy itself that the applicant has fulfilled these Terms and Conditions. The applicant must co-operate fully with the Department in any verification process.
8. The Department's decision is final and binding. No correspondence will be entered into.



9. The Department may suspend, vary or cancel the Promotion at any time.

10. The Department collects personal information in order to conduct the Promotion and may disclose such information to third parties, including, but not limited to, Bioshares Summit 2024 Event organisers, and for future promotional and marketing purposes. Applicants should direct any written request to access, update or correct personal information to the Department.

11. To the fullest extent permitted at law each applicant releases the Department from any and all liability (in negligence or howsoever) for costs, damages, expenses, and losses which any applicant may suffer or incur as a result of the Department's action or inaction arising out of or in connection with the Promotion.

12. Without limiting clause 11 above, the Department is not liable (in negligence or howsoever) to the applicant for the acts or omissions of third parties (including any parties for whom the Applicant is or may be vicariously liable).

13. These Terms and Conditions are governed by the laws of Western Australia.
