



EXEMPTION NOTICE

Environmental Protection (Controlled Waste) Regulations 2004 Part 4, Regulation 49

Exemption number CWE03/2024

In accordance with regulation 49(1), I am satisfied that:

- (a) the circumstances in which this exemption is requested are justifiable and accountable; and
- (b) the exemption will not adversely affect the operation of the Environmental Protection (Controlled Waste) Regulations 2004.

and

I HEREBY EXEMPT Regional Power Corporation trading as Horizon Power and subcontractors engaged by Horizon Power from Parts 2 and 3 of the Environmental Protection (Controlled Waste) Regulations 2004 on the terms and conditions set out in this notice.

Activity to which this exemption applies

The transportation by Horizon Power and subcontractors engaged by Horizon Power of:

- Used Lead acid batteries
- Waste mineral oils unfit for their intended purpose
- Waste oil and water mixtures or emulsions, and hydrocarbon and water mixtures or emulsions
- Oil interceptor waste
- Used oil filters
- Oil sludge
- Sulfur Hexafluoride
- Chemical treated power poles
- Light globes, lamps and fluorescent tubes containing controlled waste listed in Schedule 1 of the Regulations.

From generation sites to Horizon powers depots, being:

- Karratha Depot – Lot 1966 Stovehill road, Karratha WA
- Port Hedland Depot – 18 Anderson Street, Port Hedland WA
- Kununurra Depot – Lot 228 Messmate way, Kununurra WA
- Carnarvon Depot – Corner Iles road and Robinson Street, Carnarvon WA
- Esperance Depot – 143 Sims street, Esperance WA
- Broome Depot – 2/4 McDaniel Road, Broome WA



Exempted regulations

Horizon Power and subcontractors is exempted from compliance with the following regulations;

- Parts 2 and 3.

Conditions of this exemption

1. The controlled waste is clearly labelled with controlled waste type prior to transport.
2. The controlled waster is stowed securely during transport in a separate compartment to the driver.
3. The quantity of waste transported by Horizon Power and subcontractors engaged by Horizon Power shall correspond with the quantity subsequently collected by a licensed controlled waste carrier from the Horizon Power depot.
4. Horizon Power and subcontractors engaged by Horizon power must ensure that the vehicle or tank used on a road to transport controlled waste is used in such a way as to prevent the waste spilling, discharging or falling from the vehicle or tank.
5. Horizon Power and subcontractors engaged by Horizon Power must record the following information:
 - a. Type of controlled waste;
 - b. Amount of controlled waste;
 - c. Delivery site/location
6. Upon request, provide the above information to the CEO within 21 days.

In accordance with subregulation 49(2E) if a condition of this exemption notice is breached, the exemption ceases to have effect.

Reasons for Granting of this exemption

1. The circumstance in which this exemption is requested are justifiable and accountable.
2. The exemption will not adversely affect the operation of these Regulations.

Period of Exemption

This exemption begins on the date of this notice and ends on 30 October 2027.



Revocation or Variation

In accordance with subregulation 49(2) this exemption notice may be revoked or varied by me at any time by written notice.
