



# **SUMMARY OF KEY REFORMS**

## JULY 2020 - NOVEMBER 2024

#### Improved coordination, data and reporting

- Coordinator General function established to coordinate approvals reform efforts, improve customer service, cross agency collaboration, and provide integrated reporting for better oversight and accountability.
- **Performance Measurement Tranche 1 & 2** analysis of average approval timeframes for certain project types to inform decision making.

### Systems and process initiatives to improve the customer experience

- Fast Track Mining Approvals Strategy Stream 1 reduced assessment timeframes through additional resourcing and people/cultural enhancements.
- Occupational Licences (Lodge and Pay Phase 1) enables applicants to submit licence applications and supporting information online and securely pay application fees.
- Online Aquaculture Management and Reporting System provides more efficient reporting for approximately 400 aquaculture businesses.
- **Biodiversity Data Repository (BIO) (Dandjoo)** stores and shares data from a range of sources including proponent submissions provided for regulatory purposes.
- Environment Online Environmental Protection Authority's foundation supporting environmental impact assessment activities under Part IV of the Environmental Protection Act 1986 went live in August 2022.
- Small Business Friendly Approvals Program in partnership with 20 local governments. Implementation of the program by local governments makes it easier, faster and less costly for small businesses to establish and increase their productivity.
- **Approvals WA** a virtual one stop shop established on wa.gov.au and administered by agencies to help proponents to navigate the approvals process across a range of project types.
- **Tourism Approvals Pilot Project** streamlined and improved assessment processes for tourism activities and tourism developments in the Swan Canning Development Control Area.

#### SUMMARY OF KEY REFORMS JULY 2020 - NOVEMBER 2024

- Tourism Approvals Mapping Project improved the management of commercial tourism operations and uses on lands and waters managed under the *Conservation and Land Management Act 1984*.
- **Improved Scientific Use Licensing** streamlined the regulatory requirements under the *Biodiversity Conservation Act 2016* and the *Animal Welfare Act 2002* with respect to scientific licensing and permits.
- **New risk assessment tool** to reduce processing time by 50 per cent for more than 400 low-risk proposals to take or disturb threatened species and ecological communities each year.
- Reduced reporting burden pilot project stopped or halved the environmental reporting requirements for lower risk industries affecting more than 60 per cent (n. 600) of eligible licences (Part V of the EP Act).
- **Green energy approvals Initiative** established a dedicated Green Approvals Team at DWER and Green Energy Major Projects Facilitation team at JTSI to deliver efficient approvals processing for renewable energy projects, while preserving the unique environmental biodiversity of Western Australia.

#### Enhanced capability in risk-based practice and to support process change

• Four Common Understanding Workshops or events held - to improve communication, culture and capability of frontline approvals and assessment officers.
