

The State Infrastructure Programme

The Premier is required to develop a State Infrastructure Programme each year in consultation with the Treasurer, under Section 18 of the *Infrastructure Western Australia Act 2019*.

The 2025 State Infrastructure Programme spans a ten-year period and includes:

- an overview of the infrastructure commitments in the 2025-26 State Budget (covering the years 2025-26 to 2028-29); and
- **)** a longer-term outlook on the State's infrastructure needs and challenges.

This document has been developed by the Department of the Premier and Cabinet with support from the Department of Treasury and Finance and informed by independent advice from Infrastructure WA.

Document Overview and Structure

The WA Government's infrastructure investments are spread across our vast State and many different sectors. To ensure the breadth of this activity is captured, and is easily accessible to the reader, this document is divided into three main parts:

» Chapter 2: Significant Infrastructure Investments

This chapter provides an overview of key infrastructure investments in nine different sectors covering the years 2025-26 to 2028-29.

» Chapter 3: Infrastructure Outlook

This chapter outlines the emerging needs and challenges relating to Western Australian infrastructure in the six years following 2028-29. Reference to specific projects or initiatives in this chapter should not be interpreted as a commitment by Government to invest in these proposals. Consideration of specific projects may occur as part of future State Budget processes.

» Appendix 1: List of Significant Infrastructure Commitments

Appendix 1 provides a list of significant WA Government infrastructure commitments. A project is considered a significant investment if it is anticipated to cost over \$20 million.



Infrastructure Investment Overview

The 2025-26 State Budget forecasts an operating surplus of \$2.4 billion. Similar operating surpluses are forecast across the remainder of the forward estimates period (between \$2.4 billion and \$2.8 billion over 2026-27 to 2028-29). This will provide an important source of nondebt funding to finance the Government's significant investment in infrastructure.



ASSET INVESTMENT PROGRAM Total Public Sector





Figure 1. WA Asset Investment Program spend annually, 2025-26 WA State Budget

The State's Asset Investment Program (AIP) totals \$38.0 billion over the forward estimates (from 2025-26 to 2028-29), including \$12.1 billion of spending in 2025-26. General government sector investment represents \$13.9 billion (or 36.6% of the total program), with the public non-financial corporation sector responsible for the remaining \$24.1 billion.

The WA Government continues to invest in infrastructure required for our rapidly growing State. Key areas of investment across the forward estimates are utility infrastructure (\$13.3 billion); road, rail, and transport projects (\$10.7 billion); public and affordable housing and land development (\$4 billion); health infrastructure (\$3.2 billion); ports (\$1.7 billion) and education (\$1.7 billion). This pipeline will facilitate economic diversification, create local jobs, drive new industry growth, and strengthen communities across the State.

Jobs and Economic Development

Infrastructure is key to keeping our economy strong and facilitating job creation. The WA Government is helping to ensure the State is equipped to succeed in an evolving global economy by diversifying our industry and investing in workforce development. These investments foster innovation, empower WA business, and continue to unlock opportunities across the State.




Industry and Economic Diversification

Industry is a key pillar of WA's economic prosperity. This prosperity is underpinned by our vast mineral and agricultural wealth, as well as emerging industries such as clean energy and defence. Diverse and resilient industries will be key to supporting the jobs of the future while ensuring WA continues to prosper amid dynamic global change and uncertainty.

Significant government investments in this space include:

- An additional \$500 million in the 2025-26 Budget for the Strategic Industries Fund, with investment now totalling \$1 billion, to support delivery of common user infrastructure and enabling works across WA's Strategic Industrial Areas;
- An additional \$30 million in the 2025-26 Budget for the Collie Industrial Transition Fund, to secure new job creating projects and to further support Collie's transition away from coal-fired power generation; and
- > \$25 million from 2025-26 to 2028-29 to expand manufacturing facilities in Forrestfield, establish a Local Industry Development Fund and to support the establishment of the Advanced Manufacturing Technology Hub in Picton.



Creative Industries, Tourism and Sport

High-quality infrastructure is a catalyst for WA's creative, tourism, and sporting sectors – supporting vibrant, inclusive spaces that celebrate local culture and welcome the world. This new infrastructure allows WA to host major events, create new jobs, and secure even more investment. Aside from economic benefits, these sectors showcase WA and our talent while strengthening community pride and cross-cultural connection.




Key infrastructure investments in these sectors include:

- \$233.5 million to construct the Perth Film Studios, including \$47.7 million in 2025-26, to deliver WA's first dedicated screen production facility;
- \$163.2 million to build the Australian Hockey Centre, helping to secure WA as Australia's premier hockey destination via a new high-performance training facility and international competition venue;
- \$150.3 million for the redevelopment of the Perth Concert Hall to reinvigorate this iconic State cultural institution, which includes \$12 million from the Commonwealth Government, \$4 million from the City of Perth and \$30 million from Woodside through the Resources Community Investment Initiative; and
- > \$55 million towards the redevelopment of the Perth Cultural Centre ensuring the precinct continues to champion the State's unique heritage and arts industries.













Health

Well planned and integrated health infrastructure is critical to ensuring all Western Australians have access to quality health services.

WA Health's AIP is valued at approximately \$3.2 billion over the forward estimates period and includes a mixture of new asset investment, the improvement and expansion of existing assets, and planning for future projects.

Women and Babies Hospital Project

A total of \$1.8 billion has been allocated to expand services and choice for women, newborns and families across three sites, including a new Women and Babies Hospital located at the Fiona Stanley Hospital precinct in Murdoch and two new family birth centres – one north and one south of the river.



Bunbury Hospital Redevelopment

\$471.5 million is committed to the redevelopment of Bunbury Hospital. The redevelopment will deliver additional medical and intensive care beds, an expanded emergency department, increased operating theatre capacity, and maternity, birthing and neonatal services.

Medical Equipment and Imaging Replacement Program

The \$748.8 million Medical Imaging and Replacement Program comprises capital works to modernise healthcare equipment. The 2025-26 Budget includes a \$93 million investment in the Program over the forward estimates.

Geraldton Health Campus Redevelopment

Construction is progressing on the \$190.2 million redevelopment of the Geraldton Health Campus. This investment will deliver an expanded emergency department, a new intensive care unit, and an integrated mental health service, including an adult mental health inpatient unit and a mental health short stay unit.

Graylands Reconfiguration and Forensics Project

\$186.2 million will be invested in the Graylands Reconfiguration and Forensics Project across the forward estimates, to ensure the Graylands site continues to meet the needs of Western Australians living with mental illness now and in the future.

Bentley Health Service - Surgicentre

Work is progressing on the \$166.7 million Bentley Surgicentre. The Surgicentre will reduce wait times by separating non-complex elective surgery from emergency surgery, and deliver additional operating theatres, a surgical ward and new procedure rooms at the current Bentley Hospital site.

Peel Health Campus Redevelopment

\$117.1 million has been allocated across 2025-26 to 2028-29 for the redevelopment of the Peel Health Campus and expansion of its emergency department. These works include additional inpatient beds, a new mental health inpatient ward and emergency centre, an additional operating theatre, a palliative care hospice and additional chemotherapy spaces.






Education and Training

Uplifting the State's current and future workforce capabilities is fundamental to WA's prosperity. Investing in our schools and TAFEs provides students with the skills they need to respond to opportunities in emerging industries and rapidly changing ways of work.

Education

The Department of Education's AIP totals \$1.7 billion from 2025-26 to 2028-29 for new public schools and improved infrastructure, including \$668.9 million to be spent in 2025-26. These investments will facilitate the delivery of high-quality educational infrastructure across the State, supporting students and educators in developing skills and knowledge for the future.



Significant projects include:

- \$316 million for major upgrades to infrastructure at 17 primary and secondary schools and education support centres across the State;
- > \$94.4 million from 2025-26 to 2026-27 for transportable classrooms to support schools in meeting temporary, short to medium-term fluctuations in student enrolments;
- > \$85.3 million in 2025-26 to 2026-27 for the first tranche of minor upgrades to classrooms, sporting facilities and play equipment, which includes the \$43.3 million Cool the Schools program;
- \$14 million in 2025-26 for planning and delivery of Stage 1 of the Brabham Senior High School, to accommodate 1000 students in the rapidly growing north-eastern suburb; and
- \$4.5 million to expand infrastructure to support the four year-old kindergarten pilot program, forming part of the Government's \$33.8 million investment to trial the program at 10 sites across WA.







Training

High quality training facilities ensure every student can build the skills they need for the future. \$211.9 million has been invested over the forward estimates period towards training infrastructure. This will expand training opportunities available within the State, positioning the workforce to respond to the increasing demand for skilled labour.

Key government investments include:

- \$61.5 million for the Department of Training and Workforce Development's Remedial Works Program from 2025-26 through 2028-29, enabling the upgrade of ageing infrastructure across WA's training facilities;
- \$43.4 million, including \$33.9 million over the forward estimates, to ensure our TAFEs have the modern equipment they need to deliver the best training outcomes;
- \$36.6 million from 2025-26 through 2027-28 towards renewables training equipment at the Clean Energy Skills National Centre of Excellence, to support the State's growing renewable energies sector; and
- > \$12.5 million over the forward estimates to establish a Heavy Vehicle Driver Training Facility at the North Metropolitan TAFE.







Community Safety

Investment in police stations, emergency and custodial infrastructure is integral to our community – supporting the capabilities of WA's emergency services and working to reduce crime, promote security, and foster safe communities.

Major infrastructure investments include:

- > \$254.1 million for Stage Two of the Casuarina Prison Expansion;
- \$193.9 million to support the delivery of the Fremantle Police Complex, the Baldivis Police Station and the Forrestfield Police Station;
- \$150.9 million on land and building works for fire and emergency services, including \$18.3 million to construct a new Career Fire and Rescue Services station in the Yanchep region; and
- > \$40.1 million towards the Interagency Emergency Service Radio Network, including \$6.3 million in 2025-26, delivering upgrades to ensure the critical network between community safety agencies continues to be reliable and secure.



Transport and Major Infrastructure

Building accessible and sustainable communities requires efficient transport links and plentiful housing.

The 2025-26 State Budget commits \$10.7 billion of investment in transport infrastructure over the next four years spanning the breadth of road, rail, river and ports. This pipeline of works includes synergies with the WA Government's Made in WA initiative helping to rejuvenate local capabilities while strengthening supply chain resilience.

A selection of major infrastructure projects is listed below with further details in **Appendix 1**.





Westport

Given WA's geographic isolation and trade-driven economy, WA's economic prosperity relies heavily on sea-borne trade. The Westport program will deliver a new port and associated infrastructure to support a new container terminal in Cockburn Sound.

Key projects currently in progress within the Westport program of works include:


- \$122.7 million (jointly funded by the State and Commonwealth Governments) to define project scopes and designs, primarily for marine works, including the replacement of the Kwinana Bulk Terminal; and
- > \$92.4 million for road works including enhancements to Anketell Road, Roe Highway and the Kwinana Freeway to meet Westport logistical requirements.






\$213.5 million in 2025-26 to 2026-27 for works associated with the Perth Entertainment and Sporting Precinct to strengthen connections between Optus Stadium, Perth City and surrounds; and









Electric Buses (e-Buses)

Electric buses are a smart investment for modern transport systems. Benefits include reduced emissions, less maintenance, and more liveable cities through cleaner air and quieter streets.

Through the Made in WA plan, the State has also committed to make 130 electric buses locally. In support of this, the Government is investing \$435.3 million for e-buses, charging infrastructure and other depot modifications. The first stage of upgrade works to accommodate e-buses are focussed on the Malaga, Karrinyup, Bayswater and Claisebrook bus depots.

WA Agricultural Supply Chain Improvements

The Government is investing \$177.2 million on the Agricultural Supply Chain Improvements program. This program will increase freight capacities along key agricultural transport routes in the Wheatbelt, Great Southern, Mid West and Goldfields-Esperance regions.

Regional Road Safety

Main Roads' \$992.6 million Regional Road Safety Program is contributing to a reduction in the number of people killed and seriously injured on regional highways and roads. Main Roads will invest \$112.9 million in the Program between 2025-26 and 2026-27 for the sealing of shoulders and installation of audible edge lines, which are proven treatments to reduce single vehicle run off road crashes.

Main Roads' \$34 million Regional Level Crossing Upgrade will also see a further \$25.6 million invested into regional road safety over the forward estimates period.







Port Authorities

The AIP includes investment in port infrastructure totalling \$1.7 billion over the next four years.

Fremantle Port Authority

The Fremantle Port Authority's AIP for 2025-26 to 2028-29 totals \$360 million, covering the Inner Harbour in Fremantle and the Outer Harbour located in Cockburn Sound.

Key investments over the forward estimates include:

- > \$31.8 million for deck strengthening at Berths F and G at Victoria Quay and protective fenders to help prevent damage to the berths during mooring;
- > \$30 million to revitalise B-Shed on Victoria Quay, including construction of a new Rottnest Island ferry terminal and visitor centre; and
- > \$20.3 million to create a new tug facility at J Berth which will provide the home and services for the fleet of tugs that manage shipping across the port.





Kimberley Ports Authority

The Kimberley Ports Authority is positioning itself to capitalise on the region's developing resources sector. Its AIP for 2025-26 to 2028-29 totals \$43.7 million and includes \$14 million between 2025-26 and 2026-27 for the construction of inspection and washdown facilities at the Port of Wyndham to support direct imports of international containers and general cargo.

Mid West Ports Authority

The Mid West Ports Authority's AIP over the forward estimates totals \$391.1 million and includes:

- **\$306.5** million over 2025-26 to 2028-29 for the Geraldton Port Maximisation Project; and
- > \$23.4 million over 2025-26 to 2027-28 on a port-wide firefighting system to provide fully compliant fire systems across the Port of Geraldton.

Pilbara Ports Authority

The Authority's AIP totals \$727.9 million over the forward estimates period. This includes:

- ▶ \$309.8 million between 2025-26 and 2026-27 for delivery of the Lumsden Point General Cargo Facility and Logistics Hub;
- \$58.7 million in 2025-26 for the Port of Dampier's Bulk Handling Facility; and
- > \$14.4 million between 2025-26 and 2026-27 to support the future development of the Port of Ashburton's multi-user facilities.

Southern Ports Authority

The Southern Ports Authority's AIP over the forward estimates totals \$165.1 million. This includes \$87.7 million for sustaining capital works across the three ports (Albany, Bunbury and Esperance) to maintain current port capacity and sustain its asset base.







Housing

Housing is critical to WA's liveability, supporting population growth, workforce stability, and community wellbeing. It underpins economic development, attracts investment, and ensures people can live affordably near jobs and services.

The Government is delivering a program of over 5,800 social homes, with more than 3,000 homes already complete, and a further 1,000 homes under construction or contract. Additionally, since 1 July 2020, over 2,000 refurbishments have been completed with maintenance conducted on many thousands more.

Significant investments in housing include:


- ◆ \$1.6 billion of investment into New Social Housing which includes \$557.6 million over the forward estimates period;
- \$438.4 million for the Government Regional Officer Housing Program to help accommodate public sector employees such as teachers, police and health workers residing or relocating to regional areas;
- \$151.8 million for the METRONET Social and Affordable Housing and Jobs Package investing in housing which helps build liveable and connected communities while supporting infill density targets;
- \$138.2 million for the Housing and Homelessness Investment Package comprising \$48.7 million for Common Ground -Mandurah and \$89.5 million for Common Ground - Perth; and
- > \$75.7 million for Aboriginal Short Stay Accommodation in the East Kimberley, Geraldton and Perth.

In addition, the Department of Primary Industries and Regional Development's AIP includes \$15.7 million over the forward estimates period for the North West Aboriginal Housing Initiative which creates pathways towards socio-economic independence and wellbeing in the Pilbara and Kimberley.










Key Government investments include:

- \$111.5 million for Plan for Our Parks, which will create a minimum of five million hectares of new national parks, marine parks and conservation reserves, protecting natural assets and opening opportunities for nature-based and cultural tourism;
- \$41.1 million for upgrades and works across Karijini, Murujuga, Torndirrup, Wellington and William Bay National Parks, including \$6.4 million between 2025-26 and 2027-28 towards upgrades to the Wellington Dam Kiosk and William Bay National Park; and
- ▶ \$36.3 million for the Environment Online digital platform, enabling more streamlined processes for environmental and water regulation across the State, with works progressing to finalise the platform.









Planning and Land Use

Strategic planning and land use are essential to WA's growth - effectively guiding infrastructure delivery and environmental outcomes. The WA Government has invested in several significant projects that support effective planning and land use.

Western Australian Planning Commission

The Commission's AIP totals \$192.2 million from 2025-26 to 2028-29 and includes the acquisition of land reserved under the Metropolitan, Peel and Greater Bunbury Region Schemes and development of facilities on reserved land, along with land acquisitions for transport infrastructure.





DevelopmentWA

DevelopmentWA's AIP totals \$2.1 billion over the next four years, with \$980.7 million to be spent in 2025-26 on new and continuing works.

The AIP will enable the delivery of land for housing (including social, affordable and community homes), business and for infrastructure to support WA communities, including:

> \$685.2 million for land development as part of the Metropolitan Program, including \$269.7 million for the Ocean Reef Marina, \$176.8 million for Alkimos Central and \$146.1 million for the Subi East Precinct to further enhance liveability;





- > \$652.8 million over the forward estimates for land development under the Residential Program, including \$397.8 million for Industry and Infrastructure Acquisition and Development, \$112.9 million for the Pier Street Residential Development and \$103.8 million for the Fremantle Burt Street Residential Development;
- > \$287.9 million of State Government investment in Housing Australia Future Fund projects to support social and affordable housing and other acute housing needs in the metropolitan area;

- \$225.3 million for the Industrial Lands Authority Program, including \$25.2 million for the Neerabup Australian Automation and Robotics Park and \$151.9 million for new works to support major industrial development on the Western Trade Coast; and
- \$81.1 million for land development under the Regional Program including \$65.9 million for the Karratha Madigan Road and \$15.2 million for the Nyamba Buru Yawuru – Health and Wellbeing Campus.







Water

Water is an essential resource for WA's economy, environment and communities. As WA faces increasing water supply challenges including from climate change, population growth, and industrial demand - the availability of affordable and suitable water sources will be crucial to maintaining our way of life.

The Water Corporation's AIP commits \$2.2 billion in 2025-26 to water infrastructure projects across the State.

Significant investments include:

- \$992.9 million in 2025-26 towards the Alkimos Seawater Desalination Plant (ASDP) program of works, with Stage One expected to contribute 50 billion litres of drinking water per year to the metropolitan water supply;
- \$313 million in 2025-26 to wastewater treatment and network projects in both the northern and southern metropolitan corridors, including the \$55.7 million expansion of the Kwinana Water Reclamation Plant and the \$45.3 million upgrade of the Woodman Point Water Resource Recovery Facility; and
- \$498 million in 2025-26 for regional water infrastructure including:
 - \$235.1 million towards a major upgrade of the Goldfields and Agricultural Water Supply Scheme to deliver an additional
 7.2 megalitres of water daily to communities and key industries;
 - \$66.6 million towards upgrading the capacity of the Burrup Seawater Supply Scheme to enable supply to Perdaman's urea project underpinning a secure local supply of fertiliser; and
 - \$52.2 million towards the construction of a water treatment plant in Onslow, which will have the capacity to provide up to 1.5 million litres of drinking water per day to the Onslow community.





The State's electricity corporations (Western Power, Synergy and Horizon Power) will spend an estimated \$7 billion from 2025-26 to 2028-29, with major investments including:

- \$623.9 million over the forward estimates to deliver key renewable assets comprising \$199.9 million to complete the Collie Battery Energy Storage System and \$424 million for the Kings Rock Wind Farm;
- \$542 million in 2025-26 to continue to progress the Clean Energy Link – North project, to upgrade transmission lines to allow new wind capacity connections in the Wheatbelt and Mid West, and other works to support decarbonisation of the South West Interconnected System; and
- > \$112.2 million in 2025-26 and a further \$237.7 million over the outyears to enhance safe and reliable electricity supply in the regions, including in Exmouth and Leonora.











Western Australia is experiencing robust population growth. As the State evolves, so too will its infrastructure needs and pressures. The path ahead will be shaped by the energy transition, new industries, technological innovation, and changing community aspirations.

This chapter provides an overview of the significant infrastructure needs and challenges that will impact Western Australia over the next decade, and some of the steps the WA Government has already taken to address them.





Workforce

Equipping Western Australia's workforce with the skills required for the future is a vital and ongoing priority. Over the next decade, the State will continue to act to ensure individuals, industries, and communities are prepared to thrive in a rapidly evolving economic, technological, and environmental landscape.

With much of the developed world currently facing shortages in skilled labour, investment in our workforce will remain critical to ensure WA is well-positioned to deliver the infrastructure needed to support our emerging industries and the growing community.

The WA Government is working to uplift the State's labour force by investing in our pipeline of skilled local workers. Measures include:

- > \$21.9 million in the 2025-26 Budget to make additional building and construction courses fee-free in 2026, 2027 and 2028;
- > \$27 million to provide an additional 225 places in the Group Training Organisation Wage Subsidy Program to support employers and apprentices in the construction sector, and \$14.6 million to the Adult Apprentice Incentive Program for 400 places to employ mature-aged apprentices in building and construction; and
- > \$11.5 million over the forward estimates to establish the AUKUS Defence Industry Incentive Scheme to grow Western Australia's AUKUS defence workforce

Housing

Western Australia's strong economy and desirable lifestyle continue to attract new residents, driving sustained population growth and increasing demand for housing and other enabling infrastructure. Whilst data from the Real Estate Institute of WA reflects a positive shift with Perth's rental vacancy rate improving from 0.4% in early 2024 to 2.8% as of May 2025, ongoing commitment to delivering housing will remain essential in addressing supply constraints.

The WA Government is responding to these challenges, investing in a pipeline of new and affordable housing supply. With \$5.8 billion invested into housing and homelessness initiatives since 2021, additional key initiatives include:

- \$1.3 billion over the forward estimates to address. homelessness, and improve public housing and crisis accommodation across WA, including through new Common Ground Facilities, the Social and Affordable Housing Investment Fund, and Short Stay Accommodation Facilities; and
- > \$438.4 million for the Government Regional Officer



Transport

WA's transport network plays a significant role in connecting communities, critical services and business to markets. As the State's population and industry continue to expand, the breadth and efficiency of our transport infrastructure will remain a key determinant of WA's ability to support economic growth, productivity and community wellbeing.

Despite much of METRONET having now been delivered, including the recent opening of the new Ellenbrook Line and the Thornlie-Cockburn Line, notable expansion of the public transport network will continue. Greater use of Perth's river network through METRONET on Swan will provide opportunities to enhance accessibility to key education and employment hubs within Perth. The project will also support priorities such as urban development and growth in our green infrastructure through electrification of Perth's ferry network.



Additional initiatives designed to prepare WA for the future include:

- \$707.5 million over the forward estimates to widen and upgrade the Kwinana Freeway, helping to ease congestion including to support future economic activity connected to the Western Trade Coast;
- \$25 million from 2026-27 to 2028-29 to improve the South Coast Highway, a key freight and tourism route stretching from Esperance to Walpole; and
- > \$25 million from 2025-26 to 2026-27 for the Northam-Pithara Road to realign sections of the road and replace ageing bridges.

With 90% of the world's goods trade occurring via maritime transport, strengthening transport networks and access to ports is crucial for connecting WA businesses to interstate and global markets. To ensure the State's port infrastructure meets future demand, the Government is progressing Westport – a new container port in Cockburn Sound – with a preferred design announced and detailed planning underway. The 2025–26 Budget also commits \$744.1 million to upgrade other key port assets, including the Lumsden Point General Cargo Facility and Logistics Hub in the Pilbara.



Economic development

Ensuring WA can respond to increasing uncertainty in the global economy will require careful consideration and proactive planning. Geopolitical tensions, climate change and economic fluctuations can impact WA's prosperity now and into the future.

WA's economy has strong foundations – with abundant natural resources, stable institutions, a skilled workforce, good infrastructure and strong links to major trading partners. This position is further strengthened by the State's strong credit rating, being the only Australian state to hold a AAA credit rating from the two major agencies, S&P Global and Moody's.

The Government is investing to ensure the State's healthy economic position continues. As part of the 2025-26 Budget, the Government invested \$1.4 billion to make WA's economy more resilient.

This investment included:

- a \$500 million expansion of the Strategic Industries Fund (taking the total contribution to \$1 billion), which will help unlock industrial land across WA;
- > \$209.4 million to boost local manufacturing of buses, batteries and ferries; and
- **>** \$38.5 million to support the defence, mining and exploration, and hospitality sectors.

Energy transition

The world is undergoing significant transformation, driven by climate change and the global shift toward decarbonisation. These forces are reshaping infrastructure needs everywhere – including in Western Australia. As industry and government move toward a net zero future, demand for renewable energy, clean transport, and expanded transmission networks will increase demand for skilled labour, materials, and specialised expertise.

WA's energy transition is already well underway. The Government has invested \$1.4 billion into decarbonisation initiatives in 2025-26, spanning utilities, ferry and bus electrification, and other new energy initiatives – bringing total investment since 2017 to \$6.4 billion. These investments will accelerate WA's renewable energy generation and extend network capacity to meet rising demand. This includes \$584 million over the forward estimates to unlock wind generation north of Perth and to expand renewable energy generation, enabling closure of coal-fired power stations by 2030.




Emerging technologies

As the digital landscape continues to evolve rapidly, technological transformation is fast driving change to economies and communities across the world. Ensuring our infrastructure is built for a digital future will be critical in navigating mass digitisation and positioning WA to respond to emerging opportunities and threats.

The Government is supporting the uptake of new technologies with the WA: Digitally Evolved Digital Industries Acceleration Strategy, which aims to empower the digital capabilities of industry and businesses across the State. It is also expanding fee-free TAFE courses, which will assist in the development of a future digital-ready workforce.



Current initiatives including the Regional Telecommunications Project, Regional Digital Connectivity Program, and State Agriculture Telecommunications Infrastructure Fund will work to strengthen regional connectivity.

From transport and energy to ports and essential services, these projects are designed to strengthen communities, support economic development, and drive prosperity across Western Australia.

Looking ahead, the Government will continue to monitor evolving trends that shape our society – whether demographic shifts, workforce dynamics, technological change or environmental challenges. Recognising these changes will play out over decades, the Government will continue to plan proactively and adaptively, ensuring WA's infrastructure meets our future needs and unlocks the opportunities ahead.
