To maintain the currency of the State emergency management documents,

- Statement of fact amendments were approved by the State Emergency Management Committee Executive Officer on 30 September 2025 in alignment with State EM Preparedness Procedure 3.4 (resolution 17/2021):
 - o Correction of typographical, grammatical and referencing errors across the Policy, Plan, and Procedure documents
 - Minor updates to the definitions of State Hazard Plan and State Support Plan to better reflect their function
 - o Removal of all references to Westplans, given the time elapsed since the transition to State Hazard Plans
- Minor updates to State Hazard Plan Heatwave as requested by the Department of Health to improve definitional accuracy.
 - Following the 2023 SEMC Subcommittee and Reference Group Review, the Public Information Reference Group (PIRG) was realigned to report through to the Community Resilience and Recovery Subcommittee (CRRS) (resolution 18/2023). The following consequential amendments to were approved by the SEMC on 9 October 2025 (resolution 64/2025).
 - o The PIRG is a reference group of the CRRS and the Chair of CRRS will appoint the Chair of PIRG.
 - Clarification of responsibilities including that the Chair of PIRG is responsible for maintaining the strategic
 arrangements of public information in conjunction with the PIRG, where the SEPIC retains responsibility for the wholeof-government public information response arrangements.
 - State Hazard Plan HAZMAT Annex B Space Re-Entry Debris (SPRED) was approved for an extension to the comprehensive review requirements until March 2026 (resolution 64/2025).
- The Impact Statement Guide (attachment to State EM Recovery Procedure 5.4) was approved for an extension to the comprehensive review requirements until June 2026 (resolution 64/2025).
