

List of Specified Offences

The following offences are classified as 'specified offences' under section 8A.4(2) of the *Local Government Act 1995* (Act). A council member who commits a specified offence is considered to have committed a specified breach under the Act.

Receiving, seeking, agreeing to receive, giving, offering, or promising a bribe involving a public officer.	s. 82
Acting on insider information, acting in a matter where a pecuniary interest exists, or acting corruptly in the performance or discharge of functions to gain a benefit or cause a detriment to a person.	s. 83
Corruptly altering, omitting or falsifying records, providing false information or returns, or omitting to provide a required return.	s. 85
