

## Ministerial decisions made under section 18(6A) of the Aboriginal Heritage Act 1972

Published 3 December 2025

The amended *Aboriginal Heritage Act 1972* (Act) came into effect on 15 November 2023. Section 18(3A) requires the Minister for Aboriginal Affairs to publish notice of decisions made under section 18(6A) of the Act. The table below sets out the Minister's decisions pertaining to new information concerning an Aboriginal site in relation to a consent under section (3)(a) of the Act.
