

The Sexual Violence Prevention and Response Strategy sets out a long-term whole-of-community vision for a Western Australia (WA) free from sexual violence. It recognises the complex, widespread and pervasive nature of sexual violence in WA and its profound impacts on victim-survivors, families, and communities. affecting health and wellbeing, education, economic participation, relationships and housing outcomes.

The Strategy provides a coordinated framework for action across four interconnected domains:

Domain 4: Recovery and Healing

The First Action Plan (Action Plan) is intended to guide coordinated action across priority areas, recognising that reform and delivery are already in progress across domains. It outlines key initiatives aligned to the Strategy but does not represent the full extent of work underway across government to prevent and respond to sexual violence.

Progress will continue to be driven in partnership with community, industry, service sectors, and government agencies. This Action Plan complements and builds on significant activity already occurring, reinforcing collective efforts to prevent sexual violence, support early intervention, strengthen responses, and enable recovery and healing.

The Action Plan identifies eight priority areas to address sexual violence in WA.
