The Tribunal orders:

1. The applicant has until 27 February 2026 to make any application for leave to reopen its case, which application is to be accompanied by a supporting affidavit and written submissions all of which is also to be provided to the other parties and the Shire of Mundaring.
2. The respondent has until 6 March 2026 to file and provide to the other parties and the Shire of Mundaring such material and submissions upon which it relies in response to any application to reopen by the applicant and any submissions by the respondent.
3. The intervenor and the Shire of Mundaring have until 13 March 2026 to file such material and submissions upon which each of them relies in response to any application to reopen by the applicant.
4. A hearing of a half-day duration is to be listed on a date not before 20 March 2026.
5. The applicant shall provide to the Tribunal by no later than 20 February 2026 a joint list of the dates on which the parties and the Shire of Mundaring will be available for a hearing of half-day duration not before 20 March 2026.
