- the current transaction is within 10 years of the instrument that effected the first transaction and
- each transferee in the current transaction was a transferee in the first transaction and
- the further interest is being transferred from an excluded person within the meaning of section 16(1) of the *First Home Owner Grant Act 2000* (for example, the Housing Authority).

- The transaction record (e.g. contract for sale or transfer of land) that evidences the current transaction.
- A completed [Form FDA41 'Foreign Transfer Duty Declaration'](#) for each person acquiring or receiving the land.

## How duty will be assessed

- The rates of duty, thresholds and total value of the dutiable property that applied at the time of the first transaction will apply to the current transaction.
- The duty payable will be reduced by the amount of duty paid by the transferee(s) on the first transaction and any other further concessional transactions on which duty has been paid.
